## H.B. 2018, H.D. 1 RELATING TO GOVERNMENT PROCESSES AND SERVICES


House Committee on Government Operations

As you know, we conducted our work pursuant to Act 177, Session Laws of Hawai'i 2015, which asked us to conduct a study to review the process, efficiencies, and accountability of various departmental engineering sections, except for those within the Department of Transportation, that manage general fund capital improvement projects. We noted inconsistent adherence to best practices and SPO guidance.
