In consideration of HOUSE BILL 2025 RELATING TO MARINE SPECIES

House Bill 2025 proposes to establish a marine species task force to identify ten vital marine species vulnerable to extinction if take levels of those species increases and recommend actions to ensure the sustainability of those species. The Department of Land and Natural Resources (Department) opposes this measure.

The Department already has the ability to informally convene advisory groups to discuss a number of subjects and to provide suggested guidance. A task force established by statute would involve considerable administrative burden.

The Department notes that the National Marine Fisheries Service, Office of Protected Resources (OPR), is regularly petitioned to review the status of many species in the area of the Hawaiian Islands. These reviews are to determine if any species already on the list of threatened or endangered species should change their status or if any new species needs to be added. Their review process is quite extensive, with staff and funding specifically provided to conduct this review for species status.

We work with OPR, the Pacific Islands Fisheries Science Center (PIFSC), and others, whenever practical, to utilize not only their expertise, but their considerable resources, to determine species status. For marine mammals, OPR produces stock assessment reports (SARs), sometimes annually, depending on whether new information becomes available. OPR also produces recovery plans for many species to guide activities to eventually delist species that have recovered. Since these mechanisms already exist and we are using them, the task force is unnecessary. The work of the

proposed task force is already being done and is funded at the federal level, with procedures already in place.

The following testimony is presented on behalf of the Pet Industry Joint Advisory Council (PIJAC) and it membership in opposition to House Bill 2025, establishing a Marine Species Task Force. We appreciate the opportunity to submit our comments before your Committee.

PIJAC is the world's largest pet trade association representing the interests of all segments of the pet industry. PIJAC's membership includes member associations, organizations, and corporations as well as individuals involved in the commercial and hobby pet and aquarium trade. More specifically, we represent the interest of live animal retailers, importers/exporters/ breeders, product manufacturers, wholesale distributors, and hobbyists.

Let me start by saying that nobody cares more about healthy and safe pets than do PIJAC and our members. We have for many years provided a well-respected animal care certification program that is widely utilized by not only persons in the commercial pet trade but shelters, humane societies and institutes of higher education as well. Our association has long been recognized as the voice for a responsible pet trade, and we routinely advocate legislative and regulatory proposals establishing governmental mandates where appropriate to advance the public interest and welfare of pets and the environment. PIJAC works closely with US Department of Agriculture and Department of the Interior to ensure effective enforcement of the federal Animal Welfare Act, management of threatened or endangered species and control of invasive species, and have since its inception. We regularly work with federal and state agencies as well as local governments to advance animal welfare and environmental interests.

Hawaii's aquarium industry is considered as one of, if not the, best regulated near-shore fishery in the world. The Department of Land and Natural Resources (DLNR), pursuant to State law, submits a report every five years to the legislature entitled "Relating to the West Hawaii Regional Fishery Management Area." The 2015 Report found that the "The Hawaii marine aquarium fishery is currently the most economically valuable commercial inshore fishery in the State with FY 2014 reported landings greater than \$2.3 million." The regulatory mechanisms covering the Hawaiian aquarium fishery supports the tenets of the sustainable use of renewable natural resources supported in the IUCN's Policy Statement on sustainable use.
