In consideration of HOUSE BILL 2046 RELATING TO MILITARY LAND

House Bill 2046 proposes to transfer all state land leased by the United States Army to the state Department of Defense (DOD) by June 30, 2017. The Department of Land and Natural Resources (Department) has concerns with the bill and wishes to discuss the intent of this bill with DOD. At this time, we offer the following comments.

This measure would amend Section 121-10, Hawaii Revised Statutes (HRS), to give the adjutant general charge of "all property of the State leased to the United States Army." DOD does not appear to have authority to hold fee title to real property. In such cases, the mechanism for transferring State lands between agencies is a set-aside by executive order pursuant to Section 171-11, HRS. Under that section, the receiving agency has management control of the land.

Some of the State lands currently leased to the United States Army include forest reserves under the management of the Department's Division of Forestry and Wildlife (DOFAW). Transferring management jurisdiction of these lease lands to DOD by executive order would likely require the removal of the lands from the forest reserve. Having multiple executive orders to different agencies on the same land results in conflicts between the agencies on how to use the land. DOFAW's administrative process for removing lands from a forest reserve requires a public hearing, which complicates the removal process.

Additionally, DOFAW has forest reserves in some of the Army leases that are still open to the public (e.g., Pupukea, Ewa and Kuaokala on Oahu), and others that are still open to public hunting (e.g., Pohakuloa Training Area on Hawaii Island). DOFAW would like public access to continue in these areas and is concerned that transferring lands out of the Department would

Chair Yamane, Vice Chair Cullen, and Members of the Committee:

My name is Kamakana Kaimuloa, and I am the Vice President of Military Affairs at The Chamber of Commerce of Hawaii (The Chamber). I am here to state that The Chamber <u>supports the intent</u> of HB 2042, which transfers all state land leased by the United States Army to state DOD by June 30, 2017.

In recognizing how critical the U.S. military presence is to Hawaii's economy, the Chamber officially established a military affairs department in 1985. For 31 years the Chamber, through its Military Affairs Council (MAC), has served as the State's liaison in matters relating to the military and has been steadfast in working to protect and preserve the military's presence in Hawaii, promote public awareness and understanding of issues challenging the military locally and nationally, and serve as the advocate for military and their families.

Although the Chamber supports the intent of this legislation, prior testimony by the Department of Land and Natural Resources noted that there may be statutory challenges that need to be resolved in this bill, namely, that the DOD does not appear to have authority to hold fee title to real property. Additionally, it is our understanding that the DOD lacks the administrative resources to manage such lands at this time. Despite these challenges, the Chamber believes that further discussion is merited.

Aloha Chair Yamane, Vice Chair Cullen and Members of the Committee:

The Ka Lāhui Hawai'i Political Action Committee (KPAC) affirms and defends our Hawaiian peoples' right to over 1.8 million acres of our national lands.

KPAC submits the following testimony in opposition to HB 2046. This bill would transfer all state land leased by the United States Army to the State Department of Defense (DOD) by June 30, 2017. The US Department of Defense administers 163,592 acres in Hawaii consisting primarily of military bases and training ranges. Clearly this bill would transfer thousands of acres of land leased by the Army for military purposes from DLNR to DOD. The US military's use of land in Hawaii, particularly the Army, has generated lawsuits for failure to comport with environmental laws as is the case with the over 4,000 acres at Makua Military Reservation on Oahu and for breach of trust in protecting public lands due to the military's failure to ensure that munitions are cleaned up as is the case with the over 22,000 acres at Pohakuloa on Hawaii Island. Clearly, the military has a poor track record and this State must not further jeopardize our limited precious resource by allowing the DOD to oversee these lands.

Thank you for this opportunity to testify. Hawai'i Peace and Justice STRONGLY OPPOSES HB 2046. This bill amounts to an attack on public trust lands. The lands in question were entrusted to the State of Hawai'i after statehood. However, the military refused to relinquish control despite assurances during World War II that the land would be returned after the war ended. So it returned title of the land to the State of Hawai'i but retained control through onerous lease agreements (tens of thousands of acres for 65 years for \$1.00). The result of these egregious arrangements has been the destruction of thousands of acres of public trust land. Community members have demanded an end to these destructive activities for decades.

This bill would effectively give control of the land to the military, and abdicate state's duty to protect these important environmental and cultural resources, in violation of the state constitution. The Hawai'i Department of Defense is not the proper or legal entity responsible for stewardship of public lands and the environment. Placing these lands in its jurisdiction would be a case of the proverbial fox guarding the henhouse. With its hundreds of thousands of acres of contaminated lands in Hawai'i, history does not permit us to trust that the military can be transparent, accountable, and effective stewards of Hawai'i's environment.

According to the 2010 census, the population of Waianae is 48,519, and Native Hawaiians comprise 58.5% of this community. Of the more than 200 endangered plants and animals in Hawaii, 30 are found in Makua Valley and 19 in Pohakuloa. Continued military presence has detrimental social impacts in Hawaii – including negative impacts on the health and wellness of our communities. The military use of land continues to separate our communities from continuing cultural practices, and restoring healthy land and resource management at Makua and Pohakuloa. For example, in a 1992 Environmental Review, the Army reported that in 1982 alone – they destroyed 350 900-pound napalm bombs, mustard gas, a minimum of 5,243 tons of ordnance and hazardous waste, and 2,621 tons of potential hazardous waste in Makua. 
Aloha. The Conservation Council for Hawai'i opposes HB 2046, which transfers all state land leased by the United States Army to state Department of Defense by June 30, 2017, and requires the DOD to submit a report to the legislature.

There is no justification for this proposal. The military occupies approximately 236,000 acres in Hawai'i, including about 22% of the land on O'ahu, and thousands of square miles of surrounding airspace and sea. Some of these areas are leased from the State, while other areas were retained by the military at statehood. Approximately 56% of these lands are ceded lands. Which areas and how many acres would be transferred to the state DOD pursuant to HB 2046?

Public land, including ceded land, is held in trust by the State for the people and future generations. None of it should be transferred to the state DOD, especially ceded lands, which will someday be returned to a sovereign Hawaiian entity. It is bad enough that so much land was retained by the military at statehood. The transfer of additional land to the state DOD would effectively preclude other land uses in the future.

The military has a long-standing record of destruction and poor stewardship of the land it occupies in Hawai'i. The military is responsible for the decline of rare, threatened, and endangered species, destruction of cultural sites, and contamination of our land and water. We need as much oversight and control as possible for these lands. We are not confident this will happen if areas to the military are transferred to the state DOD.

Here is a map of military land on O'ahu (approx. 85,000 acres or 22% of the total land area on O'ahu).



Instead of giving land to the military, we urge you to implement the following actions:

- 1. Assess current leases of land to the military and determine whether it is in our best interest to continue leasing these lands.
- 2. Set lease fees at fair market value.
- 3. Stop leasing state land to the military for \$1 per acre per year.
- 4. Require the U.S. Navy to fund the complete restoration of Kaho'olawe.
- 5. Require the U.S. Army to continue ecosystem restoration and conservation of rare and endangered species at and surrounding live-fire training areas, including Makua Military Reservation, Schofield Barracks, and Pohakuloa Training Area.
- 6. Require the U.S. Navy to cease strafing and target practice on Ka'ula Islet.
- 7. Amend the Administrative Order on Consent and require the U.S. Navy to replace disintegrating underground storage tanks at Red Hill, O'ahu in a timely manner and based on the best available technology and information.
- 8. Require the U.S. Navy to fully fund monitoring soil and groundwater contamination at Red Hill and to remediate soil contamination now before the fuel migrates and contaminates our groundwater.
- 9. Require the military to clean up its mess on currently and previously occupied lands based on a prioritized list negotiated by the State and Department of Defense.

Please accept this testimony from KAHEA: The Hawaiian-Environmental Alliance. KAHEA is a Hawai'i-community based 501(c)(3) nonprofit organization with over 10,000 supporters. We are writing in strong opposition to H.B. No. 2046, which proposes to transfer control of public lands leased to the U.S. military from the Department of Land and Natural Resources (DLNR) to the Adjutant General of the state Department of Defense (DOD) for the following reasons:

First, section two of HB 2046 is dangerously ambiguous and vulnerable to an interpretation under which lands transferred to DOD control will not be subject to HRS chapter 171 leasing procedures. Section two reads:

Without regard to chapter 171, Hawaii Revised Statutes, by June 30, 2017, each department shall convey to the state department of defense all state lands that are under the control of that department and that are leased by the United States Army.

HRS Chapter 171 governs the leasing disposition of the majority of public lands, including Hawaiian National lands. Amongst its provisions are those for public auction, hearing, and notice. HB 2046 proposes more than merely an "administrative" transfer. The DOD is under both state and federal governmental control. By placing Hawaiian national lands under DOD, HB 2046 would effectively remove protections of Hawaii's unique kuleana from these lands. Hawaii's public trust lands are not "military lands," but sensitive ecosystems and constitute the trust between the state of Hawaii' and the Hawaiian people. By effectively alienating these lands to military control, and alienating the public from procedures under HRS chapter 171, HB 2046 undermines that trust.

Second, HB 2046 appears to propose an end-run around recent litigation challenging DLNR's failure to fulfill its duties as a public trustee of Pohakuloa lands leased to the U.S. Army. By removing Pohakuloa lands, which are Hawaiian national lands, from DLNR's control, HB 2046 would shield DLNR from challenges to their proposed re-leasing of these lands to the Army. Notwithstanding potential exemptions from HRS chapter 171, DLNR submitted testimony specifying that under HRS 171-11, "lands subject to this measure must be remediated from environmental hazards, including but limited to unexploded ordnance, prior to its return to [DLNR]." Not only would Pohakuloa lands go to the DOD, but also "all

appropriations, records, equipment, machines, files, supplies, contracts, books, papers, documents, maps, and other personal property heretofore made, used, acquired, or held by any agency or department" would be turned over. Enacting HB 2046 could set a precedent under which agencies may defer their public trust duties to Hawaii's lands by simply transferring them to another agency's control. Although DOD also shoulders the State's public trust duties, its exemptions from Chapter 171, HRS procedures would make public oversight, awareness, or challenges against violations of those duties nearly impossible.

Third, HB 2046 constitutes bad management of agency resources. DOD lacks experience and expertise in managing public trust resources. DLNR was set up specifically to manage public lands and is staffed with experts in the management, disposition, and maintenance of public trust resources.

Mahalo nui for considering our testimony and for refusing to pass HB 2046.

The Office of Hawaiian Affairs (OHA) **OPPOSES** HB2046, which attempts to transfer all state land leased by the United States Army to the State of Hawai'i Department of Defense (State DoD) by June 30, 2017.

Much of the state lands leased to the U.S. Army, including the Pōhakuloa Training Area on Hawai'i Island, Kawailoa and Kahuku Training Areas on the north shore of Oʻahu, and Mākua Military Reservation on the Waiʻānae coast of Oʻahu, are of particular importance to the Native Hawaiian community, and to the general public. A majority of these lands are comprised of former Hawaiian Kingdom and Crown lands, ultimately acquired as a result of the unlawful overthrow of the Hawaiian Kingdom. In addition, much of the public lands leased by the U.S. Army hold great historic, cultural, and environmental significance. For example, Mākua valley historically hosted a thriving Native Hawaiian population that cultivated and lived off of the abundant resources in the region. The valley was also historically used as a port of landing for voyaging canoes, and was the location of celebrated cultural institutions, including renowned pā lua and hālau hula. In addition, a number of native plant and animal species have and continue to be found in Mākua valley, many of which are currently considered threatened or endangered. Accordingly, OHA has a strong interest in restoring and protecting the ecological integrity and natural and cultural resources of these and other Army-leased lands.

Unfortunately, much of the state lands leased to the U.S. Army have suffered continuous degradation after years of extensive military training and use. While mitigation and restoration efforts have taken place in some areas, there continues to be issues regarding the existence of toxins, unexploded ordnance, and other hazards that may already require substantial resources to remediate or otherwise address. OHA shares the concerns of other community groups and organizations regarding the continued military use of such lands, and the resulting accumulation of long-lasting cultural and environmental impacts that may result.

OHA notes that transferring U.S. Army-leased lands to the State DoD may lead to the presumption that these lands will continue to be used for "defense or military purposes" indefinitely, regardless of potential cultural and environmental impacts, and notwithstanding the potential for alternative uses that may be more consistent with the public interest. While the Department of Land and Natural Resources (DLNR) has a broad

mission to "[e]nhance, protect, conserve and manage Hawai'i's unique and limited natural, cultural and historic resources held in public trust for current and future generations of the people of Hawai'i nei," the State DoD has a much narrower mission to "assist authorities in providing for the safety, welfare, and defense of the people of Hawai'i" (emphasis added).<sup>2</sup> In addition, whereas the DLNR is headed by an executive board, with expertise and/or knowledge related to natural resource management and Native Hawaiian traditional and customary practices (the Board of Land and Natural Resources, or BLNR),<sup>3</sup> the State DoD is run by a single executive known as the adjutant general, who "shall have charge of the state military reservations, armories, and all other property of the State kept or used for military purposes" (emphasis added).<sup>4</sup> Hence, the State DoD is focused on a narrow mission of military support, rather than the overall interest of the environment and the public trust. If the State DoD is given management control of the lands currently leased to the U.S. Army, its mission and expertise strongly suggest that it will continue renewing leasing such lands to the U.S. Army, with little consideration for natural and cultural resource concerns, or the potential for alternative and more beneficial uses of the land.

Therefore, OHA urges the Committee **HOLD** HB2046. Mahalo for the opportunity to testify.

Good morning Chair Yamane, Vice-Chair Cullen, and members of the committee:

My name is David Lane Henkin, and I am an attorney with Earthjustice. We appreciate the opportunity to offer this testimony in **strong opposition** to House Bill 2046, which seeks to transfer control of all state land leased by the United States Army to the State Department of Defense.

The state lands the Army currently leases include some of the most culturally and biologically sensitive lands in Hawai'i. The Army leases substantial portions of Mākua Military Reservation on O'ahu, which is home to over forty endangered and threatened species and more than one hundred Native Hawaiian cultural sites eligible for listing on the National Historic Register. The Army also leases nearly 23,000 acres at Pōhakuloa Training Area on Hawai'i Island, which is also rich in cultural and biological resources. Unlike the Department of Land and Natural Resources, which currently controls lands leased by the Army, the state Department of Defense simply lacks the expertise and personnel to ensure adequate protection of these public trust resources.

Moreover, the Army is currently in negotiations with the State of Hawai'i to renew its leases of training lands at both Mākua and Pōhakuloa. While the state Department of Defense certainly should have opportunities to provide input for the lease talks, turning over control of the Army leased lands to the Department of Defense would effectively place the same interests on both sides of the negotiating table. To ensure adequate protection for irreplaceable cultural and biological treasures located on the leased lands, it is vital that the Department of Land and Natural Resources retain control of those lands and, with it, the lead in negotiations with the Army.

We appreciate the opportunity to offer this testimony and respectfully ask you to hold HB 2501.

I am a mother of three daughters all who are named after places & a rare endemic plant that only grows in Mākua valley; Ko'iahi, Ma'aloa, & Kūla'ila'i. Each of them had their feet touch the sands of La'ihau & Kūla'ila'i. They are being trained to be the next kia'i (protectors) of this 'āina. In 2004 I was brought to Mākua on an access. 2 years later, I welcomed my eldest child into this world, Ko'iahi. She solidified our piko as an 'ohana. Ko'iahi is a pristine ravine famed for an endemic variety of small leafed maile whose scent would welcome those passing by the ahupuaa. Ko'iahi ravine was heavily abused by the U.S. military being used as a live fire training area. Till today, there are still remnants of unexploded ordinances due to the lack of care and clean up from the current occupiers.

Koʻiahi, Mākua, and Kahanahaiki ahupuaʻa are known to a large number of rare, endemic, and endangered Hawaiian plants still thriving in this valley. One being the rare Maʻaloa plant, endemic to the ravine of Koʻiahi; my second child is named after this plant.

My third child is named Kūla'ila'i after the beach break in Mākua. There is a river which lays dry and without water severely cutting the chord of the water that flows from our mauka region down into the ocean. Without water we lack a. amazing spawning environment for our aquatic life which we as kanaka depend on for food. There are remnants that remain in ocean that have yet to be removed from the current occupiers of this land.

Clean up your mess and leave! The lack of responsible stewardship of the military places me in STRONG opposition of HB2046. I will not sit and watch our beloved homeland continue to be destroyed. # TESTIMONY IN OPPOSITION TO HOUSE BILL NO. 2046 RELATING TO MILITARY LAND

Good morning Chair Yamane, Vice-Chair Cullen, and members of the committee:

My name is Frederick A. Dodge, MD, and I am a member of Malama Makua and resident of Wai'anae. I appreciate the opportunity to offer this testimony in strong opposition to House Bill 2046, which seeks to transfer control of all state land leased by the United States Army to the State Department of Defense.

The state lands the Army currently leases include some of the most culturally and biologically sensitive lands in Hawai'i. The Army leases substantial portions of Mākua Military Reservation on O'ahu, which is home to over forty endangered and threatened species and more than one hundred Native Hawaiian cultural sites eligible for listing on the National Historic Register. The Army also leases nearly 23,000 acres at Pōhakuloa Training Area on Hawai'i Island, which is also rich in cultural and biological resources. Unlike the Department of Land and Natural Resources, which currently controls lands leased by the Army, the state Department of Defense simply lacks the expertise and personnel to ensure adequate protection of these public trust resources.

Moreover, the Army is currently in negotiations with the State of Hawai'i to renew its leases of training lands at both Mākua and Pōhakuloa. While the state Department of Defense certainly should have opportunities to provide input for the lease talks, turning over control of the Army leased lands to the Department of Defense would effectively place the same interests on both sides of the negotiating table. To ensure adequate protection for irreplaceable cultural and biological treasures located on the leased lands, it is vital that the Department of Land and Natural Resources retain control of those lands and, with it, the lead in negotiations with the Army.

I appreciate the opportunity to offer this testimony and respectfully ask you to hold HB 2046.
