H.B. 2047, H.D. 2 – RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

Purpose: Requires the HCDA to undertake and complete the Kalaeloa Energy Corridor Project.

Position: This testimony reflects my view as the Interim Executive Director only, as the Authority has not had an opportunity to formulate a position on this measure.

The Hawaii Community Development Authority (HCDA) requested \$6 million dollars from the State Legislature to fund the Kalaeloa Energy Corridor Project, as we recognize its importance to providing reliable energy to the Kalaeloa Community Development District. The district currently suffers numerous electrical outages, putting a strain on area businesses and government resources, such as the FBI building, Army National Guard, and Kalaeloa Airport.

The HCDA supports the intent of the bill, however, we request that an appropriation be made to cover the \$6 million dollar project cost, should our CIP request fail to be approved.

Testimony reflects the view and position of the Executive Director and not that of the Authority.

Consideration for funding is consistent with Standing Committee Report No. 331-16 from the Committee on Consumer Protection & Commerce, however, the HCDA notes that H.B. 2047, H.D. 2 did not insert an appropriation section.

The HCDA supports the flexibility provided for in H.B. 2047, H.D. 2 to meet the electrical standards set forth by the Hawaiian Electric Company (HECO) as conditions may change to accommodate unforeseen circumstances, as construction commences.

For Section 2, the HCDA recommends the following changes to the enumerated specifications to read as follows:

- (1) Utility ductlines shall run along lower Fort Barrette Road and Enterprise Avenue from Kapolei Parkway to Midway Road.
- (2) Utility ductlines shall be constructed in accordance with applicable specifications of the public utility companies.
- (3) Utility ductlines shall be constructed to accommodate future service connections from adjacent properties.
- (4) Location of the utility ductlines within the rights-of-way shall be coordinated with the Navy, public utility companies, State of Hawaii Department of Transportation and City and County of Honolulu, as applicable.

The HCDA¢s recommended specifications are consistent with the current scope of the project as refined with project stakeholders, including HECO and accomplishes the following:

- Removes technical specifications for flexibility to meet utility standards and adapt to unforeseen conditions/circumstances.
- (2) Recognizes additional parties that the HCDA must coordinate with on the project beyond the Navy relative to the rights-of-way.
- (3) Recognizes that metering and connection fees to the new energy corridor as the responsibility of the landowner, not the State of Hawaii.

Chair Luke, Vice Chair Nishimoto, and Members of the House Committee on Finance:

I am Major General Arthur J. Logan, State Adjutant General and the Director of the Hawaii Emergency Management Agency. I am testifying in **STRONG SUPPORT** of House Bill 2047 HB2.

This measure will improve the electrical infrastructure at Kalaeloa. The existing Navy legacy system is deteriorating, but the Navy cannot improve or maintain the infrastructure because they have no Federal mission at Kalaeloa. Hawaiian Electric will not accept the Navy's electrical infrastructure in its present condition because it does not meet HECO design or construction standards.

The Hawaii National Guard recently completed two Military Construction (MILCON) projects, the Kalaeloa Readiness Center (\$32M) and the Combined Support Maintenance Shop (\$38M). Both facilities are now subject to irregular power service ("blackouts") which brings basic operations to a stop and hampers day-to-day operations.

The Army Aviation Support Facility (\$33M) is currently under construction. Upon completion, this new facility will increase the stress on the failing Navy electrical system and worsen the electrical situation.

A potential complete electrical system failure would render these facilities nearly useless and severely downgrade the operational preparedness of the Hawaii Army National Guard.

The Hawaii Army National Guard facilities require a secure, stable electrical infrastructure. The new infrastructure must have capacity for future construction at the Army Guard's Kalaeloa installation. I ask for your full support of this measure.

Thank you for allowing me to testify in **STRONG SUPPORT** of House Bill 2047 HB2.
