Purpose of Bill:	Allows home schooled students to participate in extracurricular activities offered at the public school that they would otherwise be required to attend. (HB2135 HD1)

Department's Position:

The Department of Education (Department) recognizes the intent of HB 2135 HD1. The Department is reviewing this proposed measure and respectfully offers its comments and concerns.

Specifically, as proposed in Section 1(a):

(1) The health requirements set forth in sections 302A-1154 through 302A-1157, prior to the child's participation in the extracurricular activity ; and

- Should this measure move forward, the Department is exploring alternatives that may allow Department of Health staff to follow-up with families of students who have not met or are unable to meet the health record or vaccination requirement mandates of this proposal.
- Currently, health records are not required for home schooled children. It is not necessary for the home schooled child to submit the TB (tuberculosis) test clearance or Form 14 (Student Health Record). This is of concern to the Department due to health and safety of all students.

(2) The participation requirements and restrictions for the extracurricular activity , including maintaining appropriate grade point averages and paying appropriate fees ; provided that the requirements or restrictions shall not be inconsistent with this section .

- The Department and school leadership continue to voice strong concerns about the ongoing academic progress monitoring of home schooled students as mandated by this measure as students must maintain a certain Grade Point Average (GPA) in order to participate in extra-curricular activities including sports.
- The additional administrative oversight necessary to monitor varied home schooler'

curriculum will add to the principal's responsibilities and already heavy workload.

- Significantly, in the Board of Education's report to the 2014 Legislature, the Home school representatives also noted that indicative of a parent's choice to home school is the desire to individually select curriculum, thus, determining a means to evaluate progress will be difficult, and is dependent on the cooperation of the home schooled student's parent.
- At this time, parents of home schooled children are not required to officially enroll and un-enroll students in order to home school their child; therefore, no birth certificate or proof of residency is required. Failure to provide a birth certificate and proof of residency will be particularly problematic as it pertains to high school athletics. This could also impact league competition based on the rules of each interscholastic league.

Further, proposed in Section 1(b);

(c) As used in this section, "extracurricular activity" means a school-authorized or education-related activity occurring during or outside the regular instructional school day, including sports, cheerleading, clubs, and other programs.

• The Department is soliciting additional feedback regarding the participation of home schooled students in extracurricular activities held during the regular instructional school day, including any required tools to monitor and track a home schooled child's participation and/or presence on campus during the school day relative to ensuring safety.

Hawaii Administrative Rules and Board of Education (Board) policy. Notwithstanding Hawaii Administrative Rules, Title 8, Chapter 12, Compulsory Attendance Exceptions, http://www.hawaiiboe.net/AdminRules/Pages/AdminRule12.aspx, there are no Board policies governing home school students' access to public school activities.

- Pursuant to HAR §8-12-2, "Home schooling' means a viable educational option where a parent instructs the parent's own child" and pursuant to HAR §8-12-13, when a parent submits an intent to home school, the parent is responsible for "the child's total educational program including athletics and other co-curricular activities."
- Should this measure move forward, the Department will need to review and propose a new policy and changes to current Board policies, as needed, for the Board's consideration.

Funding and Fees. Further, the public school system does not receive any funding for home schooled students since they are not counted in public school enrollment counts. Schools would not receive funding through weighted student formula for home schooled students. The details of establishing a fee schedule for home schooled students' participation remains to be explored.

Feedback from Educational Leaders. This year, the Department sought feedback from our Complex Area Superintendents and Principals on this measure. For your consideration, we would like to share some of those comments:

The student would need to be enrolled at the home school [Department designates a "home school" for a student based on where a child physically resides]. When a parent chooses to home school his/her child it is akin to enrolling the child at a private school. The extra curricular activities at my participation school are reserved for students enrolled at that specific school. Students enrolled at a private school do so by choice. Their parents still pay taxes but opt for a different educational experience for their child. Along with that, they forego the opportunities that would be provided by the public school. Similarly parents who opt for home schooling do so with the same. Extracurricular activities are part of a school's comprehensive educational program. These activities extend the learning into other contexts, reinforcing study skills, working in conjunction with classroom teachers and remain accountable to the school's

program. If there is a student that is not enrolled at the school, the overall purpose of extra curriculars to play this role is debilitated. (Elementary principal)

What about TB, physical, insurance. We have no control on how home schools grade. They do not come under Chapter 19? Do they get trainings? How do we set up accounts for pay? (High School principal)

Athletics - will students need to meet GPA [grade point average] requirements? Will the "parent" be the one giving the grade? Difficult even for elementary schools as students may meet during the school day. There are grade checks as well as behavioral expectations.(Former Complex Area Superintendent)

2014 Legislative Report. Lastly and notably, in 2014, the Board submitted its report in response to the 2013 Senate Concurrent Resolution (SCR)76 on this subject to the Legislature. The Board convened a stakeholder group to research models and best practices on home schooled student participation in public school extracurricular activities and sports and explore implementation of such a program in Hawaii.

The Board reported:

- All appeared to agree that academic eligibility was important, but measures, monitoring and funding still need to be addressed. Currently, public school students are required to maintain a 2.0 Grade Point Average in all classes required for graduation. Board Policy 4520. There is generally a quarterly grade check but this can be more frequent.
- Behavioral requirements were discussed and it appeared reasonable that if a student was disruptive, that student should not be allowed to participate. Still, there were questions raised about other athletic requirements such as classification of junior varsity versus varsity, years of eligibility, physical/health checks and credits for establishing grade level.
- Since school principals and athletic coaches felt strongly about ensuring academic achievement and discouraging students from being withdrawn from public school to play sports, a restriction was discussed of twelve months of home schooling as a prerequisite to participating in sports. A requirement of the home school student being registered with the school as a home schooled student at the beginning of the year as a requirement to participating in sports was also discussed. The applicability to other extracurricular activities still needs to be explored.
- The variety of fees that are required of public school students were noted and discussed. These fees are noted costs for participation in extracurricular activities and sports and thus, may be fees that the home schooled student would need to bear. Examples of fees included: transportation fees, equipment fees, and catastrophic insurance fees.
- It was determined that the definition of enrollment for home schooled students in the public school would need to be clarified. It appeared that the participants would agree that enrollment requirements could be possible but there was opposition to requiring all home schooled students to enroll since not all home schooled student would want to participate in a public school extracurricular activity or sports.
