I am in full support of H.B. 2163 HD 1. Youth violence is a complex problem requiring appropriate, necessary intervention. When programs are successful, youth are provided with the necessary skills to stop violent acts and redirect their attention to a productive future. My name is Darin Kawazoe and I am the Director of Program Development and Grants for AFY. I cannot imagine what life would be like for hundreds and thousands of youth who did not or could not benefit from AFY's services. I am a survivor of youth violence.

It took time for me to recover – physically, emotionally, and mentally - from the violence I experienced in high school. It was like experiencing one of the greatest lost in life. I needed someone to advocate for me and my family; someone to reach out and address the multitude of needs of being a crime victim of violence. Like the hundreds of kids that are bullied and assaulted each day, I had a difficult time returning to school. I was not only ashamed and embarrassed, but also felt like my safety was at risk. Someone needed to pay attention to my depression, my risk of using drugs and alcohol as well as dropping out of school, and the overwhelming need to seek safety perhaps through anti-social kids.

The chances that you know a crime victim of violence are great. Violence can happen to anyone. No one should have to go through the recovery process of being a crime victim alone. What I have learned over my 30 something years of working in the 'field' is that while certainly not all victims will become offenders and not all offenders were victims, many youth are both, and many of our most vulnerable families include both. Effective programs that address youth violence and gang membership must take into account the 'entire' individual and all of his or her risks as well as needs.

The issue of youth violence is a public health issue, which demands government assistance and funding. It took time to rebuild my life and pick up the pieces after high school. I am grateful that I am resilient. But, not all the youth we work with are that way. I thank AFY for allowing me to use my own experiences for the greater good to stop violence in its tracks and help Hawaii's youth to stay in school. We need your help more than ever.

I am in strong support for HB 2163 which relates to Youth Gangs. Youth violence and youth gangs are on the rise. AFY has built a credible reputation for over 25 years in working with this specific youth population. Their passion is evident in their work, relationship building, and the lives they have been able to impact through their success.

Once again I strongly support HB 2163 and hope that you will see the bigger picture on how this Bill will also support and promote safer schools and communities for our children and youth to prosper now, and for years to come.

Chair Chun Oakland, Vice Chair Riviere, and members of the Senate Committee on Human Services,

Ho'omaluhia, the Hawaii Branch of The Family Violence & Sexual Assault Institute (FVSAI) and The Institute on Violence, Abuse and Trauma (IVAT) supports HB 2163 HD1 relating to Youth Gangs. The mission of our two nonprofit agencies is to improve the quality of life for individuals by sharing and disseminating vital information, improving collaborations and networking, conducting research and trainings, assisting with program evaluation and consultation to promote violence-free living.

For the past 13 years, FVSAI and IVAT have been collaborating with many of the state agencies and nonprofit programs in the islands to sponsor an International Training Summit in Hawai'i on the latest research, prevention, assessment and intervention techniques concerning various aspects of trauma and maltreatment, including youth violence.

We support a multi-pronged approach to reducing youth violence and delinquency among high risk youth. We believe that early identification of adverse childhood experiences will help identify our youth who are most at risk and in need of addressing deep rooted issues, trauma, aggressive and violent behavior. Ho'omaluhia and IVAT can assist in training and providing program evaluation to any organization that provides therapeutic prevention, mental health programs, and in-school centered group counseling for high risk youth.

An appropriation today to address youth violence and delinquency will prevent a larger adult criminal population in the future. It is the route to helping the local communities in the efforts to reduce the violence and abuse that too often negatively affects our families. Thank you for the opportunity to testify in support of HB 2163 HD1 with an amendment.
