OFFICE'S POSITION: OYS supports the intent of the measure but requests that any appropriation not affect the priorities in the Executive Biennium Budget. OYS supports a balanced and multi-prong approach to strengthen and improve a community's response in addressing problems affecting a community such as youth violence, including outreach to and establishing relationships with high risk youth to help promote education, self-esteem, individual growth and development, leadership, and responsibility.

Additionally, if therapeutic prevention and mental health programs are funded, consultation with the Child and Adolescent Mental Health Division of the Department of Health should occur in the development of this service array.

PURPOSE: The purpose of the measure is to appropriate funds for operational costs to provide therapeutic prevention and mental health programs for high risk youth.

RE: H.B. 2163; RELATING TO YOUTH GANGS.

Chair Morikawa, Vice-Chair Kobayashi and members of the House Committee on Human Services, the Department of the Prosecuting Attorney of the City and County of Honolulu ("Department") supports the intent of H.B. 2163, however, would urge this committee to consider reallocating the funds associated with H.B. 2163 to Adult Friends for Youth as an alternative agency to carry out the goals and objectives.

The purpose of H.B. 2163 is to help reduce youth violence and delinquency in the State by creating therapeutic prevention and mental health programs for high risk youth. The creation of additional programs to assist our youth is consistent with this Department's ongoing concern for at-risk youth. Over the years, our Department has seen increases in crime involving youth offenders who at times are as young as 12 years of age. Yet, despite this rise, there are few programs available to youth offenders in Hawaii, often leaving them with little or no meaningful alternatives.

While the purpose of H.B. 2163 is to establish a multi-pronged approach in programs which works to combine elements of community and school counseling, our Department would strongly urge this committee to consider appropriating funds associated with H.B. 2163 for the fiscal year 2016-2017 to Adult Friends for Youth as an alternative. Adult Friends for Youth, was established in 1985 at the University of Hawaii, School of Social Work and boasts a stellar track record and history of sustainability which would ensure that any appropriated funds will be allocated properly and effectively. Adult Friends for Youth works with more than 400 high risk youth per week and has established many successful programs such as their Re-directional Therapy which is an effective therapeutic approach to combat violence, drugs, crime, teen pregnancy, family dysfunction, learning disabilities and anti-social behaviors amount the very high risk youth both in and outside of the classroom. Through the programs implemented by

Adult Friends for Youth, their services have successfully changed the attitudes and behaviors of over numerous different gangs. They have also successfully assisted multiple gang members through the difficult task of integration back into the community.

For all the reasons above, the Department of the Prosecuting Attorney of the City and County of Honolulu supports the intent of H.B. 2163 and strongly urges this committee to reallocate any funds to the Adult Friends for Youth Program. Thank you for the opportunity to testify on this matter.

We have directly seen the successes of funding programs like AFY from their clients who have transitioned from troubled pasts into becoming hard-working apprentices in our IBEW training program. Chair Morikawa, Vice Chair Kobayashi and members of the Committee of Human Services, I am here to testify in support of HB2163 relating to Youth Gangs.

Before taking on the role of President and CEO of Adult Friends for Youth, I spent over 20 years in the field working directly with youth involved in gangs and violence. What have I learned over the years? Gang members and youth involved in violence are usually acting out as symptom of deep rooted issues. They join gangs because they need a place to belong and the gang becomes their surrogate family. Like drugs, the gang becomes a means to escape dealing with problems that have become overwhelming for them to handle. To break up the gang or to work with a youth in isolation is defeating because you are taking them away from their only support network. We also know that peers tend to have the most influence on each other at this developmental stage in their lives. Youth gang membership and violence is not limited to particular communities nor is it limited to only public housing, it is much more wide spread.

So what have I learned that works? Providing outreach services to these young men and women and engaging them in group counseling sessions helps begin identifying the deep rooted problems, talk about it, and teach them skills to cope with the problem as well as skills to empower them. These services has to be consistent, long-term and infused in their communities. These services should be holistic and include the entire peer group to turn negative peer pressure into positive peer pressure so that they can begin to hold each member accountable for their actions. The Juvenile Justice System has agreed that working with a youth in their environment is much more effective than incarceration and has made stride to provide services to a youth in their communities. Youth involved with gangs and violence should be given the same option.

Over the years, gang membership and violence have become more prevalent because technology namely social media has brought it to the forefront. Fights, name calling, bullying and recruitment of members are often posted to many of these sites allowing the problem to spread faster and island wide. This sensationalizes the violence and makes it attracting to watch as well as engage in the behavior. Social media has also been the catalyst that have brought youth (sometimes close to a hundred) from all over the island to engage, participate and/or witness a fight causing members and residents of the community to live in fear.

At Adult Friends for Youth (AFY) we reach and provide services to more than 350+ students a week, which involves group counseling as well as outreach, case management, advocacy, truancy reduction, leadership training, and mentorship on and off the school campus. Our street wise, street smart therapeutic approach works with high risk youth on their own turf and tackles difficult challenges that youth faces. We work with youth gangs as whole entities and for three plus years. Our services are culturally relevant to Hawaii's diverse multi-ethnic population. We also provide crisis services and interventions 24/7 because we know that the violence do not only occur between 9 am - 5 pm. AFY works in partnership with school administrators and faculty to provide effective counseling services to reduce and eliminate destructive behaviors on school campuses in order to create a violence-free, safe educational environment where students can thrive. We provide mediation services between rival gangs at schools and between schools. We partner with other programs to refer youth for more services when they have learned to properly conduct themselves in the appropriate settings.

We ask for your support of this bill, HB 2163, because it will provide services to our youth, who are the future and give them the opportunity to become productive and contributing members of society. Thank you for allowing me to testify.

Aloha, my name is Malakai Maumalanga and I am the Director of Redirectional Services at Adult Friends for Youth. I am support of HB2163 relating to Youth Gangs.

I want to start by stating that I would not be here today testifying if I didn't get the support I needed to change my life. That support came from Adult Friends for Youth (AFY). As a kid growing up in Kalihi I got heavily involved in gangs and violence which seemed like a normal life for me. It's a lifestyle you don't grow out of unless you get the support to deal with these issues. I was expelled from every school I attended because of all the fights. My gang was well known by the police for the destructive behaviors and violence we caused in the communities. It got so bad that the police were often posted on King Street to monitor us. The kids in the neighborhood would not come to the park to play they were afraid of all the trouble. We had been in so many fights and we didn't care that we terrorized our neighborhood. Nobody wanted or knew how to deal with us. Then AFY came into our lives. At first we thought they were another police program to monitor us. We later found out they really wanted to help us and have a peaceful and safe community. I have been blessed to have had AFY help me and my friends deal with our issues so that we could live a productive life. They worked with my whole gang to decrease the violence and to help us begin to hold each other accountable. The accountability that we had for each other helped us to look toward a more productive life. If you only work with one youth or one person from the gang it becomes difficult for that person to try and steer the other members to a positive path. However, if you work with the gang as whole entities—the peer pressure now is easier and becomes positive rather than negative. I went to jail many times but with the continuous support of

AFY I eventually went to college and got a Master's degree in Social Work. I had all of this experience and today my friends and I are productive people of society. We are not a burden or draining our economy but rather giving back.

Today, I am the Director of Redirectional Services at AFY. We help students redirect their lives and change their perspectives of life through Redirectional Therapy. We believe that all students have the capacity to enter mainstream if their issues are addressed and their feelings nurtured. By redirecting youth violence and gangs it has a tremendous impact in our schools and communities. By supporting HB 2163, it gives these youth an opportunity to reach their full potential. Aggressive behavior and violence is a disease, if left untreated spreads like any other disease. So please support HB 2163, give our gang youth a chance in life, and help to redirect them from destructive behaviors to a constructive life. Adult Friends for Youth's Staff is on call 24/7. We provide therapeutic services to the most at-risk youth on the island of Oahu, and it is truly a privilege.

They may not always follow directions, they may not allow for services in what we think of as the traditional therapeutic setting, they may not even believe that they need services. What the youth do understand is that when Adult Friends for Youth begins services with them, they are being respected, heard, understood, supported in a safe environment.

They are the youth that often have no place to go and have lost hope, therefore they have turned to destructive behaviors and violence to cope with their struggles. Often, the youth find themselves in the juvenile court system or worse. People often ask me, "Why would you want to work with the bad or rotten kids. They have no respect and don't care about their education." I usually respond by saying that those are not the kids that I provide services to. I provide services to the students that society has given up on, that program after program has given up on, and sometimes their own family has given up on. I get to watch youth gang members engage back into their education, communities and families. I get to help them believe in themselves once again.

The therapeutic process of changing a life is never short or simple, which is why the work of Adult Friends for Youth is so important. There is no quick fix to improving a life. Just like adults, change takes time.

We ask that the state support the agencies that are facilitating this change. Do not give up hope in our youth. If we are asking them to believe in themselves, we have to believe in them as well. Supporting HB 2163 shows your commitment to Hawaii's at-risk youth in redirecting their lives from destruction and delinquency, to becoming contributing members of society.

I cannot imagine what life would be like for hundreds and thousands of youth who did not or could not benefit from AFY's services. I am a survivor of youth violence.

It took time for me to recover – physically, emotionally, and mentally - from the violence I experienced in high school. It was like experiencing one of the greatest lost in life. I needed someone to advocate for me and my family; someone to reach out and address the multitude of needs of being a crime victim of violence. Like the hundreds of kids that are bullied and assaulted each day, I had a difficult time returning to school. I was not only ashamed and embarrassed, but also felt like my safety was at risk. Someone needed to pay attention to my depression, my risk of using drugs and alcohol as well as dropping out of school, and the overwhelming need to seek safety perhaps through anti-social kids.

The chances that you know a crime victim of violence are great. Violence can happen to anyone. No one should have to go through the recovery process of being a crime victim alone. What I have learned over my 30 something years of working in the 'field' is that while certainly not all victims will become offenders and not all offenders were victims, many youth are both, and many of our most vulnerable families include both. Effective programs that address youth violence and gang membership must take into account the 'entire' individual and all of his or her risks as well as needs.

The issue of youth violence is a public health issue, which demands government assistance and funding. It took time to rebuild my life and pick up the pieces after high school. I am grateful that I am resilient. But, not all the youth we work with are that way. I thank AFY for allowing me to use my own experiences for the greater good to stop violence in its tracks and help Hawaii's youth to stay in school. We need your help more than ever.

Dear Members of the Human Service Committee

Aloha! We are Zara and Gary Aki, and we are residents of Kamehameha Homes. We also are active within our Community here, and have been Board Members for our Kamehameha Homes Tenant Association since 1997. Our 3 children are grown and on their own leading a very productive life. We have 7 grandsons, and they're a blessing and joy to us. It's just the 2 of us, yet we continue to do volunteer work for our Community simply because we care about our neighbors and because this is home. We became aware of AFY when our son, (our youngest) was attending Kalakaua Middle School. He became a client of theirs and Debbie was his worker. While being involved with AFY, he adjusted and learned from them. To this day, he will quote what he was taught "the choices you make today, may determine your future." Kinohi had some issues still, but Debbie periodically checked on him throughout the years. When he graduated in 2001, like most young men, didn't know what he wanted to do, wasn't sure if he should give college a try. But, he did. Debbie walked him through the process, helped with all the paperwork, and for the first week or so picked him up and took him to HCC. All we asked of our son, was to give it a shot and see if you like it or not. When everyone had doubts about Kinohi, and when he was down about himself, Debbie was there for support and guidance. For that, we are so grateful and appreciative.

When HPHA had funds available for Associations to benefit their Communities, our KHTA Board, chose AFY as one of the agency to come in and work within our Community and with our kids. With our experience with AFY, it was agreed among our Executive Board to select them and hopefully they would come here to service our Community, and they did. We even had classes for Adults with Ms. Terry Fisher, and we had a great time sharing and learning about ourselves. We also became more aware of the scope of service that they provide for the youth. It is unreal. Sad to say that the funds from HPHA ran out. But, AFY didn't allow that to stop them. They continued to work with the kids and we believe that they made a difference in their lives.

Recently, we've come together again due to the increase in the Gang Activity/ Violence that have been taking place. These Gangs congregate here at Kamehemeha Homes, and they fight. I'm talking about 50 plus kids, with no respect and a whole bunch of attitude! They stop traffic on King Street, and here on Haka Drive. They had weapons on them and they would throw them at the other kids who they were fighting with. They had pipes, sticks, rocks, a machete was seen, it was extremely dangerous for us. They would scale the outside walls of Kamehameha Homes and they would be all over our Community. Police are called, but they are quick to run away as soon as they see or hear a police siren. Since last September, our Association have worked side by side with Farrington High School, HPD/ Weed and Seed, AFY, and HPHA. We have had 2 Community based meetings here at our Hall to discuss and try to come up with positive solutions, or an action plan to address this. Last year we invited some Legislators with various agencies, Farrington and Mckinley High School, and HPHA to meet with our residents, and just to let everyone know that this is some serious business. Through the planning process and in us seeking advice, it was AFY who stood by us and guided and supported us. AFY is currently working with the Gangs that have been fighting and we see positive results. There have been no current fights here. In this last meeting, it was reported to us that the State & City did not grant AFY money. This is very sad. When an agency such as AFY, who does terrific work with our youth in trying to steer them on the right path, to have no funding is sad. Here you have a credited agency whose work record speaks for itself, where the staff is on call 24/7. Whenever there is a type of Gang Violence/ Fight, AFY is the one everyone calls. Come on people!!! We need help to insure the safety of our kids

and grandkids. We plead with all of you to support HB 2163 for agencies like AFY. Services like theirs is very crucial to a lot of families and Communities.

Thank you for considering my testimony on this important bill. Most of my years as a teacher, vice-principal and principal in Hawaii's public schools were spent with students who were considered disadvantaged and/or alienated from mainstream society. My first nine years as a principal were spent at Olomana School, serving students in the Detention Home and the Youth Correctional Facility. My last fifteen years were as principal of Farrington High School. At Olomana I saw the tremendous amount of money that is spent in 24-hour care and security of young people for whom we just did not have appropriate services in the community. Some had committed serious crimes, but many others were there because of gang affiliations that connected them to drugs, truancy, and disorderly conduct. When they were released back to the community they were rarely better for having been locked up. When I went to Farrington, I saw many similarly troubled students, but I also saw how a systematic program of support and interventions turned hundreds of lives away from harmful, anti-social behavior.

The best results were realized when students were worked with in groups on campus and in their natural communities. For many, the gangs replaced dysfunctional families and it made the most sense to work with the entire "family" to change the negative direction in which they were headed. Farrington commits resources to obtain the specialized services needed to support our students. Schools that are unable to find the resources are simply not able to meet the needs of these young people...and they are on all campuses in all communities.

Investment at the front end of a problem almost always costs less than paying for the consequences later. Your support for this bill now, and as it moves through the legislative process, will demonstrate your understanding of how important this investment will be for the future of our State.

I strongly support the allocation of funds for programs that proactively reach out to our youths while working in tandem with schools and communities and other entities.

One current and existing example is Adult Friends for youth (AFY). AFY provides services which are invaluable to students, schools and communities and has specifically and especially been extremely successful in addressing youth and gang violence in Waipahu. The relationships forged by the AFY staff and the youths in the community allow for proactive communication and diffusing of countless potential confrontational situations from actually occurring. My name is Ronald Oyama, Vice Principal of Farrington High School.

I would like to submit a testimony on behalf of Adult Friends for Youth. I have been at Farrington High School for 9 years, and in the Department of Education for 26 years. Farrington High School has a steady enrollment of approximately 2,400 Students. We are currently servicing about 5 federal housings, and our poverty level is at approximately 59%.

Like me, before I transferred to Farrington High School, most of the public never experienced or had to deal with our youth that are being attracted to the gang life and the provisions that gangs provide for our young men and ladies. It gives them a home, a belonging, an identity, a sense of pride, and in most cases, love. I have come to know many members in gangs and let me say, they are young men and women, growing up, looking, searching and longing for a place to call home. A place and company where they truly feel the love and the respect that they are searching for. Many of our students in gangs have gravitated towards each other because they do not feel safe in our community.

It's different to work with, help, and deal with our students affiliated with gangs and all the deep rooted issues that comes with them on a daily basis. These students who are gang members are your sons, your daughters, your nieces and nephews, your grandchildren. They are searching and yearning for a better life just like anyone else. They just been looking for this in the wrong places. They need support, but who has the time to deal with our children who have some deep rooted, twisted childhoods, and unspeakable secrets that no one will ever hear of?

Many times students affiliated with or in gangs are dealing with issues that they have no outlet to express, no one to navigate and help them through their issues within themselves or with others. Many times the feeling of helplessness turn into rage, paranoia, false pride, and then violence. This is when the public then hears about the gang violence on the streets, in their neighborhoods, and the animosity and hostility that stems from deep rooted confrontations from past generations.

AFY has been a huge force and influence on our campus and in our students' lives. They take the time to deal with our groups and through their therapeutic discipline, they navigate through the groups' and individuals' needs, feelings, and emotions. Our students affiliated with gangs need to be heard, to be supported, to have someone they can truly pour out their feelings to. AFY has been there for them. AFY supports ALL Clients, even after graduation and into their adult lives. Their doors are never closed. AFY clinicians are available to our student clients 24 – 7 and are on the clock with them anytime they need help and support. Our administers, counselors, social workers, and security has worked hand in hand with AFY whenever we have had confrontations, fights, and gang wars. AFY has very strong relationships with our gang members and they are deeply trusted and respected. This is one of the reasons we have made huge strides when reconciling, mediating, and returning our campus back to normalcy. Without AFY our school cannot function. We cannot duplicate the services, time, and specialty that they have perfected

over the years. Without AFY I fear there will be no one that the gangs will trust, relate to, and feel that they are understood.

I am asking you to please consider their request for funding. We need AFY not only for our school, but our community, and most importantly for the students that need help, love, and understanding. I am writing in support of HB2163. I am an educator that has worked in Kalihi for over 20 years. I was an elementary teacher for 14 years, a counselor at Farrington for 10 years and most recently as an administrator.

I have watched many of my students go from kindergarten to college. I have also watched the negative aspects of the community take its toll on my students who have started using drugs, gotten involved in gangs, dropped out of high school and become part of the cycle of incarceration. I read once that it only takes one influential adult to change the course of a child's life. The questions is which adult will that be, and which direction will they be sent.

As an outreach counselor at Farrington I was tasked with helping students who couldn't make it in the regular classes find success in alternative programs on and off our campus. My students had a multitude of issues which in turn affected their success academically. Many didn't come to school regularly and when they did, found themselves in the middle of or the cause of every fight. My students were mostly gang involved and most of them adjudicated in the juvenile court system. I learned early on that the key to helping my students was the relationship I created with them, not when we were in the middle of a crisis, but when things were quiet and trust could be built. As a school counselor there was a limit to what I could do for my students, but it was never too much for AFY.

Developing a relationship with teens, especially at risk teens is not easy and takes time. The staff at AFY are able to develop trusting relationships by working with students in weekly group meetings on campus and then go into the community and work with students where they live. AFY staff take the students on "outings", showing them positive, pro-social activities they can do together that are not only fun but legal. They teach our students the power of mediation by walking them through the process and the value integrity by teaching them to keep their word. The trust that is built with our students is invaluable when crisis arises. We call AFY who are able to defuse potentially dangerous situations by going to the homes of our students to work with them and their families. I've actually lost count of the number of times that AFY was able to help rival gangs peacefully resolve their conflict. .

Over the last 12 years I've watched AFY build relationships that started when they were in high school and continue into their adult lives. Supporting HB2163 will allow AFY staff to continue to be the one adult that positively changes the lives of our at risk youth.

At first I thought I have let my mom down but AFY gave me a second chance to redeem myself. I graduated from the program and now I am a student at Honolulu Community College majoring in liberal arts. I am trying to get my requirements so that I could try to transfer into a university and try to better my life.

About nine months ago I was in Las Vegas, Nevada and I was convicted of burglary, home invasion, and conspiracy. I got sentenced to six months of probation and fifty hours of community service. When I refused, the judge informed me that they were going to throw me into a juvenile detention home until my eighteenth birthday, to serve time for the crimes I committed. My loving mother came up with the idea of sending me to Hawaii to the rest of my family members as a form of punishment. The only way for me to stay out of 'juvie' was to come to Hawaii but double my probation period and community service hours. Two weeks later, I was on my way to Hawaii.

After being on the Island for three weeks, my Aunty was taking my cousin Paea to the C-Base program at AFY and told me to tag along. Arriving at the AFY office, Paea introduced me to Lisa (AFY staff). I was referred to AFY because I was short on credits, one year of probation, and a hundred hours of community service. Lisa, Jeff, and the other staff members helped me complete my hours of community service within two months by helping around the office. AFY helped me create a resume and get my worker's permit to find a job. I was able to apply and got hired at Domino's pizza where I have been employed for five months now. I am currently in AFY's C-Base program and I will graduate in September 2016.

If it wasn't for agencies like AFY, I would still be running around with my friends making bad choices and I would be unemployed. I hope my story will impact others to never give up and to know that they matter. Especially, youth like me who deserves a second chance. We are human and everyone makes mistakes. Also, don't judge a book by its cover because you don't know what their story is.
