TESTIMONY ON HOUSE BILL NO. 2169, RELATING TO SOCIAL WORKERS.

TO THE HONORABLE DEE MORIKAWA, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is May Ferrer, Executive Officer for the Social Workers Program,

Department of Commerce and Consumer Affairs ("Department"), Professional and

Vocational Licensing Division. The Program appreciates the opportunity to submit

testimony offering comments on House Bill No. 2169, Relating to Social Workers.

House Bill No. 2169 revises the supervision requirements for the licensure of clinical social workers by deleting the requirement of direct face-to-face individualized supervision, and replacing it with supervision that may be face-to-face or via a Health Insurance Portability and Accountability Act-certified ("HIPAA-certified") video conferencing service. By deleting the requirement for individualized supervision on page 4 line 14, it is not clear what type of supervision would have to occur to meet the

sixty hour requirement. The Department recommends that the individualized supervision requirement be retained.

Regarding the language in the bill that would provide for face-to-face or HIPAAcertified video conferencing, the Department recognizes that a number of states have begun to authorize face-to-face electronic supervision and understands that this mode of supervision will facilitate supervision in rural areas. The Department suggests that rather than allowing all the supervision to occur in this fashion, the committee consider retaining at least some in person face-to-face supervision. The Department also requests that the bill include a definition of HIPAA-compliant video conferencing so that the required mode of video conferencing is clear.

Regarding the revisions on page 5 line 20 to page 6 line 1, the Department supports this revision. The Department finds that this language is prohibitive to some individuals who are not able to obtain supervision within their employing agency because a qualified Licensed Clinical Social Worker may not be available, or because the agency does not allow for supervision to take place on site.

The National Association of Social Workers, Hawaii Chapter (NASW) strongly supports House Bill 2169, relating to social workers, with an amendment.

- NASW Hawaii represents 865 members
- There are currently 1,952 Social Workers licensed by DCCA.
- Tele-medicine has become standard practice in the Social Work/Mental Health field and should be allowed for garnering supervision.
- Social Workers on the neighbor islands, rural Oahu and some Department of Veteran's Affairs Social Workers are currently challenged to meet the statute requirements for direct "Face to Face" Supervision.
- Rural Social Workers qualified to provide supervision for the LCSW Certification are limited in number.
- Universities across the Nation offer both bachelor and masters level Social Work Degrees via technology, which does not require direct in-person "face to face" instruction.

Comments: Greetings: I support HB2169, regarding supervision for social workers in Hawaii. The need for supervision by mental health practitioners seeking licensure who also live in rural areas or on the neighbor islands has created unnecessary hardship on those who seek to advance their knowledge, experience, and credentials in the field of social work. I would also like to advocate that special exception be provided on SECTION 2, (3) (c), line 5 for social workers who are Veterans, Service Members, and their Family (SMVF) members who often struggle to meet the supervision restrictions tied to accumulating sufficient supervision hours "within no more than five years". This limitation presents undue hardship to SMVF whose first priority may be serving our country, as dependents supporting a loved one who experiences multiple changes in duty assignment, or who may require special consideration related to their status as a Veteran. I recommend current language be retained, but with addition language similar (or simplified) indicating the following caveat, "exception being provided to Veterans, Service Members, and their family members who may request extension to the limit of five years, with written statement detailing the reason for the request for extension and verified by written statement from the applicant's current supervisor." My name is Loren Case and I am a graduate student at the University of Hawai'i at Mānoa (UHM) in the Social Work Distance Education Program. My current location is on the Big Island of Hawaii. I am writing in support of HB 2169 to clarify the supervision requirements for licensure of clinical social workers through face-to-face supervision or via Health Insurance Portability and Accountability Act-certified video conferencing service.

During my time as a graduate student on the Big Island I have had the chance to do multiple internships with the Judiciary and Department of Health. During my internships video conferencing was a vital piece for communication with clients and other centers. On the Big Island the demand for social work services are most needed in rural areas where transportation options are limited. Fewer Licensed Clinical Social Workers work in rural areas and thus it is very important to have the option for supervision via video conference service. During one of my internships I had to drive two hours a day just to get to and from my supervision sessions which was very challenging mentally and financially.

Due to rural locations throughout the State of Hawaii where individuals seek out work and experience to fulfill their total of three thousand hours, it is important to integrate the requirement of face-to-face supervision with supervision via Health Insurance Portability and Accountability Act-certified conferencing service which will count towards the required one hundred supervision hours. The reason being that it is difficult for individuals in rural areas to meet the face-to-face supervision requirements. Transportation is poor in most of the rural areas and many centers have been starting to use video conferencing services as a main way for communication. For these reasons, I strongly urge you to support HB 2169.

This is critical as rural areas have a shortage of licensed professionals able to provide face-to-face supervision.

Chair Morikawa, Vice Chair Kobayashi and members of the House Committee on Human Services. I am testifying in strong support of HB 2169 Relating to Social Workers.

I was the Executive Director of the National Association of Social Workers, Hawaii Chapter in 1994 when we first established the LSW license for social workers in the state and in 2002 when we added licensing for bachelor level social workers (LBSW) and clinical social workers (LCSW). At that time, 14 years ago, the technology for video conferencing was still fairly new and not fully accepted as a means of communication for a profession that is historically based on face-to-face interaction. In fact, at that time we were very skeptical and cautious about using technology to do therapy. Today the technology has matured and become very sophisticated. Security and privacy issues have been resolved and it is an accepted mode of communication. Telehealth including the use of technology for therapeutic purposes is much more widely accepted than in 2002. In fact, professional education for our degrees and continuing education courses are also now provided via teleconferencing or online. Our professional practice has evolved to embrace technology and so must our statute change to incorporate these new advances.

This bill allows the <u>option</u> of either face-to-face or a HIPAA compliant video conferencing to meet supervision requirements for licensing. Additionally, this will make it easier for our colleagues on the neighbor islands to receive supervision for their clinical license.

We need our profession to keep up with the times and HB 2169 will help us do that. Thank you for the opportunity to testify in support of HB 2169. RE:SB2269/HB2169
