In consideration of HOUSE BILL 2176 RELATING TO ENVIRONMENTAL PROTECTION OF MAUNALUA BAY

House Bill 2176 proposes to establish the Maunalua Bay Task Force to study and develop recommendations for the Maunalua Bay master plan. The Department of Land and Natural Resources (Department) opposes this measure. The Department has lead jurisdiction for regulation of activities in Maunalua Bay and is actively engaged with stakeholders in current planning efforts for the bay.

Maunalua Bay fronts one of Hawaii's most highly populated areas, with a population of over 60,000 immediately adjacent to the bay. The Department's jurisdiction over activities impacting the bay includes forestry and wildlife, aquatic resources, boating and ocean recreation, historic preservation, and conservation and resource enforcement, among others. Examples of resources and threats over which the Department has oversight are upland forest quality and degradation, the freshwater streams in the many watersheds emptying into the bay and issues of water quality and sediment; coastal shorebirds and habitat stewardship; historic fishponds; the marine resources including seagrass beds, reefs and open waters and issues of fisheries depletion and invasive algae; and the many commercial and recreational boating uses including swimming, surfing, fishing, paddling, diving, and thrill craft and user conflicts and safety issues. All of these resources are the public trust responsibility of the Department.

This Department jurisdiction brings responsibility for regulating activities through both local and statewide regulations. Many of these regulations need to be brought up to date to address current conditions. The Department has been actively involved in bay-wide initiatives for community engagement in recent months.

- The Department's Division of Boating and Ocean Recreation (DOBOR) recently formed the Maunalua Bay Recreational Advisory Committee (M-RAC). The purpose of forming the M-RAC is to create a framework to solicit public input on DOBOR rules for ocean recreation in Maunalua Bay. The M-RAC will be given short term (six mos), Mid-range (1-3 yrs), and Long-term (ongoing) goals for the management of Maunalua Bay and will submit recommendations to DOBOR who will then review and propose amendments to the Hawaii Revised Statutes (HRS) or Hawaii Administrative Rules (HAR) if warranted. A full description of the M-RAC can be found on the DOBOR website at http://dlnr.hawaii.gov/dobor/mrac/.
- A comprehensive community initiative is underway by Mālama Maunalua to begin a marine spacial planning process, which is a public process used successfully around the world in a broad collaborative method of gathering input and analyzing and allocating the spatial and temporal distribution of human activities in marine areas to achieve identified ecological, economic, and social objectives. This includes a comprehensive array of stakeholders in the bay, including fishers, boaters, recreational users, and others totaling close to 30 stakeholder groups, with a goal to engage in broad and deep dialogue to resolve user conflicts and propose updated regulations to manage our natural and cultural resources and recreational and commercial uses. The Department has been participating in an ex-officio capacity.

The Department is the necessary lead governmental entity for these community engagement initiatives, since the end result of proposed regulations would need to be approved by the Board of Land and Natural Resources and implemented by the Department. The Department believes these initiatives are already well underway and should be allowed to continue, in their current form or as otherwise initiated by the Department to ensure comprehensive stewardship oversight, without being supplanted by a new task force, nor one led by the Office of Planning which does not have the jurisdictional responsibility for regulating activities for the bay that the Department has. Department Testimony: The Department of Health (DOH) respectfully offers comments on this measure. The purpose of this measure is to establish a Maunalua Bay task force to create a comprehensive Maunalua Bay master plan. While the DOH supports the formation of a task force, we believe that the master plan for Maunalua Bay should address the U.S. Environmental Protection Agency's (EPA) nine key elements of a watershed-based plan (WBP). The targeted watersheds could then become eligible for federal grants.

8 WBPs provide a roadmap for how watersheds will be managed and are important tools 9 used by federal, state, and local entities to protect water quality and water resources. Specifically, 10 WBPs identify strategies and activities, including best management practices, to improve stream 11 and coastal water quality by reducing and preventing land-based and marine sources of pollution. 12 WBP implementation has resulted in significant pollutant load reductions and water quality 13 improvements throughout the state.

The DOH Clean Water Branch (CWB) Polluted Runoff Control (PRC) Program
implements WBPs using Clean Water Act (CWA) Section 319 grants, which are awarded to the
PRC Program annually by the EPA. Prior to implementation using CWA Section 319 funds, the

WBP must be approved by the DOH-CWB to ensure that the WBP addresses the EPA's nine key
elements of an effective watershed plan, which are described in detail in the EPA's *Handbook for Developing Watershed Plans to Restore and Protect Our Waters* (March 2008) and the *Hawaii Watershed Guidance* (prepared in 2010 by the Office of Planning, Coastal Zone
Management Program). The DOH-CWB suggests that these nine key elements be addressed in
the Maunalua Bay master plan in order for the entire Maunalua Bay to be eligible for CWA
Section 319 funds for water quality improvement projects.

8 Currently, Wailupe watershed is the only watershed with an approved WBP within Maunalua Bay. The PRC Program funded the development of the Wailupe WBP in 2008 and 9 implemented a project from the Wailupe WBP from 2011 to 2014 to demonstrate best 10 management practices at Wailupe Beach Park, resulting in load reductions of total nitrogen, total 11 phosphorous, and sediment. Based on the Statewide Geographic Information System Program's 12 watershed data, six additional watersheds—Waialae Nui, Niu, Kuliouou, Kamilo Nui, Kamilo 13 14 Iki, and Portlock—will be eligible to receive CWA Section 319 funds to improve water quality if 15 the nine elements of a WBP are included in the Maunalua Bay master plan. Expanded efforts to 16 control polluted runoff in Maunalua Bay have the potential to benefit the local community by 17 providing cleaner, safer waters for cultural, recreational, and commercial use.

Offered Amendments: The DOH-CWB suggests the following revision to S.B. No. 3028,
Page 5:

"SECTION 4: The master plan, as approved by the director of the office of planning,
shall include an assessment of the environmental and ecological activities on the bay. <u>The master</u>
plan shall address the nine key elements of watershed plans, as described by the *Hawaii*<u>Watershed Guidance</u>. The master plan shall be used by all appropriate state agencies in the
adoption and implementation of policies, rules, and regulations relating to Maunalua Bay."

Department Testimony: The Department of Health (DOH) respectfully offers comments on this measure. Chairs Ing and Lee, Vice Chair Lowen, and Members of the House Committee on Ocean, Marine Resources, and Hawaiian Affairs, and House Committee on Energy and Environmental Protection.

The Office of Planning (OP) opposes HB 2176, which proposes to establish the Maunalua Bay Task Force whose purpose and function is to create a comprehensive Maunalua Bay master plan. The proposed task force may be duplicative of existing and ongoing initiatives in the area involving the Department of Land and Natural Resources (DLNR), the agency that has lead jurisdiction for regulation of activities in the Bay.

The Maunalua Bay Recreation Advisory Committee (M-RAC) provides an existing framework for the public to submit input on DLNR, Division of Boating and Ocean Recreation rules for ocean recreation in Maunalua Bay. The M-RAC is also charged to develop and provide to DOBOR short-term, mid-range, and long-term management goals for Maunalua Bay. "Imua Maunalua" is a recent community initiative to begin a marine spatial planning process that will encourage robust dialogue to resolve user conflict and propose updates to regulations to better manage natural and cultural resources, as well as recreational and commercial uses, in Maunalua Bay.

The Office of Planning feels that these initiatives should be allowed to run their course without an additional layer and duplication that the proposed Maunalua Bay Task Force would impose.

Malama Maunalua testimony on HB 2176 and companion bill SB 3028

As a community-based organization with the vision of *a Maunalua Bay where marine life is abundant, the water is clean and clear, and people take kuleana in caring for the Bay,* Malama Maunalua **supports** the bill. As the state agency with established management authority over Maunalua Bay, DLNR would be the appropriate agency to be charged with creating the Maunalua Bay Task Force to create a comprehensive, ecosystem-based Master Plan. The designated agency should be provided funding to perform its functions identified in the Bill.

Malama Maunalua believes it is important that both the ecological and economic integrity of the Bay are understood, taken into consideration, and protected and we support a Maunalua Bay Task Force that achieves this balance.

The Livable Hawaii Kai Hui is a 501(c)(3) non-profit, non-partisan community organization serving East Honolulu, established in 2004. Our mission is to uphold the integrity of the East Honolulu Sustainable Communities Plan which sets guidelines for sensible development respectful of Hawaiian cultural and natural resources that make East Honolulu a unique place to live. Our projects in Maunalua go mauka to makai and include: Hawea Heiau Complex, Keawawa Wetlands, the agricultural lands in Kamilonui Valley, Pahua Heiau, and Ka Iwi coast and mauka lands with Maunalua Bay an area of strong interest.

The Livable Hawaii Kai Hui strongly supports House Bill 2176 seeking to create and establish a Maunalua Bay Task Force. We understand the Task Force would include representatives from active community organizations in Maunalua, commercial operators and appropriate State Agencies to come together to identify, study and recommend ways to address use, protection and care for Maunalua Bay now and for the future. All involved are important stakeholders in Maunalua Bay.

Numerous community groups from the Maunalua area recognize that the status quo must be addressed. We have come together to do our part to ensure we have a voice in the health, care, use and protection of Maunalua Bay. HB 2176 provides the process of how the Task Force will be put together.

HB 2176 also allows the stakeholders of Maunalua Bay to have a seat at the Task Force table and to have an equal say in the future of Maunalua Bay.

The Maunalua community groups from Hawaii Kai to Aina Haina in this initiative are:

Aina Haina Community Association Fisher Hui of Maunalua Hui Nalu Canoe Club HULI Livable Hawaii Kai Hui Maunalua Fishpond Heritage Center Malama Maunalua Portlock Community Association As you can see, these Maunalua community groups represent a large number and wide range of users of Maunalua Bay, all who want to have an active voice in working for the health and care of Maunalua Bay through the establishment of the Maunalua Bay Task Force with HB 2176.

Many of these groups have worked for years for the care of the bay and through this community initiative, which we worked on together, it allows a true voice for our community in policy making. It's an unprecedented initiative for the Maunalua community, with all of these groups coming together, for the same shared goal; the health of Maunalua Bay. In addition, this initiative did not start, and is not part of, any Federal agency. This initiative was created for and by Maunalua community groups.

There is precedent set for community involvement by in protecting ocean resources with DLNR. The Haena Community Based Subsistence Fishing Area was signed into law in 2014 with "strong recognition that government cannot do it alone." This community initiative looks to have community, commercial operators and state agencies working together for Maunalua Bay.

Currently, the Dept. of Land and Natural Resources has put in place the Maunalua Recreation Advisory Committee (M-RAC). However, M-RAC only serves one purpose for Maunalua Bay and that is to review new commercial permits for the bay. http://files.hawaii.gov/dlnr/dobor/rules/amend/Amend-13-256-3-4.pdf

"The department may establish and maintain a Recreation Advisory Committee of not less than three for each recreation management area as defined in this chapter to review and make recommendations for commercial use permits or catamaran registration certificate to be issued by the department."

On the M-RAC, five members represent those who use the bay for ocean activities both commercial and recreational. It only includes one resident and does not include other groups who also have an interest in the health of the bay. A strong relationship exists between the watersheds that flow into the bay and the health of the bay, the MRAC completely excludes these communities.

The Maunalua Bay Task Force will be a far more comprehensive process and one which will have the Maunalua community discuss and identify the environmental issues of the bay that are a shared cause of concern. The Task Force will work together to execute policy for how to help care for Maunalua bay.

We do hope the House Ocean Marine Resource and Hawaiian Affairs Committee, the Energy and Environmental Committee and the Finance Committee support this amazing community initiative for Maunalua and Maunalua Bay.

In Consideration of HOUSE BILL 2176 RELATING TO ENVIROMENTAL PROTECTION OF MAUNALUA BAY

House Bill 2176 establishes a Maunalua Bay task force to study and develop recommendations for a Maunalua Bay master plan. The Aha Moku SUPPORTS this measure with amendments.

The Aha Moku encompasses the eight main Hawaiian Islands, which in turn is comprised of 47 moku and 607 ahupua'a, each one of which is individual and unique with its own natural resources. The focus of the Aha Moku System, as stated by this Legislature is to assist the State in the protection and sustainability of its distinctive natural and cultural resources by bringing forward Native Hawaiian generational and traditional resource methodology that together with scientific expertise may further protect our natural assets. On Kakuhihewa, O'ahu, there are six moku (Waialua, Waianae, Ewa, Koolauloa, Koolaupoko and Kona) with 88 ahupua'a among them. This measure impacts two of the six moku of O'ahu.

Maunalua Bay is unique in that its resources are shared by two moku, Kona and Koolaupoko. It belongs in the Koolaupoko Moku, but borders the Kona Moku ahupua'a of Kuliouou, Niu and impacts Wailupe and Waialae. Freshwater springs fed by artesian water made Maunalua a famous fishery. Once the largest thriving fishpond within the Hawaiian Islands, the 523-acre *Keahupua O Maunalua* fishpond is now the site of the Hawaii Kai Marina and the community of Hawaii Kai.

The bill cites the Kaneohe Bay Master Plan as a blueprint for effecting change, eliminating conflict, and generating public input to fulfill the Legislature and community kuleana to protect and preserve the natural resources of Maunalua. Today, it is often difficult to protect these natural resources because of the influx of invasive species which, because they are not native to Hawaii, often causes irreparable harm to our endemic and indigenous land and marine species. Development in the area caused the destruction of one of the largest and most productive fishponds in all of the Hawaiian Islands. Together, invasive species and man's need for development effectively destroyed the fisheries of east O'ahu. And while the fishpond itself cannot be restored, the history of Maunalua can be used as an educational tool on the importance of returning this once pristine ecosystem to a stable natural environment.

HB 2176, OMH-EEP, 02/17/16 Page two

Our recommended amendments are listed in Section 2 of this bill. Portions we hope to have deleted are (bracketed with strike outs). Our recommended language is **underlined** and in **bold**.

SECTION 2. The office of planning shall create a Maunalua Bay task force whose purpose and function shall be to create a comprehensive Maunalua Bay master plan, in consultation with members of the community. Upon approval by the director of the office of planning, the master plan shall be presented to all appropriate state agencies that have jurisdiction in Maunalua Bay.

The task force shall be composed of twelve members as follows:

- (1) The director of health or the director's designee;
- (2) The chair of the board of land and natural resources or the chair's designee;
- (3) One member appointed by the governor to represent commercial ocean recreation activities;
- (4) The director of the University of Hawaii institute of marine biology or the director's designee;
- (5) The president/executive director of the Portlock Community Association or

the president/executive director's designee;

(6) (The president/executive director of the Aina Haina Community Association or the president/executive director's designee) The president of the Maunalua Hawaiian Civic Club or the president's designee;

(7) The president/executive director or the president/executive director's designee of the Maunalua Fishpond Heritage Center;

(8) The president/executive director or the president/executive director's designee of the Livable Hawaii Kai Hui;

(9) (The president/executive director or the president/executive director's designee of the Fishermen's Hui) The Chairperson/designee of the Hawaii Kai Neighborhood Board;

(10) (The president/executive director or the president/executive director's designee of HULI) The Chairperson or designee of the Kuliouou-Kalani Iki Neighborhood Board;

(11) The president/executive director or the president/executive director's designee of Hui Nalu;

(12) The president/executive director or the president/executive director's designee of Malama Maunalua;

(13) A representative from the Office of Hawaiian Affairs; and,

(14) A Native Hawaiian cultural practitioner of the Maunalua Ahupua'a.

We believe this measure is greatly needed and humbly ask that our recommendations be considered.

HB2176 proposes to establish a Maunalua Bay task force to study and develop recommendations for a Maunalua Bay master plan. The following are germane:

- The Department of Land and Natural Resources (DLNR) has over-arching oversight of Maunalua Bay. The need for a task force outside of DLNR to develop a Maunalua Bay masterplan is not established.
- The composition of the proposed task force nurtures special interest groups, some of which are, at best, loosely established, and results in less than comprehensive representation of all interested stakeholders.
- DLNR processes are in place to monitor and manage the Bay: The Bay is an Ocean Recreation Management Area (ORMA) and DLNR recent establishment of M-RAC (Maunalua Bay Recreation Advisory Committee). M-RAC is a DLNR established group, the scope of M-RAC responsibility is thereby at the discretion of DLNR.
- The proposed task force needs to include a science component, to support any evaluation of the state of the Bay and, going forward, introduce science-based initiatives that provide measurable, comparative data.

Please accept this testimony as opposition for the following reasons:

- The Bill aims to create a Task force with the majority leadership composition of Private Special Interest Groups. These groups have pre-determined special interest opinions and agendas regarding the commercial and recreational use of the bay, and these opinions <u>do not</u> represent the interests of the greater community as a whole.
- 2) The Bill claims it is similar to Kaneohe Bay Task Force which should serve as a master plan. However the structure of the task force this bill aims to create does not include Public represented or elected participation. I'd like to re-iterate item #1 above: the Task force suggested by this bill for Maunalua Bay is made of special interest and private groups who are noted to oppose commercial and recreational activity. Kaneohe Bay task force did not include a majority of Private interest groups.
- 3) A task force created by this Bill could create conflict with, derail, or circumvent the efforts of the DNLR M-RAC group. DNLR M-RAC process included nomination and voting that was open to the public. The M-RAC purpose was to have a representation of public input on the DOBAR rules for Maunulua Bay.
- 4) The Bill states "heavy use" of the bay by sport-related groups and commercial ocean recreation entities as an underlying motivation for the Bill and task force itself. These statements are made as "fact", but without noted data support. The statements presume the task force will have a pre-agenda of special interest groups to control the bay's activity.
- 5) The Bill states that DNLR itself would have to adopt the plan of the task force to regulate the bay, placing the state government publicly supported trust under the power of a task force made up of private interest groups.

Please consider this memorandum in support of HB 2176 Relating to Environmental Protection of Maunalua Bay, which creates a task force comprised of representatives from active community organizations and appropriate state agencies to study and recommend measures to promote the health and viability of the Bay and to resolve conflicts among users of the Bay.

This bill grew directly from a community initiative and evolved through years of discussion about the threats to Maunalua Bay and possible remedial actions.

How are the proposals in HB 2176 different?

The bill is different in other respects from other prior efforts to address problems at Maunalua Bay: for one, the bill does not challenge the right of any group to enjoy, make a living, or seek to establish a sanctuary in or from the Bay. All positions have a right to be heard, a seat at the table; secondly, the bill seeks to establish a means to allow the E. Honolulu community to affect and implement policy, and not simply provide a sounding board; additionally, the bill does not focus on issues per se but seeks to establish a mechanism, a tool, by which issues of concern to all can be addressed in a civil manner; finally, the bill leaves to the task force the job of ascertaining just what issues are common cause to all of the constituent groups.

The intent is that the task force provide the opportunity for persons of divergent positions to participate in a civil dialogue and find worth in compromise for the benefit of the larger public interest. In this sense, the task force may be a blueprint for success in other areas of conflict in the Islands.

What about opposition to the bill?

It is dismaying to consider the amount of misinformation and nay-saying that have presented themselves as opposition to this bill from one group in particular, the Hawaii Kai Marina Association, which declined to join the community initiative for Maunalua Bay and then opined that the initiative is faulty because it does not include all stakeholders. (!) In reality, the community initiative sought to involve all groups in E. Honolulu that have been active in pursuit of measures that would increase the health and viability of the Bay. All were, and continue to be welcome to a seat at the table.

Despite readily available information to the contrary, the Hawaii Kai Marina Association also continues to drag a red herring across consideration of establishment of a task force to address issues of health and viability for Maunalua Bay. That red herring is the Maunalua Bay Recreation Advisory Committee (MRAC), established by Chapter 256-3(b) of Title 13, DLNR Ocean Recreation Management Rules, which pertains solely to issuance of commercial operator permits and not to the wide variety of issues that may come before the task force sought by the bill before the committee:

§13-256-3 Commercial operator permit requirements. (a) All operators of commercial vessels, water craft or water sports equipment shall apply for a commercial operator permit to be issued by the department. The applicant for such permit shall comply with the applicable provisions stated in Hawaii Administrative Rules, and Ocean Waters, Navigable Streams and Beaches, Sections 13-251-1 through 13-251- 20. A valid commercial use permit issued to the owner of a vessel to operate from state harbor or launching ramp facilities shall satisfy the commercial operator permit requirement of this section for the operation of that particular vessel. (b) The department shall establish and

maintain a Recreation Advisory Committee of not less than three for each recreation management area as defined in this chapter to review and make recommendations for commercial operator permit to be issued by the department as required by this section. The department shall consider the recommendations of the Advisory Committee, but is not bound by the recommendations. Members of the Recreation Advisory Committee shall have not less than three years Unofficial Compilation 256-8 experience in their area of specialty.

The task force proposed by HB 2176 would have the opportunity to address issues far and beyond the issuance of commercial permits, for example, ecological challenges to the health of Maunalua Bay arising from:

* Effects of Population Growth - span of 50 years from over 2,000 people in 1959 people to over 60,000 in 2015 (Hawaii Kai to Kahala)

- * Channelizing of the natural streams in Maunalua
- * Outdated and ineffective management of bay activities, leading to conflict and overuse
- * Illegal fishing and lack of enforcement of fishing rules in the bay
- * Pollution from unfiltered land sources
- * Endangerment to fish and coral population

And anything else that might come before the task force.

Finally, in being merely advisory, the MRAC does not come near fulfilling the role proposed for the task force.

HB 2176l does not request state funds. This choice is neither naïve nor pollyanna. Members are prepared to be resourceful, to involve the entire community in meeting its needs. For example, to enlist the assistance of the University of Hawaii to facilitate meetings (as what's been done with other community initiatives), to obtain pro bono legal assistance in making sure of adherence to open meetings provisions and possible legal research, and to bring Hawaiian kupuna and community scientists into the discussions. We believe people will step forward to help when it's a matter of improving the Bay as this is what's been done in the past in Maunalua.

I respectfully request that the committee pass this measure. Thank you for the opportunity to provide testimony in support.

Vote NO on HB 2176 I am submitting this as a private citizen, but must disclose that I currently serve on Livable Hawaii Kai Hui Board, the Hawaii Kai Neighborhood Board, and the Hawaii Kai Marina Community Association Board.

Here are the major reasons I OPPOSE the bill HB 2176:

1. <u>Weighted composition of the proposed task force</u>:

• 8 of the 12 members are from specified *private interest groups*.

• A number of these organizations are loosely structured; i.e., not formally established, have no obvious point of contact. Membership of some is not public or not open to all stakeholders.

• These groups should not be granted a special privilege to dictate policy to the DLNR when there is no indication that they represent the interests of the greater community as a whole (all stakeholders). Some of these groups do good work, but the proposed composition is clearly lopsided.

2. <u>DLNR's M-RAC is already formed to fulfill the same role as</u> the proposed task force.

• DLNR recently established the Maunalua Bay Recreation Advisory Committee (M-RAC). M-RAC members were elected by the public *via a completely transparent nomination and election process*.

1. <u>Weighted composition of the proposed task force</u>:

• 8 of the 12 members are from specified *private interest groups*.

• A number of these organizations are loosely structured; i.e., not formally established, have no obvious point of contact. Membership of some is not public or not open to all stakeholders.

• These groups should not be granted a special privilege to dictate policy to the DLNR when there is no indication that they represent the interests of the greater community as a whole (all stakeholders). Some of these groups do good work, but the proposed composition is clearly lopsided.

First of all, the DL&NR is currently working on the M-RAC program which has the same purpose as this bill. Secondly, this bill states "demands on the bay have increased many fold, due in part to intensive commercial use of the bay and its appeal to tourists". This is factually incorrect. Several years ago the DL&NR put an ORMA permitting system in place. Since its inception, the ORMA permits in Maunalua Bay have steadily decreased if not gone away totally. Initially there were 4 Thrill Craft permits, now there are 2. There was a towing permit, that one is gone. There was also some high speed boat permits which are also gone. These particular permits are heavily regulated and limited on operating days and times, they are also required to pay 3% of their gross to the DL&NR. Some of these regulations were put in place to prevent user conflicts, which has been successful. Commercial, special interest and private users have co-existed in this bay for several years without incident.

I have been unable to find any useful purpose for this bill. Please DO NOT pass this bill.

Please accept this testimony in opposition for the following reasons:

A task force created by this Bill could create conflict with, derail, or circumvent the efforts of the DNLR M-RAC group. DNLR M-RAC process included nomination and voting that was open to the public. The M-RAC purpose was to have a representation of public input on the DOBAR rules for Maunulua Bay.

The Bill states "heavy use" of the bay by sport-related groups and commercial ocean recreation entities as an underlying motivation for the Bill and task force itself. These statements are made as "fact", but without noted data support. The statements presume the task force will have a pre-agenda of limiting or restricting the bay's use by sport-related groups.

The Bill aims to create a Task force with the majority leadership composition of Private Special Interest Groups. These groups have pre-determined special interest opinions and agendas regarding the commercial and recreational use of the bay, and these opinions **do not** represent the interests of the greater community as a whole.

The Bill claims it is similar to Kaneohe Bay Task Force which should serve as a master plan. However, the structure of the task force this bill aims to create does not include Public represented or elected participation. I'd like to re-iterate item #1 above: the Task force suggested by this bill for Maunalua Bay is made of special interest and private groups who are noted to oppose commercial and recreational activity. Kaneohe Bay task force did not include a majority of Private interest groups.

The Bill states that DNLR itself would have to adopt the plan of the task force to regulate the bay, placing the state government publicly supported trust under the power of a task force made up of private interest groups.

HB 2176 recognizes the importance of Maunalua Bay as a treasured resource and seeks to establish management plans to insure long term protection of its environment. The bill identifies many of the recognized users of Maunalua Bay and suggests that the Bay is negatively impacted by these users and that legislative action is needed to develop appropriate management plans for the Bay.

The importance of Maunalua Bay and its environment to the people of Hawaii goes without question. However the task force approach provided by HB 2176 would not only duplicate existing management advisory committees for the Bay, the Maunalua Bay Recreation Advisory Committee (M-RAC), but would circumvent the designated coastal management expertise and responsibilities of the Department of Land and Natural Resources (DLNR).

HB 2176 would require the task force to complete a Master Plan for the Bay to include an assessment of the environmental and ecological impacts of activities on the Bay. How this could be accomplished in the time frame indicated, October 1, 2017, is unclear. Given the size of the Bay, its physical characteristics, and the multitude of habitats and conditions involved, preparing an environmental assessment is not likely to be possible in that length of time. Furthermore, the amount and source of funds that would be required to carry out the assessment along with the other task force responsibilities is not indicated.

In summary, while the intentions of HB 2176 are admirable, existing expertise within the Department of Land and Natural Resources can provide the needed management expertise to accomplish the intent of HB 2176 without the duplication of effort and expense. Therefore, I urge that HB 2176 be deferred.

As a 23 year resident of Hawaii Kai, I speak in opposition to SB 3028/HB/2176.

Why would the legislature need to require *another* state agency to spend time and money to create *another* entity to compete with the democratically elected entity, the Maunalua Bay Recreation Advisory Committee (M-RAC), which DLNR has already established?

Those who seek the creation of this task force obviously do not like the other entity, i.e. M-RAC, and seek to have the legislature allow the proponents of this bill to basically overrule any conclusions or directives from the already established democratically elected M-RAC. They seek this by mandating in this bill the acceptance of any product of this task force by various state agencies. Note this task force is heavily weighted 8 to 4, in favor of these special private interests, whose real leadership, membership, length of existence and true intent is unknown to this committee to the extent justifying the legislature's grant of authority to them. From my long term involvement with various Hawaii Kai community groups and their leaders, I have serious doubts about the true nature of some of these groups and the claimed inclusion of others as actually supporting this legislation.

The bill claims that this is similar to the K-Bay Task Force. This is inaccurate. The K-Bay Task Force did not consist of unknown so-called leaders of special private interests, but members from public entities, including the state, UH and the U. S. Marine Corp

The bill claims the commercial use of the Bay and its "*appeal to tourists*" is having such an effect that these 8 out of 12 special private interests need the authority to create a "master plan" which "*shall* be used by all appropriate state agencies in the adoption and implementation of policies, rules and regulations" relating to the Bay. There is insufficient scientific evidence to support the claim that tourists or pleasure craft are harming the Bay. On the contrary, there is more than sufficient evidence to support the fact that the infrastructure created over the years for the extensive housing development has proven inadequate and outdated to prevent the run-off from the mountains and surrounding land into the Bay. There is no reason to believe that M-RAC and DLNR is incapable of addressing the needs of the Bay and the entire community. The proponents of this bill have not made their case.

I ask this committee to decline to pass this bill. Thank you for allowing me to testify.

The Board of Directors of the 'Āina Haina Community Association write in support of HB 2176 Relating to Environmental Protection of Maunalua Bay, which creates a task force comprised of representatives from active community organizations from the surrounds of Maunalua Bay and appropriate state agencies to study and recommend measures to promote the health and viability of the Bay and to resolve conflicts among users of the Bay.

This proposal is the only effort currently being pursued.¹ It is a joint effort of community-based organizations in East Oahu who see the need for community input over the use and protection of Maunalua Bay. This proposal is based on the development of the Kaneohe Bay Master Plan. The current approach and management has been inadequate in reducing user conflict and preventing degradation of the bay.

There is a precedent for community involvement in protecting its ocean resources. The Haena Community Based Subsistence Fishing Area was signed into law in 2014 with "strong recognition that government cannot do it alone."

The Department of Land and Natural Resources (DLNR) claims that this taskforce is unnecessary because of the newly formed Maunalua Recreational Advisory Committee (MRAC). However, the MRAC is comprised of only six members. Five members represent various ocean activities in the bay, one represents residents. DLNR asserts that the MRAC will recommend rules for ocean recreation in the bay and will determine short, mid, and long-term goals for management of the bay. This framework falls short of what is needed and cannot come up with a comprehensive plan for the bay simply because key stakeholders are not included. There is more to a plan for the bay than merely regulating ocean activities.

¹ Imua Maunalua was "paused" by Malama Maunalua on December 4, 2015.

According to Hawaii Administrative Rules, the MRAC is tasked: "to review and make recommendations for commercial use permits or catamaran registration certificate to be issued by the department." This framework was never intended to draft a management or comprehensive plan for the bay.

Ten watersheds in East Oahu flow into Maunalua Bay. Communities from Waialae Nui to Portlock are stakeholders because their streams flow into Maunalua Bay and affect the health of the bay. Activities along those streams affect the bay.

The Maunalua Bay Region covers approximately 22 square miles of land and seven miles of shoreline, DLNR's MRAC proposal completely disregards the land, whose urbanization affects the bay and disregards the many streams and fresh water sources that feed the bay.

This bill before the committee grew directly from a community initiative and evolved through years of discussion about the threats to Maunalua Bay and possible remedial actions. The 1988 Aotani Study of the Bay and the competing uses resulted in no significant improvements.

The intent is that the task force provides the opportunity for persons who have different perspectives about the bay to come together and draft a master plan for a healthy bay for all to enjoy.

We respectfully request that the committee pass this measure. Thank you for the opportunity to provide testimony in support.
