RELATING TO THE KING KAMEHAMEHA CELEBRATION COMMISSION

Chair Shimabukuro and members of the Committee, thank you for the opportunity to testify on H.B. 2277, H.D. 1. The Department of Accounting and General Services (DAGS) supports H.B. 2277, H.D. 1 (the measure).

- Provides guidance to the member organizations and the Governor on suggested skill sets for selecting commission members to enhance the administrative aspects of the Commission.
- 2. Corrects the names of three membership organizations and replaces one.
- Provides the chairperson with the opportunity to appoint an advisory committee to advise the chairperson on the historical and archival background of the Commission.

HB 2277 HD1 – Relating to the King Kamehameha Celebration Commission

Aloha Chair Shimabukuro, Vice Chair English and members of the committee:

My name is Elmer Ka'ai and I represent the Royal Order of Kamehameha, Chapter One on the King Kamehameha Celebration Commission (Commission). I also serve as the Chair of the Commission; however, this testimony does not represent the position of the Commission.

The Royal Order of Kamehameha has proudly served on the commission since its inception and will continue support all efforts in honor of our Mō'ī Kamehameha I. **We are in strong support of HB 2277 HD1, with a friendly amendment.** This measure provides the Commission with the necessary tools to improve and enhance the operations and management of the Commission.

HB 2277 HD1 adds new approaches that will help improve the Commission's effectiveness. These approaches includes the following:

- Allows for greater statewide representation on the Commission by changing the "Island" representatives to "county" (at-large) representatives;
- Provides the Governor with suggested criteria when seeking individuals for the "at-large" nominees;
- Offers the Commission Chairperson with the opportunity to pull together a group of former commission members and staff to help the Commission's leadership team with their "institutional knowledge" regarding the operation and management of the commission;
- Clarifies the Commission's roles and responsibilities with respect to coordinating versus supporting events and activities; and
- Gives the Commission the opportunity to support all events and activities honoring the Kamehameha Dynasty, currently not recognized by the Commission.

We would like to request a friendly amendment to this measure. **We are asking that the Kapahulu Music Club remain on the Commission.** Like the Royal Order, the Kapahulu Music Club has a long and storied history on the Commission. It is our understanding that Kapahulu Music Club organizational status as a business or community organization was inactive; however, they have recently addressed this matter. The Royal Order supports that each

membership organization maintain a certificate of good standing with the State of Hawai'i issued by the Department of Commerce and Consumer Affairs and an active membership database.

Although, we also believe that return of the Daughters of Hawai'i to the Commission would be a great asset; however, and we will encourage the Commission to consider adding the Daughters of Hawai'i and may other Native Hawaiian organizations, if it is deemed necessary, in the near future.

HB 2277 HD1 is the first measures over the last 20 years that directly addresses one of the oldest Hawai'i Revised Statutes. It is a small step. We encourage the committee passage of this measure and send our deepest mahalo for your continued support for our Mō'ī Kamehameha.

Aloha mai, kākou

I am writing in support of HB 2277, HD1 that proposes to amend the membership, mission, and purpose of the King Kamehameha Celebration Commission; to authorize the chairperson to appoint an advisory committee for historical and archival matters; and to authorize the Commission to appoint an Executive Director.

I am a former commissioner of the King Kamehameha Celebration Commission representing the royal society, Hale O Na Ali'I O Hawaii, Wahiika'ahu'ula. During my tenure on the commission, one of the major stumbling blocks to advancing this celebration was funding. If not for the dedicated, committed members of the Commission and the several hundred volunteers, the celebration might have diminished significantly.

Our chairperson, Elmer Kaai, recognized that to have a vibrant celebration we needed more members with a business sense. No doubt, we are strong on Native Hawaiian culture and protocol – critical to the celebration. But, we also need staff and commissioners strong on business, marketing, philanthropy and public relations; and we need an executive director that would be responsible for all fiscal and administrative matters, including securing public contributions and private foundation grants and donations. Hence, this bill.

The King Kamehameha Celebration holds promise to be a premier event given the right resources. Unlike the other 49 states, Hawaii is the only one that honors monarchs who ruled these islands.

HB 2277 will help us to be that premier event. However, there is one flaw in the bill that we ask you to correct. By error in writing this bill, someone dropped the Kapahulu Music Club. We ask that the bill reflect for Section 8-5, HRS (a) that the Kapahulu Music Club be reinstated on the list of organizations represented on the Commission. Their membership has contributed significantly to the success of the King Kamehameha Floral parade. At one point in time, pa'u units in the parade were but a wish. Ms. Beverly Lee, as a commissioner representing the Kapahulu Music Club revived this tradition, and now the parade has one of the largest pa'u rider contingents. Additionally, she and Kumu Hula Kimo Alama, another member of the Kapahulu Music Club, recognizing the importance of floats in a parade, is hosting a float-building workshop.

The Kapahulu Music Club has a long history with the King Kamehameha Celebration. To discontinue their membership on the Commission would be a travesty and a step back for the Commission. To continue their membership is to honor their legacy of contributions and all those from their club who for years were integral to the success of the King Kamehameha Celebration.

Accordingly, please support HB2277 HD1 with an amendment to **restore the Kapahulu Music Club as a member of the King Kamehameha Celebration Commission.**
