My name is Dana Alonzo-Howeth, and I am the Chief Executive Officer of Community Clinic of Maui, Inc., now doing business as Mālama I Ke Ola Health Center. We are one of two Federally Qualified Health Centers on the island of Maui and serve the entire of island of Maui with the exception of the Hana and Haiku areas which are served by the Hana Community Health Center.

On behalf of our Health Center and those we serve, we strongly oppose HB2466 HD1 which repeals and transfers the balances of various non-general funds, including the CHC Special Fund. What most do not understand is that despite State Medicaid expansion and availability of coverage through the Connector, many residents still do not quality for QUEST and many cannot afford the premiums associated with the Connector's coverage.

The CHC Special fund represents several hundred thousand dollars that our Health Center is able to use to serve those who have nowhere else to go for primary care, dental care and all other associated support services such as nutrition, case management, care coordination, etc...

Repeal of this funding could dramatically impact Hawaii's health care system that is already struggling to provide care to those most in need.

I strongly urge you to oppose HB2466 HD1.
