In consideration of HOUSE BILL 2563 RELATING TO TOURISM

House Bill 2563 proposes to appropriate funds for the restoration of a continuous beach and infrastructure for public access along the Waikiki waterfront from Kaimana Beach to Ala Moana Brach Park. The Department of Land and Natural Resources (Department) supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Executive Supplemental Biennium Budget.

Part of the Department's mission, through the Office of Conservation and Coastal Lands is to manage coastal areas and ocean resources, including at Waikiki. The Department is engaged in efforts to preserve and restore beaches and public access along the Waikiki shore through projects such as the 2012 Waikiki Beach Restoration Project and ongoing planning to replace the failing groin (erosion control structure) at the Ewa end of Waikiki Beach. HB2563- RELATING TO BEACHES

Chair: Ing, Vice Chair: Lowen, and members of the committees:

The Waikīkī Beach Special Improvement District Association (WBSIDA) supports the intent of House Bill 2563. This legislation appropriates funds for the restoration of a continuous beach and infrastructure for public access along the Waikiki waterfront.

Hawaii's beaches have become increasingly threatened by coastal erosion. According to the United States Geological Service (USGS) National Assessment of Shoreline Change for the Hawaiian Islands, 70% of Hawaii's beaches are eroding and 13 miles of beach have been lost over the last century. Beach erosion effects shoreline access, recreation and cultural activities, coastal ecosystems and environments, and our economy. Beaches are the backbone of Hawaii's \$15 Billion tourism industry and are central to Hawaii's unique culture and lifestyle. With sealevel rise and chronic coastal erosion, the state is challenged to find effective and efficient ways to preserve and maintain our naturally occurring sand beaches. We believe the proposed legislation will support small-scale beach maintenance projects that attempt to address this issue.

Waikīkī Beach is a globally recognized icon of Hawai'i and is the state's largest tourist destination. Waikīkī generates approximately 42% of the state's visitor industry revenue and is responsible for 8% (\$5 billion) of the Gross State Product¹. Beaches are a primary attraction for visitors to Waikīkī. It has been estimated that Waikīkī Beach accounts for over \$2 billion in annual income for the local economy². However, a 2008 survey found that 12% of visitors would not return to Waikīkī due, in part, to limited beach area and resulting overcrowding². Waikīkī Beach also has tremendous cultural significance as a former playground of Hawaiian royalty and the birthplace of the sport and culture of surfing. The beaches and myriad of world-renowned surf breaks and reef ecosystem located offshore are valuable natural resources that support the culture and lifestyle of Hawai'i, and the idyllic image of Waikīkī.

HB2563 proposes to appropriate \$1.5 million to the Department of Land and Natural Resources for the planning and design work for beach improvements in Waikīkī. The bill includes a provision for a multi-use pathway in conjunction with a beach restoration project for the stretch between the Royal Hawaiian groin and the Fort Derussy Storm drain. This stretch of iconic Waikīkī shoreline has not had any beach restoration or maintenance project since the construction of a series of 8 groins in the area in the 1940's followed by small-scale beach fill in the late 1960's. No other efforts to restore or maintain the beach have occurred since then. The WBSIDA supports the intent to further enhance the beach area along stretch of shoreline which is currently mostly beachless or very narrow wet beaches.

HB2563 also calls for enhancing public access by creating a mutli-use pathway through this section of coast, possibly in conjunction with the beach improvements. Improved public access along this stretch of coast would offer an improved visitor experience and facilitate pedestrian foot traffic along the coast, thus providing a viable alternative to vehicular transportation within Waikīkī. Currently the lateral shoreline access corridor along most of Waikīkī is excellent with the exception of the reach between the Royal Hawaiian groin and the Fort De Russy Groin which has narrow public access along the top of seawalls and alternates between wet sand beaches that need to be traversed, often at an increased level of risk to the public. A continuous pathway connecting the Fort DeRussy pathway to the Royal Hawaiian Beach would serve both visitors and residents with an efficient access and unique coastal amenity.

WBSIDA is a non-profit which has the ability to partially support beach improvement projects in the Waikīkī district as a public-private partnership. The WBSIDA supports the intent of HB2563. Thank you for the opportunity to testify on this measure.
