Dear Representative Belatti and Members of the Committee:

SUBJECT: HB 2577 – Relating to Telehealth

The State Council on Developmental Disabilities **SUPPORTS HB 2577.** The purpose of this bill is to: (1) Require patient approval prior to the delivery of any medical services through telehealth; and (2) Prohibit health insurance companies from limiting the setting where telehealth services are provided or requiring in-person contact between a patient and physician before the delivery of telehealth services.

The DD Council would like to highlight the amendment on page 2, lines 5-10, to add language to inform the patient that telehealth may be used and obtain verbal consent from the patient for the use of telehealth. Telehealth services shall include a documented patient evaluation, including history and a discussion of physical symptoms adequate to establish a diagnosis and to identify underlying conditions or contraindications to the treatment recommended or provided.

The DD Council is responsible for the development and implementation of a Five-Year State Plan. Our current State Plan (FY 2012-2016) includes an Objective, "Address all medical gaps in services, as indicated within the Individualized Service Plan by September 30, 2016." An activity to address the objective is to pursue statewide telemedicine opportunities. This bill would assist in the delivery of enhanced statewide health care services, increase access to services, and provide timely information to patients and health care providers.

Thank you for the opportunity to offer our support of HB 2577.

Dear Chair Au Belatti, Vice Chair Creagan, and Members of the Committees:

The Hawaii Medical Association (HMSA) appreciates the opportunity to testify on HB 2577, which would require prior approval of a patient before medical services are provided using telehealth; prohibit plans from limiting the setting in which telehealth services are provided; and prohibits requiring in-person contact between a patient and provider prior to the delivery of health services using telehealth. HMSA supports this Bill, and we offer one suggested amendment.

Telehealth is a proven, effective and efficient way to facilitate timely access to quality health care, improve health outcomes, reduce the incidence of avoidable urgent and emergent care, and even-out distribution of health care providers. HMSA is committed to seeing telehealth become an integral part of our healthcare system, and we were the first in the nation to offer telehealth services thru our Online Care system.

HB 2577 will help to ensure our members receive healthcare services via telehealth only if they wish to use that mode of service delivery. This Bill also will afford our members the opportunity to receive telehealth services in the least restrictive environment.

That said, we recognize that mobile apps have become a dominant means of interaction, even for healthcare. HMSA members have access to healthcare information and our OnlineCare system thru our HMSA app on their smart phones and other digital devices. We suggest that the definition of "telehealth" in the Bill be amended to include the use of mobile apps.

Thank you for allowing us to testify on HB 2577.
