AUTHORIZING THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS TO ASSIST PQ ENERGY LLC

House Bill No. 2607, H.D. 1, authorizes the issuance of Special Purpose

Revenue Bonds (SPRB) to provide financing to assist PQ Energy LLC and to be formed

special purpose entities with the development and construction of renewable energy

plants within the State of Hawaii pursuant to Part V, Chapter 39A, Hawaii Revised

Statutes.

The Department is providing comments only to advise the Legislature and prospective SPRB parties that should the legislation be approved, approval of the SPRB issuance will require further discussion and satisfactory credit underwriting review of the financing components with respect to any proposed financing.

The Department also recommends an amendment to Section 4 of the bill, as follows (deleted language striked through; new language underlined):

"SECTION 4. The department of budget and finance is authorized, from time to time, including times subsequent to July 1, 2016 June 30, 2021, to issue special purpose revenue bonds ... "
