DEPARTMENT'S POSITION: The Department appreciates the intent of this measure as dissemination of information in the workplace about domestic violence resources is important to achieving safety for victims and their families. The DHS offers the following comments: it is not necessary to legislate DHS to provide this information to the Department of Labor & Industrial Relations (DLIR) as it is readily available and DHS already maintains call numbers to different domestic violence services providers on its website. The DHS defers to DLIR regarding implementation and enforcement of additional mandated workplace signage.

However, if the committee envisions additional print media to be made available, then potentially an appropriation of general funds will be required.

PURPOSE: This bill mandates the Department of Human Services (DHS) to create a domestic violence call sheet with a domestic violence legal hotline number and domestic violence shelter hotline number. It also requires all employers to post the call sheet in the workplace and requires DHS and the Department of Labor & Industrial Relations (DLIR) to make

an electronic version available on their websites. This bill imposes a fine of \$100 for employers for failure to comply.

The National Domestic Violence Hotline, 1-800-799-7233(SAFE)/1-800-787-3224(TTY), is federally funded and is available 24 hours, 7 days a week, 365 days a year. Additionally, the National Domestic Violence Hotline offers live chat from 7 a.m. to 2 a.m., Central Time, and maintains for Deaf callers video phone Monday to Friday, 9 a.m. to 5:00 p.m., or by text at the TTY number indicated above.

The National Domestic Violence Hotline is linked to the Hawaii State Coalition Against Domestic Violence (HSCADV). HSCADV hosts an excellent website, www.hscadv.org, with state wide referral resources. There are other locally based non-profits that host similar information for victims, family members and survivors, as well as referral phone numbers.

The Department contracts with domestic violence shelter providers, and as part of the contract, requires shelter providers to provide a hotline and answer calls 24 hours, 7 days a week, 365 days a year. The Child & Family Services (CFS) maintains the following Domestic Abuse Hotlines: O'ahu: 841-0822, West Hawaii: (808)322-7233, and East Hawai'i: (808)959-8864.

The Hawaii State Commission on Fatherhood, an attached commission, already posts on the DHS website, telephone numbers to local domestic violence resources, including the number for the Domestic Violence Advocacy Center, 531-3771. The Department most certainly may add the information of the National Domestic Violence Hotline, the HSCADV, and the 24/7 Domestic Abuse Hotline numbers, perhaps in a more prominent place on the website. However, this does not require legislation.

The Department will certainly work with community providers and the DLIR regarding the text of the workplace signage, and consequently, a statutory change is not required to mandate DHS.

The Department defers to DLIR with regard to implementing an additional mandated workplace signage and ask the committee to allow sufficient time by effectuating a reasonable date for the Departments to develop the requested message.

Chairs Morikawa & Nakashima, Vice Chairs Kobayashi & Keohokalole, and Members of the Committees:

My name is Linda Chu Takayama and I am the Director of DLIR. We <u>support</u> this measure as it pertains to DLIR, which is intended to make information available through the workplace to help victims of domestic violence obtain support.

Domestic violence figures prominently among social issues in Hawaii. The preponderance of evidence indicates that psychological, emotional, and behavioral difficulties in abused mothers and their children should be treated at the earliest possible stage of intervention in order to forestall the emergence of effects that are more serious and problems. The posting of information in the workplace for domestic violence victims will likely lead to more of those persons obtaining information and help. Moreover, I believe that requiring a poster in the workplace would "normalize" domestic violence victims' rights and the availability of support, similar to the way workers view

our other required posters: that rights and remedies exist for this problem.

In closing, I appreciate the drafters' recognition of our department's resource constraints in including language that requires us to make available the poster on our website for employers to print.
