<u>POSITION</u>: The Governor's Coordinator on Homelessness offers written comments, and appreciates the overall concept of the bill as it includes initiatives that align with the State's objectives related to homelessness. However, the Coordinator is concerned about the impact that this measure may have on priorities indicated in the Executive Budget.

<u>PURPOSE</u>: The purpose of the bill is to assist homeless individuals in finding jobs by requiring the City and County of Honolulu to establish a pilot program connecting homeless individuals who are willing to work with job opportunities.

This measure is in alignment with Goal 3, Objective 7 of the Hawaii Interagency Council on Homelessness Strategic Plan to End Homelessness, which is to "increase meaningful and sustainable employment for people experiencing or most at risk of homelessness."

However, the Coordinator notes that there are a number of existing programs, which provide job opportunities specifically targeted at individuals who are homeless. For example, the Hawaii Community Development Authority currently funds a job training program that employs residents of the Next Step homeless shelter for janitorial and trash removal services in Kakaako Makai. These programs support homeless

households in developing essential job skills, as well as assisting these households to increase their income through employment opportunities.

I, James Miyashiro, is in strong support for House Bill 2647. Establishing a Work-for-aday pilot program would definitely help homeless individuals get back on their feet towards independence.

As a volunteer case manager at an emergency homeless shelter, I understand the financial frustration individuals develop when working towards independence. Finding a job can be a long and daunting task, that can sometimes lead to no employment. Individuals may have down-time to spare, usually waiting for contact from services or employers [e.g. waiting for a response from Dept. of Human Services (SNAP/Welfare benefits), also trying to earn money while searching and setting up employment opportunities]. HB 2647 would help with eliminating those down-time hours and give individuals the opportunity to empower themselves to earn money while they wait for services/employers, have a sense of place and pride within their community through city beautification. We all know too well of the financial challenges that each individual faces when living in Hawaii, and establishing this pilot program will help not only homeless individuals work towards independence, but help ease work/financial worry on city/state landscaping upkeep, and help strengthen the sense of community for all individuals impacted by this program.

Having a sense of independence is something that every individual strives to achieve. For those individuals who are starting from the bottom, it is important to earn and save so that they have the financial ability to live independently. By establishing a Work-for-a-day pilot program, homeless individuals have another avenue and opportunity to gain financial freedom and take a step towards independence.
