1 Fiscal Implications: This measure may impact the priorities as set forth in the Governor's

2 Executive Budget.

3 Department Testimony: The Department supports the intent of the bill and would like to offer
4 the following comments.

5 Section 1 of the measure, directs the proposed task force to examine: (1) the levels of sewage contamination in coastal areas as a result of runoff; (2) the sustainability, scope, and capacity of 6 7 sewage infrastructure in each county; (3) Any history of infrastructure failure or overload in each 8 county; (4) Other problems related to sewage infrastructure; and (5) methods of reducing sewage 9 contamination and improving sewage infrastructure. We would like to point out that the Department's Clean Water Branch, currently implements a coastal water quality monitoring 10 11 program which measures water quality at beaches around the State. Though not directly 12 targeting runoff events, the coastal water quality monitoring program includes measurements of sewage contamination such as sewage indicator bacteria. The water quality data collected from 13 the coastal water quality monitoring program is used to determine beach sign posting and is 14 comprehensively reported every two years in the State of Hawaii, Water Quality Monitoring and 15 Assessment Report (i.e. Integrated Report). The next Integrated Report will be completed by the 16 17 fourth quarter of 2016. Item (5) to be reviewed by the proposed task force is directed to address the examination of 18 19 methods to reduce sewage contamination. The Department's Environmental Management Division, has three branches which regulate sewage systems. The Wastewater Branch regulates 20 21 individual waste systems (e.g. cesspools, septic tanks, etc.). The Safe Drinking Water Branch

regulates injection wells. Lastly, the Clean Water Branch regulates sewage systems that

discharge to surface waters. The three regulatory programs take a coordinated approach to

1 reducing sewage contamination which is described in the Hawaii Water Plan. The Hawaii Water

2 Plan was recently updated in 2014.

3 The Department supports the task force items (2), (3), (4) and (5) that is related to the review

4 of sewage infrastructure. Sewage infrastructure in the State are generally owned by the Counties

5 and various private entities. The information to be collected from the task force can be

6 beneficial to the State. However, the Department understands that the success will depend on the

7 Counties and private entities commitment to participate in the task force. Information and data

- 8 about the sewage infrastructure listed under (2), (3), (4) and (5) would have to be provided by
- 9 these parties.

10 Given the complexity of the subjects proposed for examination, the Department has concerns

11 that there are inadequate resources to procure technical support services to operate under the

12 direction of the task force.

SUBJECT: House Bill 2749, H.D.2 Relating to Waste

The City and County of Honolulu, Department of Environmental Services (ENV) strongly opposes House Bill 2749, HD2. ENV currently conducts the studies and assessments listed in section 1(b) of the bill and the data is used to drive ENV's planning and management activities. This information is already available to the Department of Health, which currently holds the responsibility to oversee and regulate wastewater systems.

It is unclear what the intent of the task force is, what value it is expected to provide which is not already available, and what it is expected by way of recommendations. Further, the proposed task force membership does not consider technical expertise or direct experience in the area of wastewater management, which are essential to understanding the findings or to crafting recommendations.

We believe the bill and the proposed task force are duplicative and unnecessary as the responsibilities currently exist within the Department of Health. It will result in an unnecessary expenditure of funds. We strong recommend that this be deferred.

The Chamber of Commerce Hawaii ("The Chamber") **supports the intent** of HB 2749 HD 2, which establishes a Sewage Runoff and Infrastructure Review Task Force in DOH to examine the extent of sewage runoff and sewage infrastructure in each county. Makes an appropriation for the task force.

It is clear that the State of Hawaii has a sewage runoff problem. On August 24, 2015, DOH reported over 587,000 gallons of wastewater were released during a single spill in Waikiki. That spill was just one of eight major spills in the state during the month of August. As the climate changes, weather patterns and heavy rain events are likely to become more frequent and severe. The Surfrider Foundation Hawaii Chapter is concerned about the likelihood of similar spills occurring in the future. It is important that the situation is remedied before another major rain event creates a similar problem in the future.

HB2749 will create a taskforce of experts in DOH who will determine the amount of sewage runoff, the extent of damage within the State's sewage infrastructure and make suggestions for the best remedies to the issue moving forward.
