BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to specify the safe
 distance for a motor vehicle to overtake a bicycle.

The following rules shall govern the overtaking and passing of 6 vehicles proceeding in the same direction, subject to those 7 8 limitations, exceptions, and special rules hereinafter stated: The driver of a vehicle overtaking another vehicle 9 (1)10 proceeding in the same direction shall pass to the 11 left thereof at a safe distance and shall not again 12 drive to the right side of the roadway until safely 13 clear of the overtaken vehicle [-]; provided that the 14 minimum safe distance for a motor vehicle to overtake 15 a bicycle is three feet; and 16 (2)Except when overtaking and passing on the right is

# H.B. 316 RELATING TO OVERTAKING A BICYCLIST

# TESTIMONY BEFORE THE HOUSE COMMITTEE ON TRANSPORTATION ON HB 316 RELATING TO OVERTAKING A BICYCLIST

Thank you Chair Aquino and committee members. I am Gareth Sakakida, Managing Director of the Hawaii Transportation Association (HTA) with over 400 transportation related members throughout the state of Hawaii.

Road safety is critically important to us, and passing can be a most hazardous maneuver so we understand the desire to create an extensive safety zone while executing it.

The danger is acute for a bicycle whether passing or being passed so creating an extensive safety zone needs to apply to both maneuvers.

Therefore, we suggest adding the following amendments to provide for the safety of bicyclists.

# [§291C-143] Riding on bicycles.

# (c) A bicycle shall not pass a motor vehicle on the right within 10 feet of any intersection, or a driveway to the right.

# <u>d)</u> A bicycle shall not travel adjacent to, nor pass a motor vehicle with a gross vehicle weight rating over 10,000 pounds unless such vehicle is stopped in traffic and not preparing to make a turn.

Bicycles are difficult to see, and motorists are not well conditioned to notice one in an area where traffic is not expected.

Motor vehicles over 10,000 pounds GVWR can be up to nine feet wide. This might leave some space for bicycles to pass on the right, however, it is so much more difficult to detect a bicycle from the driving position of such vehicles. Much of the time these drivers have no idea a bike is adjacent to them.

Being a most vulnerable party deserves extra consideration from others, at the same time the most vulnerable need to participate in considerations to assist in their own safety.

The Maui Bicycling League, a chapter of the Hawaii Bicycling League, gives its support for the Safe Passing bill HB316, our members ask that you consider an amendment to the bill to require that motorists give cyclist four feet of clearance rather than three feet.

An amendment to this bill will ensure that motorists must give cyclists a safe amount of space when they pass. Too many cyclists have been struck, sideswiped or brushed by a passing car, and according to data from the League of American Cyclists, 44 percent of all car vs. cyclist fatalities are a result of a motorist passing too closely. Today, many cyclists ride with video cameras so that when an incident does occur, they have supporting evidence. If there was an enforceable passing law, it would make passing a cyclist too close illegal and will save lives.

Thirty-two states and the District of Columbia have Safe Passing laws. Pennsylvania's Safe Passing law requires motorists to give cyclists four feet. There are already Safe Passing policies in place in Hawaii, including Roberts Hawaii's requirement its to give cyclists six feet of space when passing. # **Testimony Strongly Supporting HB316**

Aloha,

Hawaii Bicycling League **strongly supports HB316**. We request the bill be **amended to 4 feet**.

HB316 is necessary to establish a clear rule that motorists must pass a cyclist with a safe amount of space. 4 Feet, It's the Law. It will make it clear to motorist what is safe and legal. It will make our roads safer and more welcoming to cyclists.

# HB316 Will Make Our Roads Safer

HB316 will contribute to addressing one of biggest real and perceived dangers to bicyclists – being hit by an overtaking vehicle. A national survey found that one in nine bicyclists felt threatened on <u>their last ride</u> and "someone drove too close to me" was the primary reason. These statistics are verified by local cyclists; with many reporting frequently being "buzzed," when a motorist passes within inches of your life, and even more unfortunate stories of cyclists injured or killed. The statistics show the danger is real; being "rear ended" or "sideswiped" accounts for 44% of cyclist fatalities.

Making it clear to drivers that 4 feet is the law will reduce close calls and collisions from drivers overtaking cyclists.

# <u> 4 Feet – Let's Embrace a Best Practice</u>

Safe Passing laws are widespread across the US, found in 32 states and DC. While 3 feet is the most common distance, five states have laws requiring 4 feet or more. Pennsylvania has a 4-foot law and four other states (NH, RI, TX, OR) require 4 or more in certain circumstance; for example, New Hampshire requires 3 feet at 30 miles per hour and 1 additional foot per additional 10mph.

Safe Passing policies are already in place here in Hawaii - Roberts Hawaii requires it's drivers to give 6 feet and TheBus requires 7-8 feet.

Let's bring this accepted "best practice" into law and make our roads safer.

Four cyclists died last year on our roads; let's do everything we can to bring this number to zero. Please support SB316.
