Dear Chair Rhoads, Vice Chair San Buenaventura, and members of the House Judiciary Committee:

Common Cause Hawaii supports HB327, which would ban political fundraisers during regular and special legislative sessions. This bill would also repeal the \$25 per person contribution threshold for the applicability of fundraiser requirements and restrictions.

Fundraisers held during legislative session create an impression of pay-to-play amongst our legislators and those who advocate on issues before the Legislature. To increase public participation in the political process and encourage voter engagement, we must take strides to further improve public confidence in government and reduce appearances of conflicts-of-interest and pay-to-play.

We believe that repealing the \$25 per person threshold would provide clarity on what a political fundraiser is. From the general public's perspective, there is little difference with the cost of a fundraising ticket -a fundraiser is a fundraiser.
