Chair Keith-Agaran and Committee Members:

Thank you for the opportunity to submit testimony in support of House Bill No. 401, HD 2. This Bill proposes to require all applicants for a new or renewed driver's license, provisional license, instructional permit, or civil identification card to clearly decline to register to vote or fill out the voter affidavit on their application before their application can be processed.

This Bill will heighten awareness of available voter registration services while applying for or renewing a driver's license or civil identification card in an effort to increase voter registration counts. However, we are concerned that the potential increase in voter registration activity generated by this Bill could adversely impact the current process for transferring voter registration information because it is paper-based and requires physically transferring hardcopy paper documents from the examiner of drivers to the respective county clerks.

Additionally, the current process requires county election personnel to manually enter information from each voter registration affidavit. This additional increase in voter registration activity experienced by the examiner of drivers could create adverse staffing and budget issues for each county.

To accommodate any of the increases in activity generated by this Bill, we believe voter registration information and signature images should be electronically transmitted from the examiner of drivers directly to the SVRS. This would streamline and modernize the process, and ensure that our Office will be able to efficiently accommodate any potential increase in voter registration activity resulting from this Bill.

The Office of Hawaiian Affairs (OHA) Committee on Beneficiary Advocacy and Empowerment will recommend that the Board of Trustees <u>SUPPORT</u> HB401 HD2, which would reduce barriers to voting and potentially increase voter participation, by requiring applicants for a driver's license or state-issued identification card to either register to vote, or affirmatively decline to do so.

It is well known that Hawai'i has historically suffered from low voter turnout. Hawai'i consistently ranks lower than the national average for voter participation among those eligible to vote in the presidential election.¹ In response to historical data reflecting the underrepresentation of Native Hawaiians in particular in the polls, during the past two election seasons, OHA has implemented the "Hawaiian Voice, Hawaiian Vote: I Mana Ka Leo" campaign to increase Native Hawaiian voter registration, education, and turnout. In line with our efforts, OHA generally supports the reduction of barriers to the complex system of voter registration, voter education, and election-day polls.

Hawai'i's electorate will likely grow if citizens are required to affirmatively decide whether to register to vote, when submitting a driver's license or state-issued identification card application. Accordingly, OHA supports this measure as consistent with its past and ongoing efforts to increase voter turnout. OHA does recognize that consistency with federal law is of paramount importance and the logistics of implementation can be complex and costly; on these matters, we defer to the Attorney General's Office, Office of Elections, and County Clerks' offices.

Therefore, OHA urges the Committee to **PASS** HB401 HD2. Mahalo for the opportunity to testify on this measure.
