In **SUPPORT** of House Bill 438 **Making an Appropriation to the Kaho'olawe Island Reserve Commission**

House Bill 438 appropriates funds to the Kaho'olawe Island Reserve Commission for restoration and preservation projects. The Aha Moku supports this bill as it reflects the State's commitment to oversee the use and restoration of the reserve as it was stated in 2004 when the management and control of the island was transferred to the State of Hawaii from the United States Navy.

The Aha Moku encompasses the eight main Hawaiian Islands and supports the traditional and generational knowledge of the people who are connected to Kanaloa, the traditional name for Kahoolawe. This includes Native Hawaiians who have generational knowledge of the island yet live within the Moku of Honuaula on the Island of Maui. Traditionally, they traveled back and forth to Kahoolawe and are intimately involved with the cultural practices still held there.

It is imperative that KIRC continue to implement their pioneering restoration projects that have proven to be effective in the extremely harsh conditions on the Island caused by the destructive actions of the past including extensive soil erosion, destruction of sacred places and natural and cultural resources. After 10 years of escalating hope of the Hawaiian people that Kanaloa would one day be a place of safety and peace, we cannot lose this hard-won faith of our people and the public trust in this endeavor because of a lack of funding. Value cannot be measured by funding.

Please pass HB 438 and save Kanaloa (Kahoolawe). Mahalo nui loa!

Chair Yamane, Chair Ing and Members of the Committees:

I am Jan Yamane, Acting State Auditor. Thank you for the opportunity to offer comments on House Bill No. 438, relating to the Kaho'olawe Island Reserve Commission. This bill would, among other things, appropriate funds to the Kaho'olawe Island Reserve Commission for restoration and preservation projects.

In July 2013, we released Report No. 13-06, *Audit of the Kaho'olawe Rehabilitation Trust Fund*, which responded to a request by the 2012 Legislature via Senate Concurrent Resolution No. 63, Senate Draft 1, asking the Auditor to conduct a fiscal audit of the Kaho'olawe Rehabilitation Trust Fund. The Legislature requested that the audit include a determination of whether trust funds are being used in compliance with state laws and any applicable grant agreements, and to effectuate the purposes of the Chapter 6K, HRS, including the performance of duties and responsibilities of the Kaho'olawe Island Reserve Commission. In our report, we had two findings:

- 1. At its current rate of spending, the Kaho'olawe Island Reserve Commission will drain the remaining balance of the Kaho'olawe Rehabilitation Trust Fund by 2016, and
- 2. The Kaho'olawe Island Reserve Commission has not developed a comprehensive and measurable restoration plan, including estimated costs and timeframes for completion.

The following exhibit from our report illustrates the Kaho'olawe Rehabilitation Trust Fund's financial revenue, expenditures, and decreasing trust fund balance for FY1995-FY2012. As you can see, expenditures have outpaced revenues for the past decade.



Our report noted that the commission has been unsuccessful at meeting its fundraising goals and unable to secure long-term funding. Although it has cut its budget, it continues to deplete the trust fund and at its current rate of spending, the trust fund will be completely exhausted by 2016.

While this measure will appropriate needed funds to the depleting trust fund for fiscal years 2015-2016 and 2016-2017, it does not address the commission's rate of spending and inability to successfully raise funds to preserve the trust. If the Kaho'olawe Rehabilitation Trust Fund requires annual appropriations to continue, it raises the question whether the trust fund is needed or should be repealed. The commission could be supported through general fund appropriations.

Thank you for the opportunity to offer comments on House Bill No. 438. I am available for your questions, should you have any.

TESTIMONY OF MAYOR ALAN M. ARAKAWA COUNTY OF MAUI

RE: FUNDING FOR THE KAHO'OLAWE ISLAND RESERVE COMMISSION

Please accept this testimony in strong support of state funding for the Kaho`olawe Island Reserve Commission (KIRC). Whether through a share of conveyance tax revenue as proposed by SB 867, or a direct appropriation as proposed by SB 897 and HB 438, support of the KIRC is a state responsibility.

When the state accepted Kaho'olawe back from the U.S. military in 1994, it was recognized that state funding would eventually be needed to maintain and restore the island. As Section 1 notes in each of the above-reference bills, the federally-mandated Kaho'olawe Island Conveyance Commission reported to Congress in 1993 that KIRC's federal trust fund would be used to initiate conservation and other programs, but that state funding was required for the long term.

I was able to travel to Kaho'olawe last month to view the incredible work that the KIRC performs every day – its Restoration Program planting native shrubs and grasses to minimize erosion and restore native ecosystems, its Ocean Program monitoring marine species and the Island Reserve's pristine waters, its Culture Program preserving archaeological sites and promoting traditional Hawaiian practices, and its Operations staff providing all kinds of logistical and maintenance support to these program efforts. The KIRC's annual budget is less than \$3 million; they manage and are steadily restoring an entire island reserve – a former bombing range with 45 square miles of land and 90 square miles of ocean – for less than \$3 million per year; this has to be one of the most efficient government agencies in the state.

The Legislature has rightly recognized the state's responsibility to providing funding for the KIRC, and clearly appreciates the successes that KIRC has achieved. Your careful consideration of these funding measures comes at a critical time, and I respectfully request your support.

In consideration of **HOUSE BILL 438** MAKING AN APPROPRIATION TO THE KAHO`OLAWE ISLAND RESERVE **COMMISSION**

House Bill 438 appropriates out of the general revenues of the State of Hawai'i funds to be used for projects undertaken by the Kaho'olawe Island Reserve Commission, including but not limited to the restoration and preservation of the natural, cultural and historic resources of the Kaho`olawe Island Reserve and its meaningful and safe use by the people of Hawai`i. The Kaho`olawe Island Reserve Commission (KIRC) strongly supports this measure.

When the State of Hawai'i accepted the return of the island of Kaho'olawe in 1994, it accepted the responsibility "to preserve and protect a corner of their island state so that future generations can become familiar with their island's past human and natural heritage. For many Native Hawaiians and others, Kaho'olawe is a special place that has been sanctified by the loss of life in a struggle between traditional values and Western concepts of land use and management" (Restoring a Cultural Treasure, Kaho`olawe Island Conveyance Commission).

As stated in the Federally-mandated Kaho`olawe Island Conveyance Commission (KICC) final report to Congress in 1993, "in the short term, federal funds will provide the bulk of the program support for specific soil conservation projects and related activities. In the longer term, however, state revenues will be needed to continue and enhance those activities initiated with federal funds." For the past 20 years, the initial Federal funding has allowed the KIRC to establish many of its innovative programs that emphasize ancestral and traditional knowledge, provide a cultural approach of respect and connectivity to the environment, and integrate ancient and modern resource management techniques. Those initial funds will run out by 2016 if no other funding source is secured.



With 25% of the island still uncleared of unexploded ordnance and only 10% cleared for intensive use, the KIRC's continuing presence on Kaho'olawe is needed to ensure the protection of the general public. Without funding, the KIRC will have to terminate on-island operations and close the doors to public access to Kaho'olawe.

Over the past two years, the KIRC in partnership with several dozen community organizations conducted as of state-wide community gatherings to solicit and document the public's input regarding the future of Kaho`olawe. The resultant community-wide planning document entitled *"I OLA KANALOA!"* represents a foundation to encourage the collective impact of many individuals, organizations, and the community-at-large. This arrangement acknowledges that the power, energy and resources to secure the future of Kaho`olawe is shared and dispersed among its many partners.

The funding being sought in this measure is to provide a bridge to allow the KIRC to develop these community-wide partnerships, establish collaborative enterprises with other state and federal government entities, and launch long-term revenue generation and sustainable funding opportunities supporting the future of Kaho`olawe. The passage of this measure is critical to ensure that the struggle, hard work, dedication and lives given to the island will not be wasted, but forms the foundation for Kaho'olawe role as the spiritual, cultural and physical *piko* (center) of the people of Hawai`i.

Appropriates funds to the Kaho'olawe Island Reserve Commission for restoration and preservation projects.

TESTIMONY IN OPPOSITION

SB438 should be deferred or defeated for two reasons:

(1) More than \$400 Million was appropriated by the U.S. government to clean up unexploded ordnance on Kaho'olawe; and a trust fund totaling \$44 Million was established for restoration work to be done by KIRC after the island was transferred to the State of Hawaii. However, there has not been a fiscal or management audit for how the money was spent, which individuals or companies were paid how much money to do what work, whether contracts were awarded in compliance with state procurement laws, and whether the work was completed satisfactorily. Such management and fiscal audits should be completed and reported to the legislature before any additional funds are appropriated.

(2) So long as the island of Kaho'olawe is set aside by law to be transferred to a future sovereign Native Hawaiian entity, state government taxpayer dollars should not be spent to maintain or improve it. The Office of Hawaiian Affairs has more than \$650 Million in assets in its "trust fund", and its stated purpose is to provide for "the betterment of Native Hawaiians." OHA is the primary entity pushing to create a Native Hawaiian tribe, and has publicly stated that it plans to turn over all its assets to that tribe. Either this bill should be amended to include a clause rescinding HRS Section 6K-9 and making clear that Kaho'olawe is an unalienable part of the State of Hawaii, or else this bill should be amended to require that all funds for the rehabilitation, improvement, and operation of Kaho'olawe must come from the assets of OHA.

As the text of this bill explains, "Pursuant to section 6K-9, Hawaii Revised Statutes, the management and control of the Kaho'olawe island reserve will be transferred to a sovereign Native Hawaiian entity upon its recognition by the state and federal governments. This event is anticipated to occur within the timeframe of the 2026 strategic plan." And indeed, Act 195, Session Laws of 2011, began the process of creating a state-recognized Native Hawaiian tribe with the expectation that once it has been established it will then seek federal recognition. During 2014 the U.S. Department of Interior held hearings in Hawaii and on the mainland to take testimony regarding an Advance Notice of Proposed Rule-Making to change federal law regarding the criteria for recognizing Indian tribes, specifically for the purpose of facilitating federal recognition of the anticipated state-recognized tribe now being created under Act 195. Does our state legislature really intend to create a Hawaiian tribe and divide the lands and people of Hawaii along racial lines? Will this legislature do anything to protect the 80% of our people who lack a drop of Hawaiian blood, against the rapacious demands of the tribe for land, money, and jurisdictional authority? Please rescind HRS Section 6K-9 and do not appropriate any money to do what OHA has a responsibility to do. I expect my legislature not to give away the store before negotiations with the Hawaiian tribe have even begun.

Aloha e committee members;

I am writing in support of continued funding for the Kaho'olawe Island Reserve Commission, and the important work that they are doing not only on Kaho'olawe, but also in Kihei. I am sure you will receive much testimony about the crucial role KIRC has played in the protection and preservation of Hawaiian history, culture, natural resources, and more. All of this is true, and vital to Hawai'i. But I would like to discuss the work that KIRC is doing in Kihei, as well.

As the former director of Kihei Charter School, I worked with KIRC to build a partnership that includes field activities at the Kihei site of KIRC, where they are clearing kiawe and other invasive species, building trails, and planting native Hawaiian plants. This work mirrors the work they have completed on Kaho'olawe, and provides a window into that work for those who are not fortunate enough to be able to travel to the island for a volunteer trip. It also happens to be in a spot that is heavily traveled by tourists and locals, alike, and is the perfect opportunity for educating others about the history and the work of preserving Kaho'olawe.

For the seventh and eighth graders at Kihei Charter School, it is an opportunity to work with real scientists, historians, and preservationists in the field, getting their hands dirty, and making meaningful connections between the things they learn in class and the world around them. For some of our kids, it is the best part of coming to school (and the kind of experience that will hopefully keep them from dropping out in the future). I have seen boys who are completely unable to focus and keep their hands to themselves in class proudly carrying the heaviest branches and digging the biggest holes to make a contribution to this project. They give tours of the site as if it were their own home.

Funding the work of our scientists, historians, and educators is crucial to the future of these islands, not only for the actual preservation of natural resources, but also for the education and inspiration of our keiki. I strongly urge the legislators to continue funding the important work that KIRC has ahead of them. Their strategic plan for the future is solid, and they are passionate, responsible stewards of the land and the responsibilities that come with public funding.

In October of 2014, I had the opportunity to visit the island of Kaho'olawe for the first time via the Kaho'olawe Island Reserve Commission or KIRC.

In October of 2014, I had the opportunity to visit the island of Kaho'olawe for the first time via the Kaho'olawe Island Reserve Commission. On the 4-day trip, my twentyperson volunteer group worked on erosion control and other projects to help restore the island. For our particular work project, we built barriers to prevent rain runoff from destroying young plants and washing ancient Hawaiian artifacts from an archeological site into the ocean.

I was able to see the scars and devastation to the island from the nearly 50 years of live fire, bombing, and wild goats. And I gained a greater appreciation of what the island means to the Hawaiian people both culturally and spiritually.

But most importantly, I can tell you that the island is slowly healing and there are trees and plants growing in areas where there was complete devastation a few years ago. This is because of the dedication and work of KIRC and it's volunteer groups.

I was born and raised in Hawai'i but I am not a native Hawaiian. Prior to this trip, I knew

almost nothing of the history and cultural significance of Kaho'olawe, nor did I care about the restoration work being done there. However, after just four days of seeing the mission that KIRC is tasked with, their professionalism, and dedication, I am in complete support of KIRC and their efforts. As a Hawai'i resident, I feel it's our obligation to do what we can to restore and heal Kaho'olawe, so that future generations may have the opportunity to visit and learn from this very special place.

I urge you to pass HB438 and continue to fund KIRC and their mission.

I have had the great honor of visiting Kahoolawe two times in the past three years as part of a service volunteer group. These trips have been some of the most important events that I have ever participated in.

My bachelor's degree from Cornell University (2000) is in Environmental Policy Analysis and Natural Resources Management with an honors thesis in non-point source runoff pollution. Non-point source runoff is precisely what is occurring every day on Kahoolawe as the island's fragile hardpan dust blows off in the wind and flows down the gullies in the occasional rainstorm. This erosion and runoff directly affects the surrounding waters and barrier reefs of all Hawaiian Islands.

Kahoolawe is a surprising large island. The areas in which reforestation and erosion control have been implemented are a shining example of creative and resourceful land management and pollution mitigation. In consideration of HOUSE BILL 438 MAKING AN APPROPRIATION TO THE KAHO`OLAWE ISLAND RESERVE COMMISSION

House Bill 438 appropriates out of the general revenues of the State of Hawai`i funds to be used for projects undertaken by the Kaho`olawe Island Reserve Commission, including but not limited to the restoration and preservation of the natural, cultural and historic resources of the Kaho`olawe Island Reserve and its meaningful and safe use by the people of Hawai`i. The Kaho`olawe Island Reserve Commission (KIRC) strongly supports this measure.

When the State of Hawai'i accepted the return of the island of Kaho'olawe in 1994, it accepted the responsibility "to preserve and protect a corner of their island state so that future generations can become familiar with their island's past human and natural heritage. For many Native Hawaiians and others, Kaho'olawe is a special place that has been sanctified by the loss of life in a struggle between traditional values and Western concepts of land use and management" (Restoring a Cultural Treasure, Kaho'olawe Island Conveyance Commission).

As stated in the Federally-mandated Kaho`olawe Island Conveyance Commission (KICC) final report to Congress in 1993, "in the short term, federal funds will provide the bulk of the program support for specific soil conservation projects and related activities. In the longer term, however, state revenues will be needed to continue and enhance those activities initiated with federal funds." For the past 20 years, the initial Federal funding has allowed the KIRC to establish many of its innovative programs that emphasize ancestral and traditional knowledge, provide a cultural approach of respect and connectivity to the environment, and integrate ancient and modern resource management techniques. Those initial funds will run out by 2016 if no other funding source is secured.

With 25% of the island still uncleared of unexploded ordnance and only 10% cleared for intensive use, the KIRC's continuing presence on Kaho'olawe is needed to ensure the protection of the general public. Without funding, the KIRC will have to terminate on-island operations and close the doors to public access to Kaho'olawe.

Over the past two years, the KIRC in partnership with several dozen community organizations conducted as of state-wide community gatherings to solicit and document the public's input regarding the future of Kaho`olawe. The resultant community-wide planning document entitled *"I OLA KANALOA!"* represents a foundation to encourage the collective impact of many individuals, organizations, and the community-at-large. This arrangement acknowledges that the power, energy and resources to secure the future of Kaho`olawe is shared and dispersed among its many partners.

The funding being sought in this measure is to provide a bridge to allow the KIRC to develop these community-wide partnerships, establish collaborative enterprises with other state and federal government entities, and launch long-term revenue generation and sustainable funding opportunities supporting the future of Kaho`olawe. The passage of this measure is critical to ensure that the struggle, hard work, dedication and lives given to the island will not be wasted, but forms the foundation for Kaho'olawe role as the spiritual, cultural and physical *piko* (center) of the people of Hawai`i.

Dear Chair Yamane and Committee Members

I am writing in very strong support of HB 301, which extends comprehensive liability protection to the state for actions taken by individuals engaged in hazardous recreational use on state lands. The bill before you is modeled after the California hazardous recreational use statute, and if passed will provide the state with a far better and more coherent protective scheme than current law.

As you all know, last year, the Hawaii legislature barely passed Act 82, which made permanent the requirement that the DLNR post signage warning users of possible hazards on official state trails. However, this legislation leaves large gaps in state protection from hazardous recreational use because of the lack of state protection for injuries caused by non- natural hazards as well as unclear protection for hazardous recreational use on unencumbered state lands. The state needs better protection than this.

HB 301 clarifies that the burden of care rests on the individual outdoor enthusiast. Certainly, the state should remain liable if it knowingly creates harmful conditions, but it is vital that individual recreational users take responsibility for their own actions on state lands, just as they must assume responsibility for their own lives while in the water in Hawaii.

Finally, I can say without a doubt the state would save money if such a bill were to be passed. First, it limits the possibility of such huge payouts like that seen in the Brem case. Second, it saves the state the time and energy of negotiating permits with all user groups for their specific uses. Such a process is legally unwieldy and costs enormous numbers of staff hours. As a hiker and climber I urge that you pass this legislation.
