The Commission is in strong support of HB 458, HD2, which would require public schools to annually provide all incoming 6^{th} grade students with information about the human papiollomavirus ("HPV") and the availabity of vaccines.

The HPV vaccine is widely utilized, yet remains underutilized in Hawaii. We have an opportunity to prevent cervical cancer by ensuring students are provided with important health information. There is no cure for HPV and cervical cancer is the second leading cancer killer of women worldwide. Almost 70% of cervical cancer cases are linked to four strains of HPV that are protected through the two FDA approved vaccines on the market. Increased utilization of the HPV vaccine will assist in reducing our cervical cancer rates.

Further, under the Affordable Care Act, most private insurers cover the HPV vaccine with no out of pocket costs. Boundaries that previously prevented families from obtaining the vaccine have largely been eliminated. This means that the HPV vaccine is much more accessible and affordable. This bill doesn't require that young people receive the vaccine, it simply will allow the correct and medically accurate information about the vaccine to reach parents and guardians. We have the opportunity to share factual information about this vaccine with families in order to protect young people from cervical cancer. Please pass HB 458, HD2.

Providing the people of Hawaii with exceptional sexual and reproductive health care and education, through fearless advocacy and compassionate, affordable services, since 1966. 168,400 will develop cervical cancer if none are vaccinated. 51,100 will die from cervical cancer if none are vaccinated.

In Hawaii, 55-64% of adolescent girls 13-17 years in Hawaii are covered with one or more doses of the HPV vaccine (National Center for Immunizations and Respiratory Diseases, Immunization Services Division, June 11, 2014). We can do better to protect their health.

In 2009, the state convened a working group to assess whether to require cervical cancer vaccinations for girls before they entered the 7th grade. The group did not recommend requiring the HPV vaccine for girls prior to 7th grade entry because of a number of barriers, including inconsistent health insurance coverage, the high cost of the vaccine, inequality of access to the vaccination and the substantial administrative burden that would be placed on school personnel. Since then, these barriers have been reduced or eliminated entirely. With the Affordable Care Act, most private health insurance plans cover the HPV vaccine with no out-of-pocket costs. Although at least 25 states have enacted legislation to either require, fund or educate the public about the HPV vaccine, Hawaii is not one of them.

While this bill does not require youth to be vaccinated, it does at least ensure that parents receive factual information about HPV and the vaccines from a trusted source, our public schools. Until all youth are regularly and routinely vaccinated, PPHI will continue to work with our community health partners to educate parents and youth, increase access to and utilization of the HPV vaccine and prevent the spread the HPV and related cancers and other diseases. Our youth rely on us to help protect them. Let's make sure we have the right information to keep our youth healthy and safe.

The Hawaii Immunization Coalition (HIC) supports the intent of HB 458 in requiring the Hawaii State Department of Education (HDOE), in collaboration with the Hawaii State Department of Health (HDOH), to provide information relating to human papillomavirus (HPV) vaccination to all students entering the 6th grade and their parents/guardians.

Hawaii Immunization Coalition understands the importance of educating parents and preteens regarding the prevention of cervical cancer through HPV vaccination. HIC is aware that cervical cancer is the second leading cause of cancer in women worldwide and that HPV vaccination is an effective method of protecting girls and young women against cervical cancer. One of the HPV vaccines also protects against genital warts and anal cancer in both females and males.

HIC agrees with the inclusion of information relating to all other vaccines for pre-teens recommended by the Advisory Committee on Immunization Practices (ACIP) provided to parents/guardians of 6th graders entering school in Hawaii. Additional vaccines recommended by the ACIP include those for tetanus, diphtheria, pertussis, meningococcal meningitis, and influenza.

According to 2013 National Immunization Survey, only 80.2% of Hawaii teens aged 13-17 years received their Tdap (tetanus-diphtheria-pertussis) vaccination, and 75.0% received a dose of MenACWY (meningococcal meningitis). In 2013, the coverage rate for Hawaii's teens with series completion of HPV vaccine was 70.3% for females and 47.2% for males. Hawaii's teen vaccination rates for tetanus, diphtheria, pertussis, meningococcal meningitis and influenza are below the national average. Support is needed to improve the immunization rates for our teens in order to provide the protection they need.

The Hawaii Immunization Coalition (HIC) is a state-wide, community-based non-profit 501(c)3 coalition of public and private organizations and concerned individuals whose mission is to promote effective strategies to ensure that all of Hawaii's families are appropriately vaccinated against vaccine-preventable diseases.

TESTIMONY IN SUPPORT OF HB 458 HD2 RELATING TO <u>HEALTH</u>

Hawaii Youth Services Network (HYSN), a statewide coalition of youthserving organizations, supports HB 458 HD2 Relating to Health.

HYSN supports the provision of information about all of the immunizations discussed in the bill, but will focus its testimony on the benefits of HPV vaccine information.

The human papillomavirus (HPV) is the most common of all sexually transmitted infections and persistent HPV infection can cause cervical cancer and genital warts. The Centers for Disease Control and Prevention (CDC) estimates that there are 6.2 million new HPV infections each year, and that over 20 million Americans are currently infected. The National Health and Nutrition Examination Survey (NHANES) estimates that women ages 15-24 account for 74% of incident cases.

HPV is accepted as the virus responsible for virtually all cases of cervical cancer. Nationwide, the direct annual cost of HPV-related disease prevention and treatment was \$4.6 billion in 2005.

The introduction of the HPV vaccine broke new ground in public health as it is the first vaccine that can prevent certain cancers. The HPV vaccine has the potential to offer extra protection to low-income and minority women who are least likely to receive frequent screening.

This bill only requires education, not a mandate to provide the vaccine. Increasing education about this virus and its associated diseases through a careful public education campaign is imperative.



There is a long way to go in combating cancer, but this bill provides an exciting opportunity to affect women's health through informed education.

Comments: Aloha and mahalo for allowing me to submit testimony in STRONG SUPPORT of HB458. I have worked with youth and families for over two decades. During this time, I have worked with many youth (mostly girls) who have suffered from the effects of STDs, such as HPV. When I first began working as a Social Worker in 1995, there were no other options when counseling youth about protecting themselves from STDs, other than abstinence and using condoms. However, that is no longer the case. While abstinence is the only 100% fool-proof way to prevent STDs like HPV, it is not realistic to expect that all youth will abstain from sex. Some kids are going to engage in sex, regardless of the amount of messages they hear from adults encouraging abstinence. In light of this, it is irresponsible not to educate parents about HPV and the vaccine for HPV. This bill would require that we provide this education to parents and would give them the opportunity to decide for themselves whether or not to have their children vaccinated. It is a parent's right to choose whether or not to pursue vaccination for HPV for their children, but they first need to be armed with the information they need to make this decision. Unfortunately, not all parents are able to obtain this information on their own for various reasons (i.e. lack of education, language barriers, etc.). Their children deserve the same protections offered to parents who are able to get this information on their own and it is out duty to provide it. To intentionally deprive them of this information, is irresponsible and inhumane. I strongly urge you to pass this bill and to give parents the information they need to decide for themselves. Comments: Dear Senators: If the information about these and other vaccines was unbiased objective information based on valid, objective research. I could support this legislation. Unfortunately our health care delivery system is broken and profit driven. This profit driven system has suppressed the dissemination of objective scientific findings regarding the risks associated with vaccination. Information provided about vaccines does not present valid descriptions of risks and benefits. Scientific objections to individual vaccines are not presented, although there are many researchers raising such concerns. In 1979, my paper written just prior to graduating from nursing school, was written in support of vaccination. One year later, my daughter had a significant negative reaction to vaccination. She did not receive further vaccines, I am convinced that she would not be the healthy vibrant young woman she is is we continued the series. In 1988 I graduated from Naturopathic Medical school. I still held on to the idea of selective vaccination with informed consent. I also have spent the past 25 years studying the science behind vaccination. I have come to believe that science is fundamentally flawed, and that the preparations contain a plethora of toxins including neurotoxins such as aluminum (please examine the work of Dr. Ayoub). I believe we should tinker with the remarkable delicately balanced intricacies of the immune response with more humility and objectivity. While the Supreme Court has confirmed the state's rights to mandate vaccination, I believe these decisions only represent the court's ignorance of immunology. Honestly, it is an ignorance that most health professionals share, since medical school education only includes a single survey course in immunology. Comments: HB 458 Requires schools to annually provide information on HPV, DTaP, flu and meningococcal vaccines. What information are you talking about? Are you informing them on the genuine risks and benefits of vaccines, giving them an opportunity to become educated or are you creating fear and pushing vaccines? I have worked at a DOE school as a kumu the past 13 years and the informed choice information given for the influenza vaccine in almost all schools amounts to almost nothing. Besides this the nasal influenza vaccine is given in the classrooms where running noses and sneezing (common to see) is inoculating the classroom, whether a parent chose to vaccine or not, whether a sick child (who should not be receiving a vaccination) is exposed to the vaccine. I cannot even go near the classrooms that day and for days I literally do not breathe when I have to enter. (Thankfully I work in an outdoor classroom). I have deep concerns because my first child after her vaccine at 3 months of age had convulsions, seizures, high-pitched screams for a full day. I am blessed she made it; I held her and prayed all day. Trust me I became as fully informed as a makua could be. I am also a Traditional Midwife and I believe strongly in informed choice. My question to you as legislators is how educated are you on making a decision that deeply effects our 'ohana? Have you seen a child react badly to vaccines and almost die? Have you studied them? I strongly oppose HB 458. Medical information and counsel on human papillomavirus and cervical cancer is already disseminated widely by doctor's offices to parents and guardians of sixth grade children. Decisions to vaccinate or not to vaccinate against the virus are a private medical matter that does not need the involvement and promotion from the Department of Education.

Diligent research by many parents and organizations reveal that there is a lot of misinformation about the effectiveness of the HPV vaccines. In addition, adverse reactions of the HPV vaccine have harmed many young girls which the state cannot afford to be open to liability. Parents have become educated about this vaccine. They have looked at the science and weighed the risks versus the supposed benefits and many have made a choice not to get it for themselves or their children.

Gardasil's safety record is in serious question. As of Sept 28, 2010, the Vaccine Adverse Events Reporting System has more than 18,000 Gardisil-related adverse events listed, including at least 65 deaths. • After Gardasil was licensed and three doses recommended for 11-12 year old girls and young women, there were thousands of reports of sudden collapse with unconsciousness within 24 hours seizures; muscle pain and weakness; disabling fatigue; Guillain Barre Syndrome (GBS); facial paralysis; brain inflammation; rheumatoid arthritis; lupus; blood clots; optic neuritis; multiple sclerosis; strokes; heart and other serious health problems, including death, following receipt of Gardasil vaccine.

As a vaccine for children, it doesn't make sense to vaccinate to try to prevent an infection that is cleared from your body without any negative effects within two years in most healthy persons, and is not transmitted in a school setting like other airborne diseases that are easily transmitted in crowded conditions. Gardasil is designed to prevent only two of at least 15 strains of HPV that can lead to cervical cancer in those who do not clear the virus from their body within two years and become chronically infected.

A brief glimpse into the research vault on the vaccine for HPV should deter the Department of Education from any involvement. Please do not pass HB 458 out of your committee so that our keiki can be protected from questionable vaccination into their young growing bodies.

Dear Chair Kidani, Chair Green, and members of Senate Committees on Education and Health: My name is Kassandra Ozoa and I am a graduate student at the University of Hawaii at Mānoa. I represent myself, in *strong support* of HB458 HD2 which requires public schools to provide information about the human papillomavirus (HPV) and other vaccines to parents and guardians of students entering the sixth grade, beginning the 2017-2018 school year. I am in strong support of this bill because I have been directly affected by HPV, running the risk of cervical cancer.

HPV raises important health concerns. According to the Center for Disease Control and Prevention (CDC), HPV causes genital warts in about 360,000 people while also causing cervical cancer in more than 11,000 women in the United States each year. Education is imperative because HPV is the most common sexually transmitted infection in the US. Most people with HPV are not aware that they are infected and never develop symptoms or health problems until it's too late where cancer has already taken its course.

HPV has been the catalyst of the precancerous cells that have been found on my cervix. This has greatly affected my life as I have been told cancer often takes years to develop after contracting HPV and there presumably is no cure. According to the National Cancer Institute, there are two HPV vaccines that have been shown to prevent infection with the two types of HPV that cause most cervical cancers. Unfortunately, in my case, I was not able to obtain the vaccine prior to being infected, resulting in the diagnosis and biopsies that I have experienced. Early education about HPV and the existence of a vaccine as soon as it was made available in 2006 would have made a major impact on my life.

For this reason, education about HPV and the vaccine should be provided to the parents and guardians of students entering the sixth grade. I hope this information will be available to students as well. Raising awareness about this issue is of very importance to me. As an aspiring social worker, I feel that it is an individual's right to know what is going on with their body and ways that they are able to counteract any mishaps, especially in extreme cases of cancer. If I could change one thing that would have altered what I have experienced, it would have been more education in my intermediate or high school about HPV, how you contract it, the risk of cancer, the importance of screening, and most importantly the availability of a vaccine. Empowering each individual, most especially young girls to have control over their lives in having this accessibility to information is necessary to my purpose as a social worker.

Re. **Testimony in Support, HB 458 HD1, Relating to Health (specifically, the HPV Vaccine and Public Schools)**

I am grateful for this opportunity to testify in strong support of HB 458 HD2, requiring that public schools provide information about the human papillomavirus (HPV) vaccine and several other vaccinations to parents and guardians of incoming grade 6 students. My testimony is on behalf of the approximately 400 members of the American Association of University Women (AAUW) in Hawai'i, who list choice and women's reproductive health as an important current concern.

Vaccinations are key components of public health, and this hearing is especially timely given the measles outbreak and consequent public attention to herd immunity and parental misinformation about vaccinations. Provision of the HPV and other vaccines save lives, and the Centers for Disease Control and Prevention (CDC) remind us that "HPV is the most common sexually transmitted virus in the United States. Almost every sexually active person will acquire HPV at some point in their lives." Given the inevitability of this process, and the risk that HPV may lead to cervical cancer for women (with 11,000 women diagnosed with cervical cancer annually, according to the CDC), it makes sense to provide accurate, medically informed education about this vaccination. According to the CDC, HPV vaccines "are safe, effective, and offer lasting protection against most cancers caused by HPV infection." It is also logical to include the full complement of childhood vaccinations in this bill. Indeed passage of this bill is essential for a responsive and responsible public health program for school age children.

This bill is especially important for the dissemination of information about HPV and this vaccination since without legal encouragement to provide information about this particular vaccine, public schools are less likely to incorporate the information in their health messages to students' caregivers. The Department of Education needs to provide medically accurate information to parents, rather than act as a gatekeeper. Withholding information results in unnecessary deaths when these youngsters reach adulthood.

I would also like to see this information made available to students, in addition to their parents or guardians. Students age into adults who make their own health decisions, and it is provident to incorporate medically-accurate vaccine information in the education provided to this cohort, so they can mature into adults who look after their own children prudently, and also so they can rectify their own vaccination record as adults, if their parents proved unresponsive.

The HPV vaccine has been available since 2006, and Hawaiian vaccination rates are low. Please move HB 458 HD1 forward, with the goal of educating youth's caregivers, increasing HPV vaccination rates, and ultimately reducing cancer deaths in particular, and with the broader aim of increasing all childhood vaccination rates.
