Purpose of Bill:	Specifies additional elements in Hawaii's existing sexuality health education law, including additional criteria regarding implementation of sexuality health education instruction. Requires the Department of Education to provide certain types of information to the public and parents. (HB459 HD1)

### **Department's Position:**

The Department of Education (Department) would like to provide comment on HB 459 HD1 which proposes to specify additional elements of Hawaii's existing sexuality health education law and its implementation. We respectfully offer the following comments on this measure.

As a public school system, the Hawaii State Department of Education follows statutory requirements, Board of Education policies and nationally recognized guidance to inform curriculum development and adoption.

Schools provide a comprehensive sexual health education that follows the requirements set forth in the Hawaii Revised Statutes (HRS) §321-11.1 and the Hawaii State Board of Education (Board) Policy 2110, Abstinence-Based Education, which states:

"In order to help students make decisions that promote healthy behaviors, the Department of Education shall instruct students that abstention from sexual intercourse is the surest and most responsible way to prevent unintended pregnancies, sexually transmitted diseases such as HIV/AIDS, and consequent emotional distress. The abstinence-based education program shall: a. support abstention from sexual intercourse and provide skill development to continue abstention;

b. help youth who have had sexual intercourse to abstain from further sexual intercourse until an appropriate time; and

c. provide youth with information on and skill development in the use of protective devices and methods for the purpose of preventing sexually transmitted diseases and pregnancy."

Substantively, the Department suggests that efforts are currently underway to address sexual health education:

Section 2 (a) 1 - 5 (pg. 2-3), Medically Accurate Sexuality Health Education:

The Department empowers students to act by promoting and protecting their health and advocating for the health of others. The program content includes important and enduring ideas, issues, and concepts related to achieving good health. The skills include ways of communicating, reasoning, and investigating which characterize a health-literate person.

<u>Section 2, (f) (pg. 4, lines 5-8)</u>: The Department has identified and made public a list of appropriate sexual health education curricula for middle/intermediate and high school students. Additionally, resources are available to parents, student, teachers and the public on our Department website at:

Sexual health education is a component of our efforts to support student success. As there are existing policies and resources in place to address this area, the department respectfully suggests that this measure is not necessary at this time.

Re: Testimony in Support, HB 459, HD1 Relating to Health

The Commission is in strong support of HB 459, HD1, which would specify additional elements for instruction under our already existing sexual health education law. Despite a strong sexual health education law already being in place, our Department of Education (DOE) still does not have uniform instruction on sexual health education and still focuses primarily on abstinence only education. This is a disservice to our youth, who do not have access to medically accurate sexual health education.

Hawaii's youth have one of the lowest rates of condom use in the nation. Additionally, our youth experience high teen pregnancy rates and sexually transmitted infection (STI) rates. The 2013 Hawaii Youth Risk Behavior Survey, compiled in conjunction with the Centers for Disease Control (CDC) and the DOE, found that 36% of teens in high school were having sex, 25% of those teens had multiple partners in the three months prior to the survey, and 54% of those teens did not use a condom. Even more startling, 18% reported never learning about AIDS or HIV infection in school. Finally, 24% used drugs or alcohol before their last sexual encounter. The CDC states that the solutions to these shocking realities are better health education, more comprehensive health services, more supportive policies, and more family involvement. HB 459, HD1 is the appropriate response. This bill specifies the curriculum components, including age appropriate and medically accurate sexual health information.

However, allowing parents to "opt-in" is highly fallible and will provide a disservice to students. Students with unstable housing, students from limited english speaking households, and students with parents of limited literacy will likely not read provided information. These marginalized students are the hardest to reach, but they stand to benefit the most from sexual health education. The Commission respectfully urges this Committee to pass HB 459, HD1, but asks that this Committee consider amending the language to an opt-out policy. Thank you for your time. ### TESTIMONY IN SUPPORT OF HB 459 HD1 RELATING TO HEALTH

Hawaii Youth Services Network (HYSN), a statewide coalition of youthserving organizations, supports HB 459 HD1 Relating to Health.

Hawaii's communities benefit when our youth have the knowledge, skills, and resources to make safe and healthy decisions about their sexual and reproductive health.

Because we have not yet committed the resources to ensure that our young people grow up sexually safe and healthy, Hawaii has the 9<sup>th</sup> highest rate of teen pregnancy in the United States even though fewer Hawaii youth are sexually active than the U.S. average. Unfortunately, our sexually active youth have the lowest rate of condom use in the U.S. because they lack consistent access to pregnancy prevention education at school and home. Hawaiian and Pacific Islander youth have particularly high risk of unplanned pregnancy and STIs – Their teen birth rate is 145 per thousand compared to 32 for the State overall.

Young women who give birth in their teens and their children face many challenges. At age 22, only half of teen mothers have graduated from high school compared to 90% of their peers who did not give birth as teens. Eighty percent (80%) receive Temporary Assistance to Needy Families Benefits (TANF) during the 10 years following the birth of the child.

The children fare less well in school, scoring lower on standardized tests of reading and math, more likely to repeat a grade, and less likely to graduate from high school than their peers. The children of teen parents have a higher rate of emergency room visits, are more likely to have chronic health conditions, and have a higher rate of child abuse and neglect.



All of this costs Hawaii taxpayers \$37 million dollars a year, 71% of it in state and local costs. We can reduce these costs by providing culturally relevant, medically accurate, age appropriate pregnancy and STI prevention education in our schools and homes.

Hawaii residents support pregnancy prevention education in our public schools. Ninetyseven percent (97%) of participants stated that it was important for Hawaii public schools to include sexual health education in their curriculum in a 2012 survey conducted by SMS Research. The majority felt that neither parents nor schools were providing a sufficient amount of sexual health information, and only half felt prepared to talk about sexual health topics with their children. The majority believed that education on most sexual health topics should begin in the middle schools, with some topics (such as anatomy, puberty, and sexual abuse) beginning in the elementary schools.

Young people who complete pregnancy prevention education programs are more likely to practice abstinence, delay initiation of sex, have fewer sexual partners, and use protection when, and if, they begin having sex. In our work with youth:

- 94% of students got correct answers to questions about behaviors that put them at risk for pregnancy or STIs.
- 92% of students report that they can say no if they are not ready for sex or to unsafe sex.
- 98% say that it is important for sexually active persons to use a condom every time they have sex.

Everyone wants their children to grow up safe, healthy, and ready to succeed. We teach our children how to cross the street safely, because we know that one day they will face the risks of traffic. We must also teach our youth how to protect themselves from the sexual risks they will someday face.

The community supports sexual health education in our public schools, and our young people need and deserve it.

Healthy Mothers Healthy Babies (HMHB) writes in support of H.B. 459 HD1 to promote the health and safety of our youth by ensuring that all public school students receive the most effective sexual health education.

Failing to ensure that all youth receive comprehensive sexual health education has resulted in poor health outcomes for Hawaii youth. Currently, Hawaii's teens rank lowest in the nation for condom use and for use of any type of birth control to prevent pregnancy during intercourse. The consequences are severe — Hawaii's teen pregnancy rate is 9th highest in the country and costs Hawaii taxpayers around \$32 million per year.

Our organization sees firsthand the needs and the consequences for failing to provide youth with factual, medically-based information. In addition to the high rate of unintended pregnancies, teens are less likely to seek timely prenatal care, and are more likely to deliver pre-term or low birth weight babies, contributing to the added cost of care.

Comprehensive sex education covers the wide array of topics that affect sexuality and sexual health. It is grounded in evidence-based, peer-reviewed science, to promote health and well-being in a way that is developmentally appropriate. It includes information and communication skills building as well as values exploration. Ideally, sex education in school is an integrated process that builds upon itself year after year, and is provided through grade 12.

Although parents and guardians are the primary sex educators of their children, children also receive messages about sexual health from many other sources - some of which may have more negative than positive impact. Schools and other community-based organizations can be important partners with parents to provide young people with accurate and developmentally appropriate sex education.

The goals of comprehensive sex education are to help young people gain a positive view of sexual health and to provide them with developmentally appropriate knowledge and skills so that they can make healthy decisions about their sex lives. Medically accurate sex education is an investment in our future — a generation of young people who have heard more helpful messages about sexual health; able to make well-informed, responsible decisions; form healthy relationships; and take care of their bodies.

Public opinion polls show that parents and students want sex education to be taught in our schools. In fact, Hawaii residents have shown that they support sexual health education in our public schools. - utilizes teachers who are well-trained, comfortable, and believe in the program

Schools, as well as faith groups and community-based organizations, all have roles to play. In fact, the nature of our education system in America puts schools in the ideal position to take the lead in this process.

Ideally, sexual health education would be taught each year in our schools from kindergarten through 12th grade. Like all school subjects, the information and skills that are taught are age-appropriate, reflect best-practice, and build on the previous year's learning. According to the late Dr. Douglas Kirby, senior research scientist for ETR Associates in Scotts Valley, CA, and a nonpartisan expert on the effectiveness of school and community programs in the reduction of adolescent sexual risk-taking behaviors, (Public Health Reports, 190 (1997), 339-360) effective sex education:

- uses behavioral goals, teaching methods, and resources that are age-appropriate, developmentally appropriate, and culturally competent
- is based on theoretical approaches that have been proven to be effective
- takes place over sufficient time to cover necessary topics and skills
- employs a variety of teaching methodologies that present the content in ways that make it relevant to the student
- provides basic, accurate information about the risks of unprotected sexual intercourse and how to avoid unprotected sexual intercourse
- includes activities that address peer pressure and cultural pressure
- practices decision making, communication, negotiation, and refusal skills
- utilizes teachers who are well-trained, comfortable, and believe in the program

Hawaii's youth deserve the best and most effective health education and H.B. 459 will go far to ensure that students have the information and tools they need to make healthy, safe and responsible decisions.

TESTIMONY OPPOSING **HB 459 HD1 AS WRITTEN** - MAKING RECOMMENDATIONS FOR AMENDMENTS

Chair Rep. TAKUMI, Vice-Chair Rep. OHNO and Members of the EDN Committee:

Aloha Kakou,

I am here on behalf of the 'Ohana Project of the Hawaii Family Coalition to point out a glaring omission in HB 459 HD1 and all sexuality health education curricula in Hawaii's public schools. If left unattended, this can put our children at great risk.

HB 459 HD1 purports to reinforce positive aspects such as: "abstinence," "parental inspection of the curricula," "opt-out" and "flexibility" for schools to offer the curricula.

The bill, however is not sufficient. It is fraught with vagaries and contradictions. It does not provide real objectives or guidelines.

The most glaring deficiency is the lack of full disclosure of possible legal consequences to minors who engage in the sexual activities described in the curricula. Students are not taught that they could go to jail if they engage in the sexual practices taught to them in the comprehensive sex-ed curricula.

If the curricula are to be "comprehensive" and "age appropriate" they should include full disclosure of legal ramifications to students. For instance: "At what age is it "appropriate" for children to engage in intercourse?" and… "At what age is it lawful?" What about other sexual practices?

Will students be taught that engaging in sexual conduct taught in the DOE curricula are, in most instances, against the law and they can suffer dire legal consequences? Including being prosecuted, jailed and branded for life as sex offenders?

Who determines what is or is not "age appropriate?" Does this take into account developmental maturity? Not all children of the same age are of the same maturity.

Does "age appropriateness" include the legal age when it is appropriate for children to engage in sexual activity?

Does the curriculum itemize what sexual acts are illegal for minors to engage in? And at what specific age?

Will teachers be held liable for teaching sexual practices to young children if they are caught (or reported) acting out what they were taught?

Will teachers be liable if a student engages in sexual activity prohibited by law, but was not informed during sex-ed class about it being against the law?

Will teachers be fully apprised of their potential liability?

Will teachers be indemnified of liability by the state? And to what extent? And under what circumstances?

What penalties will there be for teachers who violate "age appropriateness?"

What guarantees are there for teachers that they if they teach everything properly according to the curricula that they will not incur liability should a student(s) break the law regarding sexual conduct?

How do you ensure that teachers are imparting to students the "skills" to make "healthy decisions" and have "respect" for something that will impact them "throughout their lives?"

How do these terms apply to liability? How do they apply toward indemnity?

Would any teacher with "minimum education and training qualifications" be allowed to teach a curriculum that can have such serious legal consequences?

In order to be indemnified from liability, shouldn't teachers have to go through an intensive training to certify their skills in psychological evaluation to determine a child's developmental stage (age appropriateness); shouldn't teachers be certified to have the expertise to convey legal ramifications to children?

### PARENTS

Will the legal ramifications be clearly disclosed in the syllabus provided to parents?

Will there be a disclaimer stating the limits of the teachers' and schools' liability for this program?

Full disclosure would necessitate parents signing off (acknowledging the risks) on having their child in the program. That means the sex-ed program would have to be an "opt in," not "opt out" the program.

Will laws need to be changed to "relax" penalties to accommodate students who engage in sexual misconduct that they learned about it in sex-ed class?

Will there be special legislation to expunge the names of certain minors from the sex offenders list under circumstances where the school's sex-ed program was found to be responsible?

The basic point is: None of the legal risks are disclosed in any of the DOE's sex-ed curricula, comprehensive or not.

The current system leaves teachers, the DOE and the State exposed to serious legal repercussions by not warning minors of the possible consequences of engaging in sexual activity whether "they feel they're ready" or not.

**HB 459 should be amended to require the teaching of legal consequences.** The possible legal ramifications for engaging in sexual conduct as found in the curricula should be fully disclosed to parents so that they can make an informed choice whether they want their child exposed to teachings that may endanger their child.

The information being put into the minds of children, by definition too young to make calculated, discerning, responsible decisions, endangers the child. In essence, it's like giving a child matches, cigarette lighters and blow torches to play with, without ever mentioning safety and safe use. How to put on a condom will not protect a child from legal consequences.

The potential for serious harm to children would require that the sex-ed curricula be offered only to those students whose parents are fully aware of the ramifications and choose to allow their children to participate. In other words, sex-ed should be "opt-in" requiring parental consent and indemnification.

Without full legal disclosure, the current curricula place everyone from the child on up in jeopardy. **Please amend HB 459.**

# Re. **Testimony in Support, HB 459, Relating to Health (specifically, Sexuality Health Education)**

I am grateful for this opportunity to testify in strong support of HB 459 HD 1 (with one suggested change back to opt-out), requiring that public schools provide medically accurate, age appropriate health education. My testimony is on behalf of the approximately 400 members of the American Association of University Women (AAUW) in Hawai'i, who list choice and women's reproductive health as an important current concern. My testimony is informed by my experiences teaching at the University of Hawai'i at Manoa, where, almost every semester, a female student in one of my classes finds herself dealing with an unplanned pregnancy. No doubt, many of my students also discover that they are harboring sexually transmitted infections (STIs). Although this is not something that they share with me, it is an obvious correlate of high STI rates across Hawai'i combined with inadequate health education.

On behalf of all these constituencies, I argue that passage of HB 459 is important, with great potential to decrease STIs and unplanned pregnancy rates across the state. A bill which encourages medically accurate, age appropriate discussion about body maturation processes, emotional growth, and reproductive health is an important step in encouraging youth to move forward into enjoyable, healthy adult lives.

While it would be wonderful to assume that this discussion would take place in Hawaiian homes, realistically, this does not happen. I have taught thousands of university-level students over the years, and only a handful of these students ever mentioned receiving accurate sexual education from their parents or guardians. Since my teaching portfolio includes many courses covering sex, gender, and gender violence, these class conversations occurred in the course of university educational fora and were particularly shocking to me, since my parents did discuss these issues with me, for which I am grateful. It is ironic that more parents don't discuss sexual health, maturation, and relationship topics with their children regularly, given that most children are accessing information and misinformation from the World Wide Web fairly easily. In a 2007 University of Alberta study, 90% of boys and 70% of girls (aged 13-14 years) stated that they had viewed sexually explicit items online at least once. A 2007 article in *Pediatrics* (Wolak et al.) found that 13% of youthful internet users, aged 13-17 years were purposefully locating X-rated online sites. There is ample evidence that youth are educating themselves from highly inappropriate, inaccurate sources, and in this well-connected world, age appropriate, medically accurate sexuality education for each and every child in Hawaiian schools is long overdue. Body knowledge is just as important as reading, mathematics, and other subjects taught in educational settings, and should be taught in a similar straightforward manner, as occurs in other first-world nations.

I am very disappointed that the current version of the bill (i.e., HB 459 HD 1) has changed the opt-out terms of the original bill to an opt-in modus operandi. This is not good public health provision, since it means that disengaged, disorganized parents' inability to return paperwork will result in their children missing out on information key to their future success. This means that the children most in need of sexual health education will not receive it, which does not bode well for rates of unplanned parenthood or sexually transmitted infections. Life is difficult enough for children living in chaotic home environments, and these youth do not need additional challenges. Please return to an opt-out provision in the bill. This is responsive to those parents who do not wish their children to be educated, while not penalizing children from chaotic homes.

In conclusion, passage of HB 459 HD 1 (please with a change to opt-out) is an important step toward improved health for teens and young adults, and ultimately, the wider Hawaiian population.

Aloha Dear Chair Takumi and Members,

"Health education" as it was known in my youth, was taught in every public school at or before the onset of puberty. We walked away from the class tittering, but with real knowledge of the "facts of life" to counteract the misinformation we were feeding one another in our respective locker rooms. That we now find ourselves in a political climate where the health and wellbeing of our youth is at risk because a certain segment of the

population believes that if you don't tell teens about sex they won't do, it is both sad and laughable.

This is especially true since the advent of easy access to explicit sex on the Internet. If accurate sex education is not taught in our public schools then teens WILL get their information, not just in locker rooms, but most certainly from the Internet.

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 300 local members. On behalf of our members, we offer this testimony <u>in support</u> of HB 459, HD 1, relating to health.

This bill codifies into law medically-accurate sexual education programming guidelines, including the provision of information about healthy and nonviolent relationships. This directly impacts our youth's susceptibility to sex trafficking, since traffickers engage in a variety of "grooming" practices to induce unhealthy sexual relationships with underage victims and subsequently coerce them into commercial sexual exploitation. Education is key to preventing sex trafficking, yet no standardized lessons on trafficking are included in departmental health curricula. As you're undoubtedly aware, human trafficking is a problem on our shores. Approximately 110,000 advertisementss for Hawaii-based prostitution are posted online each year, many of which feature locations that exploit school age children. According to a recent IMUAlliance study, Hawai'i hosts roughly 150 high-risk sex-trafficking ring involving several teenage girls, culminating in a pending criminal case against three individuals for promoting prostitution.

It is imperative that we improve sexual health curricula to promote the safety of our keiki. Mahalo for the opportunity to testify <u>in support</u> of this bill.

I strongly OPPOSE HB 459. This is bill is not needed and no one said it better than our own state Superintendent of Education who, in her testimony before the Health Committee wrote, "As there are existing policies and resources in place to address this area, the department respectfully suggests that this measure is not necessary at this time." Why is the state legislature not listening to the comments by the Superintendent of the DOE?

The premise of this bill is not supported by the most recent findings in neuroscience. Comprehensive sex education will do more harm than good. Dr.'s Joe S. McIlhaney and Feda McKissic Bush recently published book, *Hooked: New Science on How Casual Sex is Affecting Our Children*, specifically documents the breakthroughs in research regarding the chemical changes that occur in the brain with regard to sex, sexual images, sexual activity, sex education, etc. The book is a must read for every professional educator, pastor, teen and policy maker. Comments: I write in strong support of HB459. Once my son reaches the age of instruction, I do have an expectation that he will be informed with medically-accurate and age appropriate sexual health education, uncompromised by biases that view sex within the paradigm of reproduction. This perspective fails to include other behaviors and circumstances in which STI's can occur, particularly those intended to circumvent pregnancy. It also fails to help students recognize the different ways in which sexual and emotional abuse can occur. This particular aspect is of great concern to me, especially because children may be victimized before the onset of puberty when their own sexual awareness begins to develop. Pono Choices can help students learn to protect themselves by making smarter choices in situations where their parents most assuredly will not be present to intervene.

Furthermore, I believe the purpose of Pono Choices is not to stigmatize or place value judgments upon either the students themselves or the types of sexual behavior they engage in, but to place equal value upon the sexual health and safety of each and every student. I appreciate that this program is cognizant of the potential to create a false sense of invulnerability among students if they are misled into believing that identity or orientation is the predominate variable of risk rather their own individual behaviors.

I also support an opt-out provision to better ensure that more kids are aware of their ability to harm not just themselves, but others - others like my own kid. Not unlike children who are deliberately unvaccinated, an uneducated pool of students can impact the health and safety of those with whom they interact. Equipping our kids with science-based, medically-accurate facts is the best way to promote the mutual safety and protection of our children.

In closing, I would hope that the level of discussion this program has generated from both opponents and supporters has encouraged many of us to address the topic of sexuality health education with an honesty and maturity level befitting that of parents and adults.

Thank you for the opportunity to share my concerns about HB 459. I oppose this bill and encourage you to do the same.

There are points of agreement that we share. . .concern for Hawaii's keiki, student health particularly relating to sexuality, concern for young people engaging in sexual activity resulting in S.T.D.'s (S.T.I.'s), more pregnancies and hurting their chances for pregnancy later because of S.T.I.'s, young people making good choices that will positively impact their future and the welfare of society in general, importance of full disclosure to parents, absence of forced or violent sex, etc. Because we share points of agreement, I have provided some solutions interspersed below.

I have many reasons why I oppose HB459. Here are several.

1. Medical accuracy discriminates against sexual orientation and alternative sexual practices. And yet this bill states that information will be BOTH medically accurate and that people will not be discriminated against... "sexual orientation." Page Line

• So which will give in to the other? Will the information provided to our keiki be truly medically accurate. Sexual anatomy and physiology do not

lie as to what the purpose of various body parts are (i.e. penis, vagina, anus, mouth/throat). Anatomy clearly tells us that a vagina is made to receive a penis, an anus is not, which is why H.I.V. rates for men having sex with men are a 3000% greater risk of H.I.V. infection. Negative consequences abound for using the anus to receive a penis, for others, see the following link. <u>http://www.webmd.com/sex/anal-sex-health-concerns</u>

 Will providing medically accurate information be considered discriminating against those who say they have a different sexual orientation? For example, those will those who choose to participate in oral sex (penis in mouth) be told about the increasing rates of the incurable human paphiloma virus (H.P.V.)? Will they be told that HPV is the most common STI currently affecting 79 million Americans and adding 14 million new cases every year? Will they be told that HPV causes genital warts and cancer? Center for Disease Control <a href="http://www.cdc.gov/std/HPV/STDFact-HPV.htm#a7">http://www.cdc.gov/std/HPV/STDFact-HPV.htm#a7</a>. So, even though sexual anatomy does not lie, will people who teach our keiki lie by withholding true medically accurate information because they fear discriminating against people who choose alternative sexual practices?

2. A curriculum mandated by HB459 cannot possibly be a one-size-fits-all curriculum!

- Keiki are at different developmental ability cognitively, emotionally, relationally, and spiritually. A curriculum and/or teacher cannot possibly address the individual needs of every student in the classroom.
- Our keiki come from diverse family backgrounds. . .religiously, culturally, language, etc. How can a teacher or curriculum possibly be sensitive to each of our keiki's needs relating to ohana? To mandate a curriculum means that information will be thrust upon our keiki that will cause them much conflict and not create a safe place for learning. Every student needs to feel safe in our schools!

• An example of this has to do with my son's friend who said he almost fainted during sex ed class in 7<sup>th</sup> grade. This young man was obviously not ready to receive this information.

3. One solution to the above dilemma regarding the impossibility of a one-sizefits-all curriculum is to return sexual health education to the proper authority, namely the parents of the keiki.

• How can the State work together with each community (schools, religious groups, medical professionals, etc) to empower parents to teach their own keiki about sexual health in a way that respects the parents' authority, and their cultural and religious needs?

4. The Supreme Court has already stated clearly that parents are the primary authority and teacher of their own keiki. The State of Hawai'i wouldn't want to go against the Supreme Court would it? Please see the following Supreme Court cases and take note: U.S. Constitution, 14<sup>th</sup> Amendment, Due Process. US Code and CFRs. ORS & OAR

- "The child is not the mere creature of the state ...[the state of Oregon, by forcing parents to place their children in public school] unreasonably interfere[d] with the liberty of parents and guardians to direct the upbringing of their children under their control."
   -Pierce v. Society of Sisters (1925)
- "It is cardinal with us that the custody, care and nurture of the children reside *first in the parents*, whose primary functions and freedom include preparation for obligations *the state can neither supply nor hinder*." -*Prince v. Massachusetts*(1944)
- "The primary role of the parents in the upbringing of their children is now established beyond debate as an enduring American tradition...[*Parents'* duty to prepare children for] *additional obligations...include the inculcation of moral standards, religious beliefs, and elements of good citizenship.*"

-Wisconsin v Yoder (1972)

• "Our decisions establish that the Constitution protects the sanctity of the family precisely because the institution of the family is deeply rooted in this

Nation's history and tradition. *It is through the family that we inculcate and pass down many of our most cherished values, moral and cultural . -Moore v. East Cleveland (1977)* 

• "[O]ur constitution long ago rejected any notion that a child is a mere creature of the State and, on the contrary, asserted that *parents have the right coupled with the high duty* to recognize and prepare [their children] for additional obligations."

-Troxel v. Granville(2000)

5. In general, parents remain the best teachers for their keiki.

- Parents have known their children from inside the womb and have watched them grow. Parents know a child's personality, quirks, interests, communication ability, age readiness for potentially challenging subjects like sexuality and engaging in sex. Parents also know the values that they have taught their children.
- Some parents have challenges in parenting and communicating with their keiki about sexual matters. What can be done?
  - Solution: have the entire community work to create a program that will assist parents who are in need.
  - Solution: Assuming that there is full disclosure on what will be taught (and this has NOT been the case with current programs) give these parents an opportunity to "opt in" to a program for sexual health. Then the parent is still making an empowered choice.

6. In her written testimony to the Health committee, Superintendent Matayoshi stated that the D.O.E. does not currently need comprehensive sex education taught in our schools at this time.

 "Sexual health education is a component of our efforts to support student success. As there are existing policies and resources in place to address this area, the department respectfully suggests that this measure is not necessary at this time." 7. Planned Parenthood is one of the primary encouragers of comprehensive sex education (i.e. HB459). This is a major CONFLICT OF INTEREST BC they make their \$\$ off abortions and contraceptives via Federal funding/Tax dollars

Planned Parenthood is responsible for 300,000 abortions every year. Do you see a conflict of interest here? ## HB 459 (HU EDN) RELATING TO HEALTH

Government schools should substantially limit the any lessons about human sexuality. Our society embraces such diverse opinions about sexuality, what is acceptable for one family could be totally inappropriate for another; therefore any education should be limited to biological facts, with lifestyle choice discussions relegated solely to individual family unit discretion. Those are the boundaries we should maintain. Sexual education is a personal and private matter that should remain reserved as a parental responsibility.

## Page 3 of the bill MANDATES sex education be offered for any "elementary, middle, intermediate, high, and alternative school" operated by the DOE.

This laxity in the DOE with regard to age appropriateness is of concern. This bill invites harm to the Keiki. Young children in elementary school can actually suffer mental harm if they are taught sex education too early. Psychiatrist Melvin Anchell noted:

"Scholastic tests done on today's sexually educated 6- to 12-year-olds, indeed, show that these students have accomplished less scholastically than pre-sex-education students.

- "The sex teachings given to the 6- to 12-year-old students keep sexual impulses stirred up, disrupting sexual growth, as well as personal and cultural achievements."
- "A partial summary of adverse effects due to the sex educators' interferences during [this period] is that they: 1) Make the 6- to 12-year-old student less educable; 2) can block the development of

compassion; 3) weaken the mental barriers controlling base sexual instincts, thereby making the child vulnerable to perversions in later life.

## Page 3 of the bill also states: "At their own discretion, teachers may answer in good faith any question initiated by a student or students that is reasonably related to and consistent with the material of a course..."

This is very broad. And it also means that parents will likely <u>not have access to the oral statements</u> <u>made by the teachers</u>, since those statements are not part of the written curriculum.

# Page 4 of the bill states that "Sexuality health education under subsection (a) shall not discriminate on the basis of sex, race, ethnicity, national origin, disability, religion, sexual orientation, or gender identity".

The reality is that not all relationships are the same. There are HEALTH consequences to male-onmale sexual intercourse. According to the CDC, bisexual and homosexual males are about 2% of the US population; but an estimated 57% persons living with an HIV diagnosis in the United States are gay and bisexual men, or gay and bisexual men who also inject drugs.

This bill could mean that homosexual relationships and transgender lifestyles would need to be discussed—even to elementary students. Further, the bill's language could also be interpreted to simultaneously mandate a need to CENSOR the disclosure of the elevated health risks of homosexual behavior—in an effort to curb "discrimination". The bill could also be used CENSOR any dissent against the merits of transgender surgery, even though Johns Hopkins—which originally pioneered such surgeries—stopped doing them because they were actually harmful.

HB 459 leaves too much room for government intervention into the private lives of its citizens.

I'd like to write in opposition to HB 459 or any additional comprehensive sex education bills. The proposed bill calls for a curriculum of one size fits all for sex education. We know that in any subject matter, math, science, reading, a one size curriculum is extremely difficult to tailor to the needs of each individual student in any specific class. How much more difficult would it be to create a law which mandates teachers to teach our keiki a sensitive subject matter of sexuality, knowing that children mature at such different rates! Rates that vary in years at this point of their life, not just a few months. I would never imagine talking to my oldest child about some things that I can see my youngest child may be ready for at the same age. It would have greatly traumatized her, an extremely shy and uncertain individual. This bill is assuming that a comprehensive sex education curriculum accurately identifies when every single child would be ready for this information. Dear Rep. Takumi and members of the House Education Committee

My name is Barbara Afe.

I am respectfully asking you to read my testimony as, having worked in a detention facility for five years, I am well experienced with problems of juvenile sexual assault...juveniles just doing what they were taught in school was "okay if it feels good." Perhaps they heard it from teachers who may someday be held liable for teaching sexual practices to youth too young to legally engage in sexual activities.

Their parents need to be fully informed so they can make the decision whether of not to "opt-in" their children into these programs that prematurely sexualize their young children. After all, it's the families that will bear the brunt of any legal and social consequences.

I moved to Hawaii in 1985. I raised my three children here, left in 1996 and returned in 2009. During my years in the mainland, specifically Wichita, Kansas, I was the Chaplain of the Sedgwick County Juvenile Detention Facility for five years.

I saw more than a few youth charged and often found guilty of sexual assault status offenses. Occasionally some were tried as adults. There were both male and female, but mostly male. All had one thing in common: they did not know that they were committing a crime or status offense until after the fact.

I remember speaking with a prosecuting attorney about this. His words, "Yeah, we get these kids at the end but no one tells them at the beginning."

The comprehensive sex ed curricula in Hawaii's public schools do not address possible criminal charges. This is not only *not comprehensive*, it is costly and damaging to the youthful perpetrators and their families as well as their victims and their families.

Confidentiality keeps most of what I know with me alone, but I would like to share three stories. I know these males:

• Homecoming king, 17. Girl was 16, that's what she said. She was in fact 13 and her parents pressed charges.

• Male, 14, girlfriend and mother of his child, 16. He left the area, came back, found out she cheated on him. He hit her and was charged with aggravated

sexual assault. He didn't comply with his probation and has been in an adult facility in Kansas until 2016. It's been five years so far.

• Finally, Matthew Henderson, along with his older brother and father sexually assaulted his two younger sisters. A very high profile case. The two sisters were on Oprah Winfrey a few years ago. The show was titled 'Promise not to tell'. Matthew's older brother and father got 35 years in prison. Matthew got 7 years. He was a kid following his brother and father. Matt is a registered sex offender who has been in and out of jail since his release in 2013. He is now 22 years old, has a difficult time finding a place to live and work. I still keep in touch with Matt, he was in my facility as he awaited trial. While he knew what his family was doing wasn't right, he was 15 years old and didn't know he was committing a crime.

These are just a few I can personally attest to. There are many more in the facility where I worked. I shudder just to think of thousands more children across the country and here in Hawaii, trapped in similar and even worse situations.

Because none of the curricula disclose the legal ramifications, it will be up to you as a state legislator, to protect the children of Hawaii (both victims and perpetrators); teachers, parents, the school system and even the state, by at least making sure children are made aware of the serious legal consequences for sexual misbehavior as minors.

# PLEASE AMEND HB 459 to include full disclosure of legal consequences and protections from liability.

I am in strong opposition to HB459.

Mahalo, Representative Bellati, for not including the "opt-out" policy change into the current bill, but there are other concerns parents and teachers should have about this bill.

1. HB 459 cannot ensure that our younger keiki will not be exposed to Comprehensive Sex Education. Other states begin as early as Kindergarten.

2. Comprehensive Sex Ed is not an agreed upon healthy and effective method of teaching children about sex. It sounds good on the surface (mostly because of the term "comprehensive." Most would agree that term would suggest that we are attempting to cover all our bases and our children would be safer. But the term is misleading.

For example, abstinence has been devalued in many instances where C.S.E. has been adopted - and sexual activity is assumed, encouraged and sexual acts end up being *taught*. Yes, the acts of intercourse (anal and vaginal), as well as masturbation and oral sex are being taught to students. (Just see "Pono" Choices experimental curriculum developed by Planned Parenthood and U.H. Manoa Center for Disability Studies.)

3. Comprehensive Sex Ed is "values neutral." It does not want to instill any moral boundaries about sex (even regarding age or dangerous practices that have been statistically proven.) Sex is not "good" or "bad" it is just an act that people do. Common sense and experience tells us that there are serious consequences of "free sex" without any moral guidelines.

Let's teach our abstinence first and help our Hawaii's students learn about character, respect, ethics – which will give them a great moral framework to make good decisions as they learn about the basics of sex education. But let's not teach our children that sex is fine even if you are a minor and "By the way, if you are going to do it, here's how..."

4. Why go against the wisdom of those who are in charge of our schools, who work closely with teachers, parents and students? I agree with D.O.E. Superintendent,

Kathryn Matayoshi, who recently submitted *against* HB459 for a number of good reasons.

Finally, I want to thank you for the work you have done to set up measures to protect our children. I believe our legislators want to protect the children of Hawaii. Yes, we want to do everything we can to help parents, children and families in this day and age, but Comprehensive Sex Ed is not the route we should take. There are too many controversial teaching methods, curriculum and agendas by outside groups that want to reform the way our culture looks at sexuality and sex.
