Purpose of Bill:	Specifies additional elements in Hawaii's existing sexuality health education law, including additional criteria regarding implementation of sexuality health education instruction. Requires the Department of Education to provide certain types of information to the public and parents. (HB459 HD2)

Department's Position:

The Department of Education (Department) would like to provide comment on HB 459 HD2 which proposes to specify additional elements of Hawaii's existing sexuality health education law and its implementation. We respectfully offer the following comments on this measure.

Sexual health education is a component of our efforts to support student success. As there are existing policies and resources in place to address this area, the department respectfully suggests that this measure is not necessary at this time. Further, the annual requirement to report *"on the participation rates and outcomes of the Department's policy to allow parents to opt-in to participate in sexuality health education programs in the previous school year"* will add a reporting requirement for schools and increase their workload. (Section 2 (g), pg. 4, lines 9-15)

As a public school system, the Hawaii State Department of Education follows statutory requirements, Board of Education policies and nationally recognized guidance to inform curriculum development and adoption.

Schools provide a comprehensive sexual health education that follows the requirements set forth in the Hawaii Revised Statutes (HRS) §321-11.1 and the Hawaii State Board of Education (Board) Policy 2110, Abstinence-Based Education, which states:

"In order to help students make decisions that promote healthy behaviors, the Department of Education shall instruct students that abstention from sexual intercourse is the surest and most

responsible way to prevent unintended pregnancies, sexually transmitted diseases such as HIV/AIDS, and consequent emotional distress. The abstinence-based education program shall: a. support abstention from sexual intercourse and provide skill development to continue abstention;

b. help youth who have had sexual intercourse to abstain from further sexual intercourse until an appropriate time; and

c. provide youth with information on and skill development in the use of protective devices and methods for the purpose of preventing sexually transmitted diseases and pregnancy."

Substantively, the Department suggests that efforts are currently underway to address sexual health education:

<u>Section 2 (a) 1 - 5 (pg. 2-3), Medically Accurate Sexuality Health Education:</u> The Department empowers students to act by promoting and protecting their health and advocating for the health of others. The program content includes important and enduring ideas, issues, and concepts related to achieving good health. The skills include ways of communicating, reasoning, and investigating which characterize a health-literate person.

<u>Section 2, (f) (pg. 4, lines 5-8):</u> The Department has identified and made public a list of appropriate sexual health education curricula for middle/intermediate and high school students. Additionally, resources are available to parents, student, teachers and the public on our Department website at:

Further, should this Committee decide to move this measure forward, the Department asks that the following language be amended, Section 2 (b) (pg. 3, line 11) to read: "...elementary, middle, intermediate, and high schools, and alternative school..."

Honorable Chair Kidani, Chair Green, and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 300 local members. On behalf of our members, we offer this testimony <u>in support</u> of HB 459, HD 2, relating to health.

This bill codifies into law medically-accurate sexual education guidelines, including the provision of information about healthy and nonviolent relationships. Access to this information directly impacts our youth's susceptibility to sex trafficking, since traffickers engage in a variety of "grooming" practices to coerce underage victims into commercial sexual exploitation.

Education is key to preventing sex trafficking, yet no standardized lessons on trafficking are currently included in departmental health curricula. As you're undoubtedly aware, sex trafficking is a problem on our shores. Approximately 110,000 advertisements for Hawai'i-based prostitution are posted online each year, many of which feature school age children. According to a recent IMUAlliance study, Hawai'i hosts roughly 150 high-risk sex trafficking establishments.

It must also be noted the average age of entrance into commercial sexual exploitation, both locally and nationally, is 13-years-old, the age of an average eighthgrader. Sadly, Moanalua and Campbell High Schools were recently home to a sex trafficking ring involving approximately a dozen teenage girls, culminating in the prosecution of three men for promoting prostitution.

It is imperative that we improve sexual health curricula to promote the safety of our keiki. Mahalo for the opportunity to testify <u>in support</u> of this bill.

Dear Members of the Committee on Education,

Healthy Mothers Healthy Babies (HMHB) writes in support of H.B. 459 HD1 to promote the health and safety of our youth by ensuring that all public school students receive the most effective sexual health education.

Failing to ensure that all youth receive comprehensive sexual health education has resulted in poor health outcomes for Hawaii youth. Currently, Hawaii's teens rank lowest in the nation for condom use and for use of any type of birth control to prevent pregnancy during intercourse. The consequences are severe — Hawaii's teen pregnancy rate is 9th highest in the country and costs Hawaii taxpayers around \$32 million per year.

Our organization sees firsthand the needs and the consequences for failing to provide youth with factual, medically-based information. In addition to the high rate of unintended pregnancies, **teens are less likely to seek timely prenatal care, and are more likely to deliver pre-term or low birth weight babies**, contributing to the added cost of care.

Comprehensive sex education covers the wide array of topics that affect sexuality and sexual health. It is grounded in **evidence-based, peer-reviewed science**, to promote health and well-being in a way that is developmentally appropriate. It includes information and communication skills building as well as values exploration. Ideally, sex education in school is an integrated process that builds upon itself year after year, and is provided through grade 12.

Although parents and guardians are the primary sex educators of their children, children also receive messages about sexual health from many other sources - some of which may have more negative than positive impact. Schools and other community-based organizations can be important partners with parents to provide young people with accurate and developmentally appropriate sex education.

The goals of comprehensive sex education are to help young people gain a positive view of sexual health and to provide them with developmentally appropriate knowledge and skills so that they can make healthy decisions about their sex lives. **Medically accurate sex education is an investment in our future** — a generation of young people who have heard more helpful messages about sexual health; able to make well-informed, responsible decisions; form healthy relationships; and take care of their bodies.

Public opinion polls show that parents and students want sex education to be taught in our schools. In fact, Hawaii residents have shown that they support sexual health education in our public schools. Ninety-seven percent (97%) of participants stated that it was important for Hawaii public schools to include sexual health education in their curriculum in a 2012 survey conducted by SMS Research.

While only half of the participants felt prepared to talk about sexual health with their youth, the majority of participants didn't feel that parents or schools were providing a sufficient amount of sexual health information. A majority also believed that education on most sexual health topics should begin in the middle schools, with some topics (such as anatomy, puberty, and sexual abuse) beginning in the elementary schools.

Comprehensive sexual health education is a systematic and layered education process that supports youth and their families and helps them acquire the sexual health-related information, skills, and motivation necessary to act in ways that are congruent with their values. Like all school subjects, the information and skills that are taught are age-appropriate, reflect best-practice, and build on the previous year's learning.

HMHB strongly supports effective sex education that accomplishes the following goals:

- uses behavioral goals, teaching methods, and resources that are age-appropriate, developmentally appropriate, and culturally competent
- is based on theoretical approaches that have been proven to be effective
- takes place over sufficient time to cover necessary topics and skills
- employs a variety of teaching methodologies that present the content in ways that make it relevant to the student
- provides basic, accurate information about the risks of unprotected sexual intercourse and how to avoid unprotected sexual intercourse
- includes activities that address peer pressure and cultural pressure
- practices decision making, communication, negotiation, and refusal skills
- utilizes teachers who are well-trained, comfortable, and believe in the program

Hawaii's youth deserve the best and most effective health education and H.B. 459 will go far to ensure that students have the information and tools they need to make safe, healthy and responsible decisions.

Testimony in Opposition to H.B. No. 459, Relating to Health

Thank you for this opportunity to testify. In discussing any proposed legislation, t is important to look at the necessity of that legislation, the consequences of the proposed legislation, and its impacts on the groups and individuals primarily affected by the proposed legislation. In the interest of time, I will simply cover the first point.

<u>First, it is unclear why this legislation is necessary.</u> The same study relied upon by the Hawaii Youth Services Network, Planned Parenthood, and other groups that have testified I support of this measure states that <u>Hawaii is no longer 9th in the nation with regard to teen pregnancy</u>. That old statistic of 9thin the nation is from 2010, when the teen pregnancy rate was 65 pregnancies in Hawaii per 1000 teen girls. The <u>number of teen pregnancies in Hawaii as of 2013</u>, the most recent date for which data is available in that study, shows that there <u>were only 25</u> teen pregnancies in Hawaii <u>per 1000 teen</u> <u>girls, a drop of more than 61 percent!</u>

This same study also shows that in 2013 Hawaii is second lowest state in the nation in the rate of <u>sexually active teens</u> (the only lower state being Alaska).

Clearly, Hawaii is already doing something right when it comes to teen pregnancy and sexual activity.

The groups that testified in support of this measure also admit that Hawaii already has a "strong sexual health education law" and that parents are and should be the "primary sex educators of their children."

In addition, the Hawaii Department of Education (DOE), which is the State department entrusted with educating Hawaii's keiki in all areas, <u>has testified that the Department already has what it needs to</u> <u>educate our keiki in this area.</u> Specifically, Superintendant Matayoshi of the Hawaii DOE testified that in the Hawaii Department of Education:

"Sexual health education is a component of our efforts to support student success. As there are existing policies and resources in place to address this area, the department respectfully suggests that this measure is not necessary at this time."

Why did Superintendant Matayoshi say this? Her testimony makes it clear that <u>the Department</u> <u>already provides medically accurate sexuality health education, and already provides a list to the</u> <u>public of the materials that they use, including resources on the Department website</u>. Specifically, the Superintendant noted that:

"The Department empowers students to act by promoting and protecting their health and advocating for the health of others. The program content includes important and enduring ideas, issues, and

concepts related to achieving good health. The skills include ways of communicating, reasoning, and investigating which characterize a health-literate person."

Clearly, the Department is already taking a reasonable, broad-based, and appropriate approach to educating our keiki as whole persons, who are empowered to make good choices regarding their health and that of others in all areas, including their sexuality, without placing undue emphasis on any one area.

In addition, Superintendant Matayoshi stated that "The Department has identified and made public a list of appropriate sexual health education curricula for middle/intermediate and high school students. Additionally, resources are available to parents, student, teachers and the public on our Department website...."

In summary, for these reasons it seems clear that this legislation duplicates efforts that the Hawaii Department of Education already has underway, is unnecessary legislation, and should be deferred at this time.

Alternatively, this measure should be amended to delete Section 2, paragraphs b, c, d, and e to allow the Hawaii Department of Education to continue its current efforts and to report to the 2016 Legislature on the results of its study of those efforts.

Dear Legislators:

Bills are written in language that sounds positive and morally upright. It is easy to be persuaded by that language and concede to what it purports if you don't read carefully and critically.

I am just afraid that people have long been convinced that it is good for schools to provide sex education that they don't or won't question a bill like HB 459. However, I am using this opportunity to encourage our legislators to read deeper and ask these questions before making their decision to support or oppose.

From Section 1, paragraph 1:

1) What proof or evidence is there "that sexuality health education promotes healthy attitudes on adolescent growth and development, body image, gender and sexuality, dating, relationships, and family"?

2) And, if the above is true, why then is there the need to "bolster" the effectiveness of sexuality health education?

3) What is a "comprehensive approach to sexuality health education"?

4) What does *"greater flexibility in implementation"* mean? Why is there the need for *"greater flexibility"*? With *"greater flexibility"* you risk being able to blur the lines of having standards. Is that the goal – to be able to make all lifestyles and life choices acceptable?

5) In the last sentence of Section 1 paragraph 1, it states *"providing...greater flexibility in implementation,"* but Section 1 (1) states, *"...including additional criteria regarding implementation of sexuality health education..."* Which is it -- flexibility or adding criteria? Criteria seems to mean more regulation and requirement, not flexibility.

From Section 2:

6) Who determines what is *"age appropriate"*? How can you lump all kids who are chronologically 7 years old and say they are all at the same emotional, intellectual, behavioral maturity level to be able to hear and understand the content? You are taking a standard population and generalizing that ALL kids of that age fit.

7) In (5c), teachers may use *"their own discretion"* and *"answer in good faith"*? This allowance has the possibility of inviting subjectivity and personal beliefs. I think even teachers would find this statement questionable. It would a good argument for <u>not</u> having sex education in the schools.

8) What is Hawaii's existing sexuality health education law, and where can the public access it?

Finally, after all these years of sex education being offered in schools, the rates of teenage pregnancy are still on the rise and use of condoms are not. Then, why do we think more sex education is what is needed? And why do we look to schools to educate our young? Some say it is because kids come from homes where the family structure and parental control are lacking so they don't get the guidance. But, do we consider that it is because the school, a government entity, has taken that responsibility away from parents that parents don't need to step up and teach their own children? Parents have been made to rely and, in fact, trust schools to do their job.

Here is my radical proposal: Rather than "bolster" sex education in our schools, just do away with sex education in the schools and put the responsibility back on the parents where it belongs.

Parents are rightly the child's primary teacher. Schools and school teachers are to support parents. Let's keep the roles and responsibilities in proper order.
