HB 504 HD1 - RELATING TO PESTICIDES

Chair Choy, Vice Chair Ichiyama, and members of the House Committee on Higher Education thank you for this opportunity to testify in <u>support</u> of HB 504 HD1, which Increases the pesticide licensing fee and amends authorized uses for moneys in the pesticide use revolving fund.

Although we defer to the Department of Agriculture on the fiscal and management implications of HB 504 HD1 within the department, we strongly support the self-funded partnership that this measure would establish between the Department of Agriculture and the University of Hawai'i in order to comprehensively address pesticide education, training and monitoring in the State of Hawai'i.

As written, this bill would increase infrastructure within both the Department of Agriculture and the College of Tropical Agriculture and Human Resources, University of Hawai'i at M noa, to address this area of much concern to both the agricultural community and the public at large. This would be done through user fees, at no cost to the State general fund.

In complementation to the pesticide applicator certification training undertaken by the Department of Agriculture, a pesticide extension specialist with the College of Tropical Agriculture and Human Resources focuses on education of farmers and other users in proper choice of pesticides for different pests and purposes; integration of pesticides with other non-chemical pest control methods in order to minimize pesticide use and environmental exposure; extension of new research results to help farmers change and adapt their pest control practices; and education of the public on pesticide risks and benefits, and response to public concerns.

The activities of the pesticide extension specialist are expected to lead to additional federal funding to Hawai'i, and more comprehensive education and training efforts than could be accomplished by either the Department or the University in isolation. For example, prior to his retirement a decade ago, Dr. Barry Brennan held a comparable position at the University and was successful in obtaining grant funds from US EPA and USDA to found and support immigrant farmer training in pesticide safety and effective pest management. Through distribution of educational materials, Dr. Brennan was also active in public education, including mitigating public concerns during the heptachlor emergency of the 1980s.

Without a funding mechanism such as that proposed in HB 504 HD1, a university pesticide extension specialist position is now difficult to justify, since the position may not directly contribute to student tuition revenues under current budget models. Thus, we believe it is very important to maintain support for this position in HB 504 HD1, and we are glad to partner with the Department of Agriculture on this comprehensive approach to pesticide education and training.

Chair Choy and Members of the House Committee on Higher Education:

I am Paul Oshiro, testifying on behalf of Alexander & Baldwin, Inc. (A&B) and its agricultural company Hawaiian Commercial & Sugar Company on HB 504 HD1, A BILL FOR AN ACT RELATING TO PESTICIDES. We support this bill.

Pesticide use in Hawaii is extensively regulated by both the Federal Environmental Protection Agency and the State Department of Agriculture under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) and the Hawaii Pesticide Law (Chapter 149A, HRS). Depending upon the pesticide and its intended use, the EPA and the State impose mandatory conditions and requirements that are science based and designed to protect the pesticide applicator, the general public, and the environment. These requirements may include, but are not limited to, maximum application rates, using only specified application methods and equipment, application only under specified weather conditions, prohibition of any pesticide drift to neighboring properties that causes health or environmental harm, and, in the case of restricted use pesticides, allowing use only by or under the direct supervision of certified pesticide applicators. Pesticide labels contain specific instructions such as what the pesticide may be used on, how much of the pesticide may be used, how often the pesticide can be used, and worker protection requirements. Federal Law states that the pesticide label is the law, and that use of the pesticide that is not in conformance with the label is a violation of Federal Law and may result in fines and/or imprisonment.

This bill increases pesticide licensing fees, modifies authorized uses for the pesticide use revolving fund, and appropriates funds for various pesticide related positions and activities. We support this bill as it provides additional non-general fund revenue to enhance the ability of the State Department of Agriculture and the U.H. College of Tropical Agriculture & Human Resources to monitor and regulate pesticide use throughout the State of Hawaii. In that pesticide distribution, sales, and use are presently heavily regulated at both the Federal and State levels of government, the establishment of new positions for an environmental toxicologist and pesticide extension specialist along with additional appropriations for certification activities, compliance monitoring, electronic data collection, educational materials, integrated management technologies, and pesticide disposal will further strengthen the State's pesticide oversight and enforcement capabilities. The capacity to effectively assess and address pesticide issues along with providing additional technical resources and expertise to pesticide regulators will also be enhanced. Thus, we believe that this bill will further protect and safeguard employees, the general public, and the environment from negative impacts resulting from improper pesticide use.

Based on the foregoing, we respectfully request your favorable consideration on this bill. Thank you for the opportunity to testify.

BASF Plant Science and BASF Corporation (collectively "BASF") support the concepts in HB 504, namely providing additional resources to the HDOA to a) continue and expand their assessment of products and their uses to ensure the health of the environment and Hawaiians, and b) provide training opportunities related to pesticide and plant biotechnology products to users and the general public.

The United States Environmental Protection Agency (EPA) has stringent requirements for all pesticides that are used in the U.S. Dozens of studies are submitted for review that address each pesticide's effects on human health and the environment, not just on the targeted pest or weed. Pesticides are only authorized if the EPA determines they are safe. A second tier of review is conducted at the state level, and the HDOA is acutely aware of specific issues in Hawaii that must be addressed before a pesticide is registered for use in the state. The HDOA also has regulatory and legal tools at its disposal to address public concerns about pesticide applications and uses, including regular on-site inspections by the HDOA Pesticide Branch to ensure compliance with regulatory requirements.

Moreover, the labels for pesticide products provide adequate instructions for safe and responsible use. Pesticide labels rely on the many scientific studies conducted by the pesticide manufacturer and reviewed by the EPA to determine the guidelines that dictate the safe application and use of the product. Buffer zones, requirements for wind speed during application, the restriction of pesticide application during certain weather events, and groundwater restrictions are just some of the many aspects that are addressed on the label.

BASF believes the state should focus on providing additional educational and training resources to the HDOA, applicators, growers and the general public so they can better understand and use those innovative tools to make farming in Hawaii more productive and sustainable.

Chair Choy, Vice Chair Ichiyama, and Members of the Committee:

The Chamber of Commerce of Hawaii ("The Chamber") **supports** HB 504 HD1, which increases the pesticide licensing fee and amends authorized uses for the Pesticide Use Revolving Fund. Further requires memorandum of understanding between the Department of Agriculture and the University of Hawaii College of Tropical Agriculture and Human Resources regarding the expenditure of funds from the Pesticide Use Revolving Fund. Also establishes an environmental toxicologist position and pesticide extension specialist and appropriates funds from the Pesticide Use Revolving Fund.

Aloha Chair Choy, Vice Chair Ichiyama, and Members of the Committee:

I am Christopher Manfredi, President of the Hawaii Farm Bureau Federation (HFB). Organized since 1948, the HFBF is comprised of 1,932 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

HFB is in strong support of HB 504 HD 1, which increases the technical and outreach capacity of the Pesticides Branch at the Hawaii Department of Agriculture and UH-College of Tropical Agriculture. It also provides a funding mechanism to address correct disposal of unused pesticides.

During the last year, several questions have been raised surrounding the agricultural use of pesticides. Pesticides are not only used in agriculture, but in many areas of our daily lives, including, but not limited to homes, businesses, schools, parks, roadways, swimming pools, forests and watersheds. Improper use in any of these arenas can result in harm, much like an improper dosage of medicine can be harmful. When used properly, pesticides are valuable tools that can protect humans, pets, livestock, wildlife, crops as well as the environment.

Over time, the capacity of the HDOA and CTAHR has been reduced. This has eroded their ability to provide accurate and timely information to policymakers and the public.

Two positions are key in this bill. One is a new position for an environmental toxicologist in HDOA. The other is a pesticide extension specialist. Furthermore, the measure provides for education and training in partnership with UH CTAHR. Other important and worthy elements of the measure include:

- (1) Registration and technical review;
- (2) <u>Certification, including certification of restricted</u> use pesticides or experimental use pesticides;
- (3) Compliance monitoring activities;
- (4) Development of an electronic data collection system for all required pesticide reporting;
- (5) Personnel costs, including the hiring of necessary <u>staff;</u>
- (6) Development of pesticide-related educational materials in conjunction with the University of Hawaii college of tropical agriculture and human resources;
- (7) Demonstration trials in conjunction with the University of Hawaii college of tropical agriculture and human resources cooperative extension service agents to develop integrated management and drift management technologies; and
- (8) <u>A pesticide disposal program.</u>

HFB supports this proactive approach to pesticide regulations, outreach, education and funding thereof, and encourages you to do the same.

Chair Choy and Members of the Committee:

I am Tim Lyons, Executive Director of the Hawaii Pest Control Association and we support the intent of this bill but feel it needs some major changes.

We think it important to note that it is not only agriculture and agricultural enterprises that are regulated under Chapter 149A. It is also the structural pest control operators and its industry and we are quite different not only in practices but also in the scope of business operations. In fact, many of the pest control operators are one (1) or two (2) man shows as opposed to large companies.

Our first problem appears in Section 2 of the bill which not only increases the license fee from \$75.00 to \$310.00 but also changes that from a three (3) year renewal period to an annual

period so instead of paying \$75.00 for a three (3) year period (which previously was \$25.00), the manufacturer will pay \$930.00 over a three (3) year period. Additionally, we are not sure of the wisdom in making it an every year renewal period. The administrative cost may outweigh the benefit of perhaps a two (2) year renewal period.

Secondly, we also disagree with Section 3 which enumerates the items that the money can be used for, one of which is compliance monitoring activities. If we refer back to the beginning of the bill in Section 2 we note language that allows for the fees to be increased or decreased by the rule. It is our feeling that if compliance and monitoring expenses are taken from this fund, there is entirely too much of an incentive for government to raise the fees too frequently or not in proportion. Compliance monitoring should come out of the state budget and be lined itemed like other expenses of the Department of Agriculture.

We also have a problem with number six (6) which calls for the development of pesticide related educational materials and while we are actually fully supportive of expenditures in that regard, we find that there is no definition or guidance given as to what are educational materials.

In item 7 we see that expenses can also be incurred in order to "develop integrated management and drift management technologies" and while again, we have no problem with that, we think it should specifically state "Integrated Pest Management" which has actually been mandated for schools. Perhaps one of our biggest objections is to the deletion of language in 149A-13.5(b) which is a clause that we specifically requested based on our fears of being overshadowed by larger agricultural interests. The language that is in the current law says that the money in the fund will be used for training workshops, educational programs and other services specifically for the structural pest control industry and further that it must be "expended in a manner that appropriately addresses the needs of each category of pesticide user". With this language deleted we are fearful that once again we will be overshadowed by larger agricultural concerns and, therefore, we would specifically request the retention of that language. *Note: Reference to that language is also being deleted in (e)(1).*

Lastly, although H.D. 1 has taken out all of the appropriation amounts, we would like to note for the record that the original bill provided for specific dollar amounts that someone had in mind. We find it rather shocking that Section 14, which is the section regarding integrated management, had only a proposed \$300,000.00. Considering that integrated pest management has been mandated for use in all the schools and considering the furor that pesticides has taken over the last couple of years, we would think it would be the one thing that many people could agree on from both sides of the fence regarding pesticides. Integrated pest management is a concept that features the least toxic approach and given the difficulty of implementing integrated pest management we would think it should take the bulk of the money that is generated. Again, in Section 13, it talks about money for pesticide related educational materials but we don't know what they are and Section 11 dedicates some money for compliance monitoring expenses which we do not think should come out of this fund but rather the general fund. Again, we are not opposed to the overall concept of this bill, we just think that the structural pest control industry has by and large been ignored and we don't think that is fair.

The Nature Conservancy of Hawai'i is a private non-profit conservation organization dedicated to the preservation of the lands and waters upon which life in these islands depends. The Conservancy has helped to protect nearly 200,000 acres of natural lands in Hawai'i. Today, we actively manage more than 35,000 acres in 11 nature preserves on Maui, Hawai'i, Moloka'i, Lāna'i, and Kaua'i. We also work closely with government agencies, private parties and communities on cooperative land and marine management projects.

The Nature Conservancy supports H.B. 504 and its proposal to increase pesticide licensing fees for the purpose of enhancing pesticide training, education, management, data collection, monitoring, and disposal programs within the Department of Agriculture and the UH College of Tropical Agriculture and Human Resources.

Invasive weeds, insects, diseases, snakes, and other pests are one of the greatest threats to Hawaii's economy, agriculture, natural environment, and the health and lifestyle of its people. With favorable conditions and limited competition, non-native species arrive in the Hawaiian Islands to find an easy environment in which to thrive.

Properly used, pesticides are an important tool in protecting Hawaii's globally unique native habitats and species, many of which are federally listed as endangered, from the grave threat of invasive species. Integrated pest management and a variety of tools are employed for pest control in conservation work. Mechanical control alone of many established weeds like Miconia, Albizia, Australian tree fern, and others often proves impractical and environmentally damaging in terms of soil disturbance and loss of non-target covers. Pesticide applications for this type of weed control generally use very small volumes of active ingredient with extremely high-precision. Even so, it's critical that pesticide use comes with proper training, application, data management, monitoring, and controls. We think H.B. 504 helps provide important resources for these purposes.

Aloha Chair Choy, Vice Chair Ichiyama, and members of the Committee,

My name is Bennette Misalucha, Executive Director of the Hawaii Crop Improvement Association and HCIA strongly supports HB 504 which will expand the capacity of the State Department of Agriculture Pesticide Branch to help address public concerns about pesticide use in Hawaii.

Although pesticides are used throughout the world and in Hawaii to control disease carriers such as mosquitoes, ticks, and rodents; in our drinking water to prevent disease; in our homes to prevent destruction by termites, and in our watersheds to control invasive species, public attention and concern has recently focused on pesticides that are used on Hawaii's farms to control weeds, insect infestation, and diseases that can completely destroy a crop.

Our member companies are very aware of their responsibility to use pesticides properly and they take this duty very seriously. They use trained employees who are experienced in pesticide application and who apply them only when necessary. The safety of our employees and the community is of utmost importance to us and we follow the strict federal and State pesticide laws and regulations carefully. We are regularly inspected by the State Department of Agriculture Pesticide Branch whose duty is to enforce these laws.

Although we have confidence in the ability of the DOA to enforce pesticide laws and to ensure that the public is protected, we also recognize that increased funding and capacity will strengthen the Department and help it address community concerns. We support that mission.

Funding for the expanded role of the Pesticides Branch would be provided through an increase in State pesticide licensing fees rather than drawing from the general fund. The temporary expansion of the use of the licensing fee fund 5 years ago has proven to be beneficial to the Department's operation and this bill would further expand its use, and make it permanent. With this increased funding and authority, the Pesticide Branch can broaden its scope to include numerous new programs to ensure that pesticides are used properly.

Concerns about pesticide drift and exposure would be evaluated by a qualified environmental toxicologist who would work in conjunction with the State Department of Health toxicologist to make recommendations on health issues related to pesticides. Other valuable provisions in the bill include a pesticide extension specialist position within the University of Hawaii CTAHR who would develop educational materials and work with the DOA environmental toxicologist. A program for the disposal of unused or unwanted pesticides would also be funded. This is especially important for small farmers who may not have the funds to send unwanted materials to the mainland.

HOUSE BILL NO. 504 HD 1 RELATING TO PESTICIDES

Chairperson Choy and Members of the Committee:

Thank you for the opportunity to testify on House Bill 504 HD 1. This bill increases the pesticide licensing fee and amends authorized uses for moneys in the Pesticide Use Revolving Fund. The bill also establishes an environmental toxicologist position within the Department and requires a memorandum of understanding between the Department and the University of Hawaii College of Tropical Agriculture and Human Resources. The Department supports the intent of the bill and has some suggested amendments.

There has been an increased dialogue surrounding pesticide use in Hawaii and the call for greater scrutiny and regulation. The Department also wishes to increase its ability to educate and regulate the public regarding the proper use of pesticides and hence has requested four new positions for these efforts within our Pesticides Branch. These positions have been approved and are currently part of the Administration's budget.

The Department is supportive of numerous aspects of this bill including the creation of an environmental toxicologist position within the Department and also the creation of a pesticide disposal program. However, there are aspects of the bill that we would like to have further discussion about and to work with the committee to create a bill that would satisfy all parties involved. As such, we are working on suggestions for amended language and look forward to further collaboration on this bill.

We support a funding increase to for additional positions at the State Department of Agriculture and the University of Hawaii to increase understanding of pesticides and their uses. We do not object to a reasonable price increase in registration fees. And while it sounds good to those who may be unfamiliar with the process to go through the registration process every year is easier said than done. It is important for the committee to understand that registration is an arduous task that entails a tremendous amount of work. It would be a great hardship, and perhaps impossible for some, to undertake this process every year.

We suggest that the bill be amended to maintain the current three-year interval for registration. Current licensing processes have been effective for renewal of product licenses.
