HOUSE BILL NO. 504 RELATING TO PESTICIDES

Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to testify on House Bill 504. This bill increases the pesticide licensing fee and amends authorized uses for moneys in the Pesticide Use Revolving Fund. The bill also establishes an environmental toxicologist position within the Department and requires a memorandum of understanding between the Department and the University of Hawaii College of Tropical Agriculture and Human Resources. The Department supports the intent of the bill and has some suggested amendments.

There has been an increased dialogue surrounding pesticide use in Hawaii and the call for greater scrutiny and regulation. The Department also wishes to increase its ability to educate and regulate the public regarding the proper use of pesticides and hence has requested four new positions for these efforts within our Pesticides Branch. These positions have been approved and are currently part of the Administration's budget.

The Department is supportive of numerous aspects of this bill including the creation of an environmental toxicologist position within the Department and also the creation of a pesticide disposal program. However, there are aspects of the bill that we would like to have further discussion about and to work with the committee to create a bill that would satisfy all parties involved. As such, we are working on suggestions for amended language and look forward to further collaboration on this bill.

Chair Tsuji and Members of the House Committee on Agriculture:

I am Paul Oshiro, testifying on behalf of Alexander & Baldwin, Inc. (A&B) and its agricultural company Hawaiian Commercial & Sugar Company on HB 504, A BILL FOR AN ACT RELATING TO PESTICIDES. We support this bill.

Pesticide use in Hawaii is extensively regulated by both the Federal Environmental Protection Agency and the State Department of Agriculture under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) and the Hawaii Pesticide Law (Chapter 149A, HRS). Depending upon the pesticide and its intended use, the EPA and the State impose mandatory conditions and requirements that are science based and designed to protect the pesticide applicator, the general public, and the environment. These requirements may include, but are not limited to, maximum application rates, using only specified application methods and equipment, application only under specified weather conditions, prohibition of any pesticide drift to neighboring properties that causes health or environmental harm, and, in the case of restricted use pesticides, allowing use only by or under the direct supervision of certified pesticide applicators. Pesticide labels contain specific instructions such as what the pesticide may be used on, how much of the pesticide may be used, how often the pesticide can be used, and worker protection requirements. Federal Law states that the pesticide label is the law, and that use of the pesticide that is not in conformance with the label is a violation of Federal Law and may result in fines and/or imprisonment.

This bill increases pesticide licensing fees, modifies authorized uses for the pesticide use revolving fund, and appropriates funds for various pesticide related positions and activities. We support this bill as it provides additional non-general fund revenue to enhance the ability of the State Department of Agriculture and the U.H. College of Tropical Agriculture & Human Resources to monitor and regulate pesticide use throughout the State of Hawaii. In that pesticide distribution, sales, and use are presently heavily regulated at both the Federal and State levels of government, the establishment of new positions for an environmental toxicologist and pesticide extension specialist along with additional appropriations for certification activities, compliance monitoring, electronic data collection, educational materials, integrated management technologies, and pesticide disposal will further strengthen the State's pesticide oversight and enforcement capabilities. The capacity to effectively assess and address pesticide issues along with providing additional technical resources and expertise to pesticide regulators will also be enhanced. Thus, we believe that this bill will further protect and safeguard employees, the general public, and the environment from negative impacts resulting from improper pesticide use.

Based on the foregoing, we respectfully request your favorable consideration on this bill. Thank you for the opportunity to testify.

Aloha Chair Tsuji, Vice Chair Onishi, and members of the Committee,

My name is Bennette Misalucha, Executive Director of the Hawaii Crop Improvement Association and HCIA strongly supports HB 504 which will expand the capacity of the State Department of Agriculture Pesticide Branch to help address public concerns about pesticide use in Hawaii.

Although pesticides are used throughout the world and in Hawaii to control disease carriers such as mosquitoes, ticks, and rodents; in our drinking water to prevent disease; in our homes to prevent destruction by termites, and in our watersheds to control invasive species, public attention and concern has recently focused on pesticides that are used on Hawaii's farms to control weeds, insect infestation, and diseases that can completely destroy a crop.

Our member companies are very aware of their responsibility to use pesticides properly and they take this duty very seriously. They use trained employees who are experienced in pesticide application and who apply them only when necessary. The safety of our employees and the community is of utmost importance to us and we follow the strict federal and State pesticide laws and regulations carefully. We are regularly inspected by the State Department of Agriculture Pesticide Branch whose duty is to enforce these laws.

Although we have confidence in the ability of the DOA to enforce pesticide laws and to ensure that the public is protected, we also recognize that increased funding and capacity will strengthen the Department and help it address community concerns. We support that mission.

Funding for the expanded role of the Pesticides Branch would be provided through an increase in State pesticide licensing fees rather than drawing from the general fund. The temporary expansion of the use of the licensing fee fund 5 years ago has proven to be beneficial to the Department's operation and this bill would further expand its use, and make it permanent. With this increased funding and authority, the Pesticide Branch can broaden its scope to include numerous new programs to ensure that pesticides are used properly.

Concerns about pesticide drift and exposure would be evaluated by a qualified environmental toxicologist who would work in conjunction with the State Department of Health toxicologist to make recommendations on health issues related to pesticides. Other valuable provisions in the bill include a pesticide extension specialist position within the University of Hawaii CTAHR who would develop educational materials and work with the DOA environmental toxicologist. A program for the disposal of unused or unwanted pesticides would also be funded. This is especially important for small farmers who may not have the funds to send unwanted materials to the mainland.

Aloha Chair Tsuji, Vice Chair Onishi, and Members of the Committee:

I am Christopher Manfredi, President of the Hawaii Farm Bureau Federation (HFB). Organized since 1948, the HFBF is comprised of 1,932 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

HFB is in strong support of HB 504, which increases the technical and outreach capacity of the Pesticides Branch at the Hawaii Department of Agriculture and UH-College of Tropical Agriculture. It also provides a funding mechanism to address correct disposal of unused pesticides.

During the last year, several questions have been raised surrounding the agricultural use of pesticides. Pesticides are not only used in agriculture, but in many areas of our daily lives, including, but not limited to homes, businesses, schools, parks, roadways, swimming pools, forests and watersheds. Improper use in any of these arenas can result in harm, much like an improper dosage of medicine can be harmful. When used properly, pesticides are valuable tools that can protect humans, pets, livestock, wildlife, crops as well as the environment.

Over time, the capacity of the HDOA and CTAHR has been reduced. This has eroded their ability to provide accurate and timely information to policymakers and the public.

Two positions are key in this bill. One is a new position for an environmental toxicologist in HDOA. The other is a pesticide extension specialist. Furthermore, the measure provides for education and training in partnership with UH CTAHR. Other important and worthy elements of the measure include:

- (1) Registration and technical review;
- (2) <u>Certification, including certification of restricted</u> use pesticides or experimental use pesticides;
- (3) Compliance monitoring activities;
- (4) Development of an electronic data collection system for all required pesticide reporting;
- (5) Personnel costs, including the hiring of necessary <u>staff;</u>
- (6) Development of pesticide-related educational materials in conjunction with the University of Hawaii college of tropical agriculture and human resources;
- (7) Demonstration trials in conjunction with the University of Hawaii college of tropical agriculture and human resources cooperative extension service agents to develop integrated management and drift management technologies; and
- (8) <u>A pesticide disposal program.</u>

HFB supports this proactive approach to pesticide regulations, outreach, education and funding thereof, and encourages you to do the same.

Thank you for the opportunity to comment on House Bill 504, a proposal to increase pesticide registration fees to support the Department of Agriculture pesticide registration functions.

Products CSPA represents include disinfectants that kill germs in homes, hospitals and restaurants; candles, and fragrances and air fresheners that eliminate odors; pest management products for home, garden and pets; cleaning products and polishes for use throughout the home and institutions; products used to protect and improve the performance and appearance of automobiles; aerosol products and a host of other products used every day. Through its product stewardship program, Product Care[®], and scientific and business-to-business endeavors, CSPA provides its members a platform to effectively address issues regarding the health, safety and sustainability of their products.

Consumer protection and health benefit products include disinfectants, sanitizers, germicides, antibacterial products, and insect and rodent control products. While there may be appropriate justification of a fee increase to support the Department's registration activities, and the identified uses may be worthwhile, we encourage a discussion of the current financial needs of the Department and the identified uses of any such increase to ensure the amount of the fee is appropriate and not in excess of the needs of the Department and identified uses equally benefit all pesticide registrants. In addition, we believe the current triennial registration period remains functional and request that the registration period not be reduced.

We support a funding increase to for additional positions at the State Department of Agriculture and the University of Hawaii to increase understanding of pesticides and their uses. We do not object to a reasonable price increase in registration fees. And while it sounds good to those who may be unfamiliar with the process to go through the registration process every year is easier said than done. It is important for the committee to understand that registration is an arduous task that entails a tremendous amount of work on both the state and the registrant as there are thousands of products.
