House Bill 50 proposes to provide protections against retroactive regulation and lawsuits and prevents claims against shooting range operators and individuals engaging in target shooting. **The Department of Land and Natural Resources (Department) supports this measure.**

The Department is actively engaged in shooting range development in the State and finds this measure to complement and promote such development. Similarly, the Department is committed to ensuring that all current and future shooting range development is compliant with Federal regulations, State statutes, and County ordinances.

The Department also recognizes the importance, safety value, and educational role that established shooting ranges serve as legal places where target shooters, hunters, law enforcement, and the general public can practice and safely discharge their firearms.

Maintaining shooting ranges in accordance with existing laws is a prudent way to ensure economical and safe firearm practices.

The economical impact of shooting ranges is also significant and not only supports a recreational and right of the people, but also supports the largest fund for wildlife conservation across the country. The Pittman-Robertson Act of 1937 is a federal tax on firearm sales, ammunition, and archery equipment. Annually over 500 million dollars are raised through this Act. Hawaii is currently apportioned a little over 3 million dollars annually from this Act that goes toward wildlife conservation projects throughout the state.

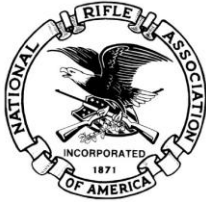

TESTIMONY IN SUPPORT OF HB 50, RELATING TO SHOOTING RANGE PROTECTION

My name is Richard Hoeflinger. I am President of On Target, Inc., a nonprofit organization supporting safe shooting sports in Hawaii. On Target is working with DLNR to develop a shooting range on the Island of Hawaii, which currently lacks any safe, legal, and publicly accessible place for instruction and practice in safe and responsible pistol and rifle target shooting.

Over the past 12 years, range design criteria were established, potential locations were evaluated, and gunfire sound assessment tests were conducted at the selected site. It is estimated that over \$1 Million in federal grant funding and in-kind volunteer service has been invested in the project to date. It is expected that development will continue with additional state, federal, and private funding sources.

Due diligence will have been performed prior to initiation of range construction. It is imperative that the investment be protected from criminal and civil penalties regarding claims of noise, nuisance, and frivolous negligence executed after construction and operation of the shooting range. On Target, Inc. respectfully requests the Water & Land Committee to support HB 50.
