HAEYC **supports** HB 607, assuring that Neighbor Island counties of Hawai'i, Maui, and Kaua'i each have representatives that serve 3 year terms on the Early Learning Advisory Board. Maui County has demonstrated its commitment to early childhood education by establishing an Early Childhood Resource Coordinator position, and HAEYC encourages Hawai'i and Kaua'i Counties to consider the establishment of similar positions in their counties.

Equitable Neighbor Island representation is important in order to assure that all keiki and their 'ohana have equitable access to important early childhood services, care, and education.

# HB607 Relating to Early Learning

Dear Chair Luke, Vice-chair Nishimoto and Committee Members:

Thank you for this opportunity to offer testimony in support of HB 607, Relating to Early Learning. My name is Robert G. Peters and I currently serve as the Chair of the Early Learning Advisory Board (ELAB).

On behalf of the ELAB, I am submitting this testimony urging the committee to approve of HB607 which provides for each Neighbor Island county to be represented on the Early Learning Advisory Board for a term of office of three years. It also includes funding to support their participation.

Currently only two Neighbor Island members serve on the ELAB and the Board feels having representation from all three would enhance our understanding of needs and how best to help support each. We know that each of our Islands is unique and has distinct characteristics that need to be considered as we continue our efforts to build a state-wide early childhood system. Having representation from each Island would make this process more inclusive and comprehensive.

The ELAB strongly supports this measure.
