#### Chair Yamane and Members of the Committee:

The Attorney General has comments on this bill.

As introduced and passed by the Committee on Agriculture, this bill authorizes the issuance of \$45,000,000 in special purpose revenue bonds (SPRBs) for a myriad of projects of Waimea Nui Development Corporation. The bill does not currently specify which part of chapter 39A, Hawaii Revised Statutes (HRS), will be identified to authorize issuance of the bonds.

The projects are generally described in the bill as related to planning, acquisition, and construction of agriculture, renewable energy, and educational facilities, including bioenergy systems, micro-grid, agricultural processing facilities, water systems, agriculture infrastructure, equestrian and livestock facilities, aquaculture facilities, and agriculture-related education facilities.

Article VII, section 12, of the Hawaii State Constitution describes seven categories for which SPRBs may be issued: (1) manufacturing, processing, or industrial enterprises; (2) utilities serving the general public; (3) health care facilities provided to the general public by not-for-profit corporations; (4) early childhood education and care facilities provided to the general public by not-for-profit corporations; (5) low and moderate income government housing programs; (6) not-for-profit private nonsectarian and sectarian elementary schools, secondary schools, colleges and universities; and (7) agricultural enterprises.

This constitutional provision is implemented by chapter 39A, HRS. Chapter 39A is divided into multiple parts describing the various types of SPRBs, and each type has its own specific requirements. For example, section 39A-191, HRS, defines a project party for the issuance of SPRBs to assist utilities serving the general public in providing electric energy or gas, in relevant part, as follows: "an electric or gas utility serving the general public and that is regulated by the public utilities commission under chapter 269." For purposes of SPRBs issued to assist agricultural enterprises, section 39A-311, HRS, defines a project as "any combination of land, buildings, and other improvements thereon, including without limitation irrigation system and infrastructure, for use of, or for, or to assist an agricultural enterprise." Section 39A-251, HRS, defines a project party for purposes of SPRBs to assist not-for-profit private nonsectarian and sectarian elementary schools, secondary schools, colleges and universities serving the general public as "a not-for-profit private nonsectarian and sectarian elementary school, secondary school, college, and university that serves the general public."

Thus, the Legislature needs to carefully consider the types of projects and the nature of the project party when making its determination on what type of SPRBs to authorize in order to satisfy the requirements of the Hawaii State Constitution and chapter 39A, HRS.

HB 608: Waimea Nui Community Development Corporation Special Purpose Revenue Bond Request Overview

#### NOTE:

Chair Clift Tsuji on the Committee on Agriculture noted that the applicable part of Chapter 39A was not identified. In the Bill, part "X" (Roman numeral 10) was not added in by the Committee on Agriculture as an amendment to the bill to identify the area of Chapter 39A, HRS. I am respectfully requesting the bill be amended to add in the part "X" to the Bill 608

The Waimea Nui Community Development Corporation (WNCDC) is a Native Hawaiian 501(c)3 operating in the South Kohala district of Hawai'i Island. WNCDC has developed a comprehensive agriculture and renewable energy enterprise, open to the entire Kohala region that directly contributes to the State's economy and security through local food and energy production. The enterprise is designed to be self-sufficient and to create small business opportunity for regional partners.

The Waimea Nui Community Development Corporation Agriculture and Energy Enterprise is designed to revitalize the South and North Kohala's long history of agriculture by developing a comprehensive complex encompassing all of the facilities needed to support a robust agriculture economy. The enterprise builds on a 3 year mentoring program which has, to date, established 34 new small farms to build agriculture related economic engines. Further WNCDC, in partnership with HDOA, will begin construction of a \$3.5M/30 acre Community Agriculture Park later this year.

The primary complex facilities are to be sited on Hawaiian Homelands as these lands are centrally located in the region, but are being constructed by the Homestead on behalf of all of the residents of the regions communities. The facilities will support existing farmers, ranchers and businesses as well as incentivizing new entrepreneurs to start businesses.

The enterprise will include the following facilities and components;

- 1. Renewable Energy Generation facilities to include an Anaerobic Digester
  - a. Creates low cost power for all of the facilities
  - b. Provides environmentally sound conversion of organic waste to energy and fertilizers.
- 2. Micro-grid
- 3. Renewable Energy Systems to create local fuel production
- 4. Additional greenhouses to support small farms at the Waimea Nui Community Agriculture Park
- 5. Post-Harvest Facility and Commercial Kitchen
- 6. Equestrian Center/County Livestock Fairgrounds
- 7. Health Center to support improving wellness and nutrition in the community
- 8. Agriculture and Energy UH-Hilo supported Education Center/Business Center
  - a. Inclusive of Distance Learning, Community Sustainability Science and Social Model, and Agriculture Field program facilities
- 9. Chill/Cut/Wrap Facility with Mobile Slaughter Support Dock
- 10. Water purification facility to support new Food Safety Certification requirements

- 11. Crushing/Feed Mill for fish, cattle, swine and poultry feeds
- 12. Agriculture/Aquaculture facilities coordinated with Kohala Institute
- 13. Irrigation and Water Infrastructure
- 14. Supporting Road and Parking Infrastructure

The enterprise has been designed through a 4 year process that began with a series of beneficiary consultations on the Waimea Homestead, and has built on this foundation through strong partnerships with USDA, HDOA, DHHL, OHA, UH and DLIR along with many private organizations and individuals from across the region.

The Waimea region has the land and resources to significantly impact the State's food and energy security through agriculture, aquaculture, ranching and energy production. In addition, the full complex will support at least 500 direct, 600 indirect living wage jobs, and over 250 new small businesses and farms by 2020.

By 2020, the WNCDC Enterprise will create products to include

- 1) Aquaculture facility producing up to 6,400,000 lbs per year
- 2) Produce production of over by 1,000,000 lbs per year
- 3) 500,000 lbs per year of value added products
- 4) Process 1,000,000 lbs of specialty meats
- 5) Produce 175,000 kg/year of hydrogen
- 6) Rental/membership fees from all facilities
- 7) Revenue from a crushing mill that supports up to
  - a. 8,000,000 lbs per year of Feed production
  - b. 40,000 tons of energy biomass pellets for use in fuel and electricity generation
  - c. 100,000 gallons of sunflower cooking oil
  - d. 250,000 gallons of sunflower energy oil
- 8) Excess electricity sales of 4,500,000 kwh

Total Revenue Potential: \$31.5M per year by 2020 with expected margins of 18% and net

revenues of no less than \$5.7M per year.

Debt Service: Bond issuance at 6.5% for 30 years would require annual repayment of

\$3.5M. The conservative net revenues and can cover the debt service.

DBEDT and DOA have developed the "Increase Food Security and Food Self-sufficiency Strategy", which the enterprise directly supports the strategies pillars of;

- 1. "Support multi-functional food hub facilities to handle aggregation, processing, treatment and distribution."
- 2. "To increase production of locally grown foods, improve agricultural infrastructure including agricultural parks, irrigation systems and distribution systems/facilities."
- 3. "Build partnerships with the increasing number of organizations involved in food self-sufficiency/food security."

Aloha Chair Yamane, Vice Chair Cullen, and members of the Committee,

The Hawai'i Alliance for Community-Based Economic Development (HACBED) strongly supports HB 608, which authorizes the issuance of special purpose revenue bonds up to \$45,000,000 to Waimea Nui Community Development Corporation (WNCDC).

HACBED was established in 1992 as a nonprofit statewide intermediary to address social, economic, and environmental justice concerns through community-based economic development and asset building strategies. HACBED has been fortunate to work with Hawaiian homestead associations and organizations across the state in partnership with the Department of Hawaiian Home Lands to provide capacity building support, such as part of the Kūlia i ka Nu'u program. Over time we have worked with WNCDC who greatly contributed to our efforts to develop an economic development strategy that would lead to further investments on and adjacent to Hawaiian homestead communities for the Hawaiii State Office of Planning and the Economic Development Administration. WNCDC is working with a clear vision to carry out economic development projects that are place-based and culturally-grounded to benefit the entire South Kohala community. As such, HACBED strongly supports the proposed bill, which would support the planning, acquisition, and construction of agriculture, renewable energy, and educational facilities.

HB 608 supports a homestead beneficiary organization that is leading the way for the native Hawaiian people in the development of their self-sufficiency and self-determination efforts and has created an outstanding model of sustainability. WNCDC's project will serve as a catalyst for economic development that is culturally grounded and based in the values of this place -- Hawai'i.
