Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to testify on House Bill 627. This bill establishes a farm to school program within the Department of Agriculture and creates a coordinator position within the Department and within the Department of Education. The Department supports the intent of this measure provided it does not adversely affect the priorities in the Administration's budget.

The Department believes in the potential of the school food network to greatly increase the amount of locally-grown fruits and vegetables that are procured within the state and has participated in a number of task forces and working groups surrounding this topic that reported to the legislature including: a report to the 2012 Legislature resulting from House Concurrent Resolution 167 (2011) and a report to the 2010 Legislature per Senate Concurrent Resolution 121 (2009). The Department continues to be an advocate for increased consumption of local agricultural commodities and would point to a recommendation from the most recent report to the 2012 Legislature that advocated exempting local produce from the procurement code for state institutions as an action step that can be taken.

The Department would also defer to the Department of Education as to the creation of a position within their department.

Aloha Chair Tsuji, Vice Chair Onishi, and Members of the Committee:

I am Christopher Manfredi, President of the Hawaii Farm Bureau Federation (HFB). Organized since 1948, HFB is comprised of 1,932 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

HFB supports HB 627, which seeks to establish the Hawaii Farm to School Program and two farm to school coordinator positions.

HFB strongly supports increased use of locally grown agricultural products, fruits, vegetables, meats, dairy and poultry products in our schools and other public institutions. This will truly be a significant step towards increasing our levels of self-sufficiency. HFB also believes that learning where food comes from is an important part of our children's education. Agriculture education involves more than just learning the basics of food production, it provides the opportunity for our children to understand and appreciate the importance of agriculture.

Many formal and informal studies have been done addressing farm to school programs and we understand the Department of Agriculture (DOA) has also done some work in this area in the past. Our farmers and ranchers have tried to work with the procurement system and can speak to the shortcomings of the system. For example, supplying a school or schools within a geographic area is feasible, but providing to the entire school system is not. Focus should now be on working with the procurement system to make institutional markets accessible while considering the capacity of farmers and ranchers in Hawaii. Assistance to farmers on how to navigate the system should be a priority. HFB recognizes the need and importance of agricultural education and school farm programs, and as a farm organization we would like to see increased emphasis of agriculture in schools. We believe that school farms serve multiple purposes. They serve not only to educate students on how to grow crops but also what it takes to turn a farm into a successful business enterprise that can be a career choice. Agronomy, economics, science, business planning, entomology, pathology and various technologies including programming, navigation and robotics are some of the courses that can evolve around the farm. Programs that teach the principles behind good agricultural practices - steps that must be taken that protect the environment, product, and worker are critical components of a school farm. The purpose of the farm should be to educate and expose students to a career choice.

Developing and maintaining an agricultural workforce should be a vital component of this program. A trained workforce with various skills is necessary to any agricultural operation. This need has to be addressed along with generating interest in our youth to pursue the various careers and to become our future leaders in Hawaii agriculture. HFB supports programs and initiatives such as the FFA, 4-H, and Farm to School programs because they help to educate and reconnect our children with agriculture. Through agricultural education programs, our children will gain an understanding and appreciation for agriculture which will result in healthier eating habits, stronger support for Hawaii's agriculture industry and will contribute to Hawaii's food security.

This should be viewed is an investment in Hawaii's future to develop well-informed consumers and supporters of our local agricultural industries.

Personal Testimony in Favor of HB 627, with reservations

Chair Tsuji, Vice Chair Onishi and members of the committee

My name is Douglas L. Vincent and I am a Professor and Animal Scientist in the College of Tropical Agriculture and Human Resources in the Department of Human Nutrition, Food and Animal Sciences. I am also a former Department Chair. I am pleased to provide personal testimony on HB 627. This testimony does not represent the position of the University of Hawaii or the College of Tropical Agriculture and Human Resources.

As the Department Chair of the Department of Human Nutrition Food and Animal Science, in 2010 I was the lead author of the University of Hawaii report on the feasibility of a Hawaii Farm-to-School Program (SCR121 SD1 HD1 Session 2009). At that time, the report recommended that establishing a state-wide Farm-to-School program was not feasible. Much has changed since then and through the efforts of many non-profit organizations such as Kokua Hawaii Foundation, Kohala Center and others, school gardens and farm to school programs have developed at individual schools. These programs do provide food and nutrition education to our keiki and have been successful on a limited basis at individual schools. While I believe it is a good idea and should be encouraged, I remain concerned that the issues brought forth in the 2010 feasibility study produced for the 2010 Hawaii State Legislature still exist. Issues such as equity in the provision of foodstuffs to schools, assurance of food safety regulations and remaining in compliance with USDA national school lunch program standards be adhered to. While I support the concept enthusiastically, if the positions of farm to school coordinators are funded, they must tread carefully, tempering any unbridled enthusiasm, to ensure that the program does not increase the risk to our keiki. HB627: RELATING TO A FARM TO SCHOOL PROGRAM

Chair Tsuji, Vice Chair Onishi, and Members of the Committee,

The Hawai'i Farm to School and School Garden Hui strongly supports HB627, which establishes a farm to school program and coordinator positions in the Hawai'i Departments of Agriculture and Education.

Formed in 2010, the Hawai'i Farm to School and School Garden Hui is a grassroots network of six island-level networks, along with representatives of the Hawai'i Departments of Education and Health, whose mission is to strengthen Hawai'i's statewide farm to school and school garden movement.

The Hawai'i Farm to School and School Garden Hui, along with the Farm to School Plus Working Group convened by Senator Suzanne Chun Oakland, have identified the measure in question as an essential next step in realizing for our state the profound benefits of farm to school in the areas of agriculture, education, health, and the economy. Nineteen other states have already lead the way in this effort by establishing state-level farm to school coordinators in their departments of agriculture, education, and/or university systems.

The proposed coordinators would plan and work strategically together to achieve a robust and successful farm to school program for Hawai'i:

The Kōkua Hawai'i Foundation is a 501(c)3 non-profit organization founded in 2003 by Jack and Kim Johnson. We support environmental education in the schools and communities of Hawai'i. Our programs include 'ĀINA In Schools, 3R's School Recycling, Kōkua Hawai'i Foundation Field Trip Grants, Kōkua Hawai'i Foundation Mini-Grants, and Plastic Free Hawai'i.

'ĀINA In Schools is a farm to school initiative launched in 2006 that connects children to their local land, waters, and food to grow a healthier Hawai' i. In addition to encouraging the use of locally grown fruits and vegetables in school meals and snacks, the program includes a standards-based nutrition, garden, and compost curriculum that empowers children to grow their own food, make informed food decisions, and reduce waste. 'ĀINA In Schools also promotes field trips to local farms, chef cooking demonstrations in classrooms, as well as waste reduction, garden, and cooking educational opportunities for families and community members. We work directly with 16 O'ahu elementary schools that have implemented the program school-wide. We have also trained an additional 146 educators from nearly 100 schools from across the state in the use of our 'ĀINA garden, composting, and nutrition curricula.

Over the last eight years, we have made great strides in the realm of school gardens and nutrition education. However, procurement of locally grown produce for school meals has been especially challenging. Establishing a state-level Farm to School program will bring a level of expertise and commitment that will bring local food sourcing and food and agriculture education into schools statewide. The Farm to School program will further bolster the reach and impact of the garden and nutrition educational programs that have been implemented by non-profit organizations across the state.

We support Hawai'i in becoming the 20th state that has state-level Farm to School Programs. These 19 states with state-level Farm to School Programs have seen great increases in the amount of locally grown food served in schools and positive health, behavioral, and economic impacts of their programs. Please see the attached document from the National Farm to School Network, "The Benefits of Farm to School" for specific examples and statistics on how a farm to school programs benefit students, schools, and local economies.
