Title of Bill: HB 0692 RELATING TO CROWDFUNDING.

Purpose of Bill: Authorizes DOE to use crowdfunding to fund specific capital improvement projects. Establishes the school capital improvement project crowdfunding special fund. Defines crowdfunding.

Department's Position:

The Department of Education (DOE) supports this bill. Crowdfunding represents a potential funding source that is not currently utilized. Although the funding potential of crowdfunding remains uncertain, the DOE believes that the provisions of this bill provide for a framework in which to effectively utilize crowdfunding should it prove beneficial.

For an example of the possibilities that this measure could perhaps represent, if you have a Facebook account, you are encouraged to view the "Humans of New York" (HONY) Facebook page where an inspiring example of crowdfunding is occurring for a school in Brooklyn. RELATING TO CROWDFUNDING

House Bill No. 692 proposes to establish within the State treasury the "School Capital Improvement Project Crowdfunding Special Fund" to assist with paying all or part of specific capital improvement projects within the Department of Education (DOE).

While the Department of Budget and Finance does not take any position on establishing the "School Capital Improvement Project Crowdfunding Special Fund," as a matter of general policy, the department does not support the creation of special funds which do not meet the requirements of Section 37-52.3, Hawaii Revised Statutes. Special or revolving funds should: 1) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries of the program; 2) provide an appropriate means of financing for the program or activity; and 3) demonstrate the capacity to be financially self-sustaining. In regards to House Bill No. 692, it is difficult to determine whether the special fund will be self-sustaining. In addition, the bill does not make an appropriation to allow the DOE to expend the funds within the proposed "School Capital Improvement Project Crowdfunding Special Fund."
