Dear Honorable Chair McKelvey, Vice-Chair Woodson and Committee Members,

The Hawaiian Humane Society strongly supports the intent of HB 702, which is intended to strengthen the cruelty to animal law at it pertains to dogs. However, we have several concerns regarding the language as written:

- Some of the provisions in this legislation may be in conflict with dog licensing requirements at the county level.
- Section 711-1109 (b)(i) is confusing and may be interpreted incorrectly.
- We do not agree with section 711-1109 (b)(ii), which states that an owner could be found guilty of violation even if the person was not responsible for the cause of the animal cruelty.

As a result, the bill's current language may discourage people from having their dogs licensed. We would be happy to work with the committee to provide specific amendments to strengthen the bill and to address some of our concerns.

I am in strong support of HB702, a bill that would require dog owners to notify appropriate authorities when transferring ownership of a dog. This Act will also hold dog owners accountable for abandonment and other acts of animal cruelty that often go unpunished. I am asking for your support on the bill.

I have worked at Animal House Veterinary Center in Ewa Beach for the past two years and have been in the veterinary field since 2001 and sadly I see these dogs on almost a daily basis. Most of the dogs are reunited with their loving owners and have a happy ending, but not all of them.

Hope is just one of the many that did not have a happy ending. I have attached Hope's pictures below; the first day she came into the clinic and the larger picture was the day she died.

Hope was my eye opener to just how terrible our system failed such a beautiful girl. Hope arrived in our clinic in January 2013 and died just 62 days later. I was fortunate enough to spend almost every one of those days with her. I was there the day she was brought in and with her the day she died; I made a promise to her, as I kissed her good-bye, to not let her death go unheard.

Hope was found abandoned in Nanakuli. Hope was emaciated, bruised, covered in ticks, infected ears from a botched ear cropping and in extreme poor health. She spent 62 days in our hospital and ultimately died from her previous lack of

care. Hope did have a microchip when she was found, however, the registered owner on the microchip stated that they had sold her but did not know whom they sold her to.

Hope's owner was never located and no one was ever held accountable for the neglect and suffering she endured.

This is a story we see and hear far to often here in Hawaii.

This Act will help to prevent cruelty cases like Hope's from falling through the cracks. This Act will also help us to reunite dogs with their owners in a timelier manner.

For Hope's sake and the many other dogs in situations similar to hers, I urge the committee to please support HB702.

My name is Gary Novosel and I am the President of Raw Dog Hawai'i.

I strongly desire your support for HB 702, which will make it criminal act of withholding of proper sustenance from and abuse to animals, the requirement to provide information for the transfer of dog ownership, and to make mandatory and provide the existence and update of pets' microchip identification. It is important that the law be applicable to any person in ownership of an animal and the party responsible FOR the transfer of that animal to a person or persons.

I have worked in the animal industry for 15 years and have seen the atrocities inflicted upon animals.

Personally, I have seen dogs tied to fences without food or water, victims of coordinated dog fighting using bait dogs, dogs that have been starved, beaten and neglected. Allowing these acts to continue directly translate into future abuses of animals as well as humans. Allowing this behavior to continue teaches our children this type of behavior is acceptable and subsequently perpetuates it.

The impact on our children is devastating and directly causes additional costs financially to our state. There is a proven correlation between animal abuses to the future human abuses and subsequent incarcerations because of these individuals.

I have attached to this testimony a sample of the peered reviewed scientific research that proves these facts.

I humbly offer, through my experience and knowledge to act as a resource should the legislators or staff have questions, require direct assistance or need additional information.

My name is Emily Roberson, and I would like to express to the Consumer Protection & Commerce Committee my **strong support** for HB702, also known as Hope's Law. I am testifying as an individual citizen.

HB 702 extends criminal liability to the owner of a dog that has been deprived of sustenance, requires persons holding a dog license to provide notification if ownership of the dog is transferred, and requires persons holding a dog license to provide microchip information.

I believe very strongly that we have a desperate need for stronger laws to protect the animals of Hawaii. However, even if you are not convinced that Hawaii's companion animals are in need of stronger laws to protect them, you should support this law in order to support children, women, families, and everyone else that makes up the State of Hawaii. I have worked in public health, and specifically maternal and child health, for over 10 years. The intersection between animal cruelty and issues such as child abuse and neglect, and family and intimate partner violence have been well studied and thoroughly documented for years. When animals in a home are abused or neglected, it is a warning sign that others in the household may not be safe. Also, children who witness animal abuse are at a greater risk of becoming abusers of both humans and animals themselves. Both of these facts underscore that we as a community need to be taking animal abuse and neglect seriously. However, Hawaii's current animal cruelty laws are woefully insufficient.

Animal protection laws are a reflection of how a society feels about its weakest and most vulnerable members. Please show the people of Hawaii that we as a state will protect and care for our most vulnerable by passing HB702.

#### Aloha,

My name is Valerie Taylor and I reside in Oahu, Hawaii with my Active Duty spouse, Michael Shackleford. We were stationed here in July 2012, and since being on island we have volunteered with several organizations including the Hawaiian Humane Society, to foster and care for preadoptive animals (dogs, cats, bunnies, birds...you name it!).

As a recently named Armed Forces Insurance, Military Spouse of the Year, representing US Coast Guard, District 14, I strongly advocate for the rights of all animals, especially those which are abandoned, neglected, maltreated and/or abused.

I urge your support of H.B.702/S.B.1301 – Hope's Law! This law would provide a requirement for the continued registration of all microchips, ensuring a way to track the ownership of those animals lost, abused, or left behind. Hope's Law will extend criminal liability to owners of a dog that has proven to have been abused or abandoned. Hope's Law will also require the registered microchip holder to transfer the microchip when gifting, transferring, selling, and/or rehoming a dog. Failing to do so will carry criminal liability, if the dog is found to be abandoned, abused, had bitten a child/adult or caused property damage.

On October 31, 2014, I came across a post on a social medial site containing a photo and brief description of a dog that had been brought into a local vet clinic for emergency treatment after a 'hit and run'. I reached out to the author of the post, only to find out days later -after dozens of messages back and forth - that the injured fox terrier had no microchip, collar, tag or license, and no way to identify her or her owners without someone coming forward. The pup was estimated to be between 2 and 4 years old; she was malnourished, extremely timid and showed obvious signs (mentally and physically) of being in an abusive and neglectful environment. The Animal House Vet Center took her in, treated her injuries, including removing her left eye as a result of the accident. The owners were eventually identified, and former neighbors confirmed the dog was abandoned when the owners moved to a different location. This poor girl had been on the streets for a very long time, with no home, no love and no safe haven. The staff at Animal House Vet Center took amazing care of her, covering her expenses for surgery, vaccinations, and treatment for tick-borne diseases. After becoming so involved in her story, I offered to foster the pup during healing. We met for the first time on November 10th, where I witnessed a very scared, highly anxious and emotional dog with no confidence whatsoever. A few days later, when she was well enough for release. I brought her home to join our Chihuahua, Pepe' and Maltipoo, Bella. Within a few hours, I knew she was right where she belonged, and I vowed to do whatever it took to ensure she lived the happiest, healthiest and most loving life possible. In honor of Thanksgiving and because of her trials and tribulations of the

past, we named her Ginger Grace (Pure, Lively, and unmerited favor of God), and she is now a permanent member of our family 'pack'. Despite her unfortunate circumstances, she is very loving and wants nothing more than to be loved in return.

I share this story because had Hope's Law been in effect, her owners could have been held criminally liable for the condition in which she was found – by a stranger, who witnessed a car hit her, then drive off. We already hold owners responsible for the actions of their pets, and we already have laws in place against animal cruelty. So, why not enact a law that supports what is already in place, by making it easier to track animal ownership and prove responsibility.

My name is Maria Olipas. I am an avid animal lover and pet owner.

I urge you to support H.B. 702 and S.B. 1301 which will help lost animals find their way home and legally connect animals with their rightful owners. I am in strong support of these bills because the microchip is what brought my lost dog home after five years of being gone.

My dog managed to get out of my yard. After accepting that he was not coming home, I got a call from a Humane Society officer five years later claiming she had my dog. I nearly fell out of my chair. We live in Village Park in Waipahu. My dog was found in Mililani Mauka with a different name and address on his collar from what was on the chip. Because he was legally registered and chipped to me, the information on the dog collar was irrelevant. I cannot begin to express the joy it was to bring him home to my children.

This bill will impact our community positively by providing the following:

-Allowing all pets to be tracked and accounted for;

-Lessening the amount of stray, lost, and euthanized animals due to overcrowding or financial hardship of the shelter(s);

-Keep pet owners accountable for their animals

As pet owners, our choice to home them is our responsibility. If we fail to provide for them, the animal suffers while the pet owner is free to repeat their behavior. There are no repercussions for their neglect and abuse towards their pet(s). This law would help prevent animal abuse and neglect and hold all pet owners accountable for the well being and safety of their pets. For those that have lost their pets, it will make it easier to find them and bring them home.

My name is Jae Bonarek, and I would like to express to the Consumer Protection & Commerce Committee my **strong support** for HB702, also known as Hope's Law. I am testifying as an individual citizen who has encountered many dogs, in various situations, who had microchips that did not have current owner information.

It is in my experience as a community member and as a first-responder volunteer with K9 Kokua, that too many dogs are deprived of sustenance and the owner(s) go about their normal life without any penalties. A few years ago, the group I volunteer for was contacted about a female dog that was dumped at Kea'au Beach Park and needed immediate vet care. When we got there, the female dog (later dubbed Moxy), smelt of decaying flesh, her bones on her rear right foot were completely exposed and she had many other wounds, old and new, littering her body. When we got her into our vet, there was nothing that could have been done for Moxy. Her body suffered too much trauma, due to wounds consistent with dog fighting, and this was verified with 3 dog fighting vet experts. Like Hope, Moxy was microchipped, but due to the laws that are in place now, any person(s) can say that they sold, gifted, lost, etc., and no one is required to transfer their dog's microchip info to the next person. This was just one of many of my first-hand experiences with a dog that was microchipped to someone that claimed to no longer have possession of the dog.

I believe by protecting our dogs, we can better protect our communities. Please feel free to contact me if you have any questions.

Please pass HB702 and show Hawaii that's this is where we start fighting for the voiceless.

Testimony in Opposition of HB 702

February 7, 2015

Rep. McKelvey and members of the House Committee on Consumer Protection & Commerce:

The Pacific Pet Alliance is a Hawai'i non-profit organization that promotes responsible pet ownership through education and advocacy.

We respectfully request that you not pass HB 702. Our position does present a dilemma because the Pacific Pet Alliance recognizes that K9 Kokua does wonderful work in the community for "houseless dogs" and filling the gaps in caring for animals whose owners have fallen upon hard times.

From an animal welfare view point, microchipping an animal serves a valuable purpose of reuniting lost animals with their owners. Many breeders prefer to chip an entire litter in their name prior to sale. We do this because we have a responsibility to that animal that we brought in to this world. Should the new owner renege on their contract (breeders require to be contacted first) and surrender an animal to a shelter or rescue the breeder will be contacted and can take custody of the animal. We are concerned that this bill might discourage microchipping.

Currently the practice of microchipping an animal is voluntary and available at a nominal cost to the pet owner. PPA is concerned that the unintended consequence of this bill would extend criminal and civil liabilities to innocent people and provide incentive not to microchip an animal. Paperwork errors will make criminals of innocent people who have not physically harmed or neglected animals. Their only "crime" is that they did not follow up with the new owner to ensure the chip registration was changed.

This bill also extends criminal liability to the owner of a dog that has been deprived of sustenance. Again, innocent people could be charged with animal cruelty in the second degree over failure to comply with paperwork.

While the spirit of "Hope's Law" is well meaning, its passage would have the potential to hurt too many innocent people and not have effect that its supporters want.

The Pacific Pet Alliance respectfully requests that this committee not pass this bill.

# SUBECT: SUPPORT FOR HB702, also known as Hope's Law.

# Aloha,

My name is Kale Lyman and I am submitting my testimony as an individual. I am the Sr. Volunteer and a Main Beach Crew member of K9 Kokua and have witnessed many scenarios involving a dog and how current information on a microchip can make the difference in proper identification. There is a large population of people who own dogs in Hawaii and many of them have microchips. Many of these microchips hold incorrect or out-dated information. Dog license tags can come off and during my years of volunteering, I have known of situations where a dog's collar and license tag is stolen to be placed on another dog. You cannot steal a microchip and it cannot get lost. The existing form for a dog licensing has a designated box for microchips to be included on record. All other counties allow the microchip to also be included in their systems records.

HB702 will have no impact on county licensing regulations. There will be no need for additional forms to be created or additional positions. No tax-payer dollars will be used when HB702 is passed! It is meant to help the authorities to strengthen their cases when it comes to the abused, abandonment and neglect of dogs.

HB702 places the responsibility solely on a dog owner to keep their dog's microchip info current. Just like selling/gifting a car in Hawaii, the owner has a certain number of days to submit the transfer or possibly be liable if anything occurs with the car while it was out of the owner's possession. HB702 will also help to increase the revenue for each county as more people will need to acquire their dog's license when registering the microchip number.

During my years of experience and work in the community, I have been a first-responder to many cruelty cases where dogs had a microchip and realize that HB702 is a real-life solution. I humbly urge you to pass HB702 on Monday.

Up to date chip information allows us to contact owners to receive treatment authority, in cases of abuse or neglect it allows not only the veterinary community but law enforcement information in legal cases. Animal abuse will only be conquered if our legislative leaders have the fortitude to put laws in place that hold pet owners, pet shops, and dealers accountable for the life of that animal. That is why we are here today about HB702 Hope's Law. Hope had a microchip but when the owner was contacted he said he had sold her but didn't not know whom he sold her to. Hope was found on the side of the road in Nanakuli half alive. I knew Hope personally and I visited her every chance I had. I would sit with her and love on her to prove that not all people are bad all I could see was sadness in her eyes but some how I could see a glow in her eyes of relief and trust. Sadly, hope died of neglect and internal organ failure had this law been in place when hope was found the owner on her microchip could've been held accountable and charged and we could've given

hope justice. This last Saturday I happened to be on a road in Nanakuli where I ride my horses; and I came across a dog that had been placed in a bag on the side of the road. It was very disturbing. She was also a pit bull who appeared to have just had puppies or was still pregnant and there were scars all over her body. On Sunday morning I went back to the area where the dog was found and I walked down a little and came across many bags each bag had animal remains. We counted over 40 sets of remains most of them were dogs. We scanned them all but were unsuccessful probably due to the stage of decomposition. This is why we need your support to make micro-chipping a must and to always update your information when you move or rehome your dog. Had Hope's law already been in place these dogs would've been micro-chipped, owners could've been contacted and a cruelty case opened against them if they were found to be negligent. So please give us your support in HB702 Hope's Law. Thank you for your time.
