The Department of Business, Economic Development and Tourism (DBEDT) offers the following comments on HB800 which seeks to transfer the State Foundation on Culture and the Arts from the Department of Accounting and General Services (DAGS) to DBEDT.

Our department values the economic and quality of life contributions of our creative sectors make to the overall health of our state. Culture and arts play a pivotal role in the identity of our destination for visitors, as well as contribute greatly to our growing creative economy. In 2013, these sectors represented \$3.4 Billion of the State's GDP; 4.5% of the State's total GDP.

Through establishment of DBEDT's Creative Industries Division (CID) in 2003, we have actively supported the business development of the creative sectors, launching programs such as Creative Lab, which is a key facet of our HI Growth Initiative.

As such, the department believes there are synergies between CID and SFCA and to that end, have worked with SFCA leadership to identify several collaborative projects to share expertise, resources and a collective vision under a proposed Memorandum of Understanding (MOU) between our departments.

We welcome the continued dialogue with the Legislature, DAGS, SFCA leadership, staff and its Board of Commissioners, as we fully explore the best ways in which to collaboratively strengthen Hawaii's arts, culture and all creative sectors, resulting in a thriving creative economy for the state.

Chair Cachola, Vice Chair Ito and members of the committee, I am Jonathan Johnson, Executive Director of the State Foundation on Culture and the Arts, and I am pleased to offer testimony on H. B. 800.

The SFCA welcomes discussion on departmental placement and recommends deferral of this legislation until more research relative to the impact on furthering culture and the arts in Hawaii can be addressed.

The State Foundation on Culture and the Arts (SFCA) was established by the legislature as an institution to provide education and access to culture and arts for the people of Hawaii. This was in response to a congressional initiative to designate an agency within each state to promote, perpetuate and preserve culture and the arts unique to the conditions of each state.

The intent of the Creative Industries section of the Department of Business, Economic Development and Tourism (DBEDT) is to foster economic development of the creative economy to ensure its success.

Education, access and economics all are necessary in sustaining a vibrant culture and arts community, yet proposing to move one to the other under the current legislation provides no framework for success greater than what exists today. HB 800 does not provide reasons for the transfer. Neither does it provide projected benefits for the public, each department, nor the agencies involved. The SFCA maintains that prior to considering moving, dialogue needs to be initiated among the SFCA board, between DAGS and DBEDT, between Creative Industries and the State Foundation, and between the SFCA and the public. There are many questions that need to be addressed prior to proposing a transfer, such as the impact to the public, Federal grant eligibility and access to funding under the jurisdiction of both the SFCA and DBEDT.

The SFCA and Creative Industries are brainstorming ways of working together without moving. We have identified ways to collaborate that will capitalize on each other's strengths without compromising either entities priorities, setting the stage to further culture and the arts for the people of Hawaii. We are confident, given the opportunity to partner on initiatives, culture and the arts in Hawaii will be stronger.

Thank you for the opportunity to testify on this matter.

I am in strong opposition to your intentions to place the State Foundation on Culture and the Arts within the Department of Business Economic Development and Tourism. The SFCA has had a difficult past few years, but it appears to be based on its oversight rather than it's placement within the government.

SFCA has been a thriving arts entity for close to 50 years with programs, grants, direct services, and support reaching to the arts community on every island. A quick review of one program, recent biennium grantees in 2015 includes over sixty varied visual, performing, cultural, and historic organizations, large and small, with funds received from \$1,000 - \$14,000 reaching out to local communities on every island.

I believe the composition of the SFCA Board and its Board Chair should be addressed, rather than where the organization is placed. This proposed move feels like "throwing the baby out with the bath water." Time to have an honest review within the organization to address the recent audit and recent public concerns, but it starts with Commission members, not the displacement of the organization.

There are many reasons I oppose this bill.

I'm so upset about the way HB 800 has been submitted and how it has been handled. The public, the art community, and the supporters of the SFCA have not been told about this bill. With such an unreasonably short time given to the public, the Hawaii State's art community have not been given enough time to review the bill. This bill needs to have more than thorough explanation why relocation of the SFCA is needed.

In my opinion, the current SFCA and the staff are well experienced and competent. I feel it they could use more support and help but not changing the whole vision into something else. Rather than move the agency, what they need is to have is more support than ever before.

I have appreciated the integrity of the museum and its program that is one of the most important cultural asset we have where indigenous culture have been exhibited and appreciated and shared with visitors. It is a unique institution in Asia Pacific. This bill to move SFCA and pubic art program and acquisition program seems like it would be unproductive and more an unexplained political operation underneath of all.

If so, we would like to know the detailed vision and plans. These issues need to be clarified before the Bill HB 800 should be considered.

Unfortunately, in my view, the public and the art community have not have time to review the bill. It is so disrespectful for the person who comes up with this bill. The bill has not been handled in a way that SFCA and their supporters, the art community and public have been given enough time to review this bill.
