TESTIMONY BY KANOE MARGOL INTERIM EXECUTIVE DIRECTOR, EMPLOYEES' RETIREMENT SYSTEM STATE OF HAWAII

TO THE HOUSE COMMITTEE ON LABOR AND PUBLIC EMPLOYMENT ON HOUSE BILL NO. 85

FEBRUARY 10, 2015, 9:00 A.M.

RELATING TO DISABILITY RETIREMENT

Chair Nakashima, Vice Chair Keohokalole and Members of the Committee,

H.B. 85, proposes to amend sections 88-75, 88-79, 88-284, 88-334, and 88-336, Hawaii Revised Statutes, to allow retirants receiving service retirement benefits to retroactively claim for ordinary and/or service-connected disability retirement for up to two years after their retirement.

Currently, a member (with 10 years of service) may file for ordinary disability retirement, or for service-connected disability retirement (without a minimum number of years of service), at the time the member files for service retirement. They may file for all three applications if they choose to do so. If disability and service retirement applications are filed prior to retirement, retirants may receive service retirement benefits while their disability applications are being processed, and will be retroactively adjusted upon approval of the application.

H.B. 85 proposes the following:

- It allows retirants to file for ordinary disability retirement. The current requirement is that a member be "in service" or "on leave without pay."
- It allows applicants to file for service-connected disability within two years from the date of retirement. The current statutes require that the application for service-connected disability be filed within two years of the later of: (1) the date of the accident; or (2) when workers' compensation benefits cease.

The Administrative and Legislative Committee of the Board of Trustees of the Employees' Retirement System (ERS) recommends opposition to this proposal as it provides benefit enhancements, and would therefore violate section 88-99, HRS, which places a moratorium on any benefit enhancements until the actuarial value of the ERS' assets are 100% of its accrued liability – or until the ERS is fully funded.

ERS staff also has technical and operational concerns with respect to this bill.
