Department's Position:

The Department of Education (Department) appreciates the intent of HB 861 to provide students with diabetes with care during school and respectfully suggests that the recommended provisions of this measure are unnecessary.

Department of Health (DOH) Public Health Nurses (PHNs) receive training in diabetes care. The PHNs work with schools in crafting an individualized diabetes care plan and deliver training to teachers and staff regarding a student's plan.

Contracted nursing care is available for students with diabetes who are unable to provide self-care during the school day, and every effort is made for the service to be provided at the student's geographic area school.

The student's 504 Plan provides accommodations to meet the student's needs as determined by the 504 Team, and also provides the non-discrimination protections of Section 504 and addresses administrative complaints. Hawaii Administrative Rule Chapter 61 ensures the Department's implementation of Section 504.

Further, the Department has worked together with the DOH and the American Diabetes Association in improving systems and communication between all parties regarding the care and support of students with diabetes.

Testimony by Hawaii Government Employees Association February 11, 2015

H.B. 861 - RELATING TO HEALTH

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO supports H.B. 861 *with* amendments.

H.B. 861 requires the Department of Education (DOE) to provide care to students with diabetes pursuant to the student's diabetes medical management plan. However, as written the measure does not hold the DOE accountable for the consistent and proper implementation of this commitment.

The resources and capacity of schools and its staff vary within the State of Hawaii. The contextual differences of each school, each staff member, each community and each child must be taken into consideration when such a commitment is made by the DOE. As such, the DOE must be held accountable especially when it comes to the health and welfare of our children.

Therefore, to insure that this measure is implemented with fidelity and consistently at every school, we ask that this measure be amended in its entirety to 1) require the DOE to provide the resources and personnel to each school that does not have three volunteers; 2) require that the DOE be responsible for training that will meet all health and legal requirements; and 3) require that the DOE be responsible for responding to parents on issues of compliance regarding this measure.

Our children are the most important resource we have and we support the commitment being made in this measure to provide care to children in need. However, the varying capacity and resources of each school is a reality that cannot be ignored. Therefore, the responsibility of the DOE to be held accountable to every child in need must be clear in the language of this measure.

H.B. 861 requires the Department of Education (DOE) to provide care to students with diabetes pursuant to the student's diabetes medical management plan. However, as written the measure does not hold the DOE accountable for the consistent and proper implementation of this commitment.

The resources and capacity of schools and its staff vary within the State of Hawaii. The contextual differences of each school, each staff member, each community and each child must be taken into consideration when such a commitment is made by the DOE. As such, the DOE must be held accountable especially when it comes to the health and welfare of our children.

Therefore, to insure that this measure is implemented with fidelity and consistently at every school, we ask that this measure be amended in its entirety to 1) require the DOE to provide the resources and personnel to each school that does not have three volunteers; 2) require that the DOE be responsible for training that will meet all health and legal requirements; and 3) require that the DOE be responsible for responding to parents on issues of compliance regarding this measure.

Our children are the most important resource we have and we support the commitment being made in this measure to provide care to children in need. However, the varying capacity and resources of each school is a reality that cannot be ignored. Therefore, the responsibility of the DOE to be held accountable to every child in need must be clear in the language of this measure.

I write today for BOTH of my young sons that have type 1 diabetes, to ask for your support in the passage of **HB861** that will protect the rights, health, and the education of our children in Hawaii schools who have diabetes.

• The ADA has identified gaps in diabetes care provided by Hawaii schools, and we are concerned about the unfair treatment many children with diabetes face at school due to inadequate care and untrained staff.

• These gaps place many students with diabetes in an unsafe medical environment and prevent them from participating fully in the classroom or school-sponsored activities.

• **HB861** follows the approach that most states have taken in addressing such challenges by, allowing non-medical school personnel to volunteer to be trained to provide routine diabetes care to students, and by allowing students who are able to do so to self-manage their diabetes in the classroom or at school-sponsored events.

I strongly believe **HB861** is medically safe and necessary to ensure students with diabetes receive the appropriate care and are provided access to supplies they need provided during those times when a health aide, nurse, or contract nurse is not available for daily routine diabetes care.
