The Department of Transportation **supports the intent** of this resolution, however construction of the Leeward Bikeway is not anticipated to begin in 2016. There are several environmental requirements outstanding including Section 106, anticipated Section 4(f), and NEPA clearances, in addition to utility agreements with the Hawaii Gas Company and the Hawaii Independent Energy LLC. The final design will need to incorporate any changes necessary as a result of the clearances and utility agreements.

Based on our current schedule, the project is anticipated to be advertised in the summer of 2017, with construction to begin in late 2017 or early 2018.

Aloha e Chair Inouye and Vice-Chair Gabbard:

The Trust for Public Land strongly supports HC 199/HCR 169 requesting the Department of Transportation to Begin Construction on the Leeward Bikeway in 2016.

The Trust for Public Land is working with the Blue Planet Foundation, the National Park Service, the Hawai'i Community Development Authority, and other community organizations to implement the over 80 year vision of connecting Diamond Head (Le'ahi) to West O'ahu via a multi-use waterfront path (also known as the Lei of Green or Lei of Parks concept). Different portions of the path are in different stages of planning and development. The Leeward Bike Path is a critical portion of the overall, connected vision of a South Shore waterfront multi-use path that would provide tremendous recreation, fitness, health, transportation, art/culture, beautification, and community building opportunities along the path.

The Leeward Bike Path was planned and promised to the West O'ahu community in 1980 – 36 years ago. Funding is available for the construction of the path, and has been since 1995 – over 20 years ago. This path could a tremendous asset to the community for recreation, exercise, and an alternative transportation method for getting to work or going to school.

The State Outdoor Recreation Plan (2015) surveyed thousands of people in the State regarding their recreation needs – respondents to the survey reported using walking paths, tracks or sidewalks most frequently, and emphasized the need for more bike and pedestrian paths. We urge the Senate to send a strong message to DOT to spend previously appropriated funds (including federal funds) allocated for this project and fulfill the vision of the Leeward Bike Path, a key element and connector for West O'ahu to what many groups hope will be a larger connected South Shore Multi-Use Path or Lei of Green/Lei of Parks.

Thank you for the opportunity to offer testimony in **SUPPORT** of HCR 169, requesting the Department of Transportation to begin construction of the Leeward Bikeway in 2016.

The Hawaii Public Health Institute (HIPHI) supports and promotes policy efforts to create a healthy Hawaii. As a hub for health, HIPHI As a hub for health, HIPHI serves as a convener amongst community leaders to promote and advance collaboration and innovation in public health and work towards making Hawaii the healthiest place on earth.

Bikeways are a valuable component of Complete Streets that improves a community's quality of life. Improving conditions for bicycling and walking in Hawai'i is vital for our health. HIPHI supports the Complete Streets law (Bill 26) passed by the Honolulu City Council in 2012. Because of Complete Streets, our youth and elderly are able to safely cross the street, get around without a car, go for a walk, spend time outdoors, walk to schools and food markets, and enjoy public spaces and parks. Complete Streets can benefit all communities by accommodating everyone in the public that use multiple forms of transportation, improve safety, promoting better health, creating stronger economies, providing more choices, and helping out the environment.¹

Hawai'i is ranked as the most dangerous State for Pedestrians ages 65 and older".

According to a report in 2014, Hawai'i was ranked first in pedestrian deaths among residents ages 65+. Our kupuna population are the most vulnerable to motor vehicle – pedestrian crashes compromising 47% of the total victims and dramatically increased fatality rates across the oldest age groups.^{III} Among these, 80% of the individuals that were hit were in the 65+ group occurred on O'ahu.

HCR 169 would not only reduce pedestrian and cycling fatalities and injuries but also allow hundreds of people to bike or walk for some of their short trips and thus obtain daily healthful exercise. More walking and cycling would yield further public health benefits by reducing the use of automobiles, thus diminishing air and noise pollution and the overall level of traffic danger.

Testimony to the Senate Committee on Transportation and Energy Tuesday, April 5, 2016

Regarding HR119 and HCR169 Requesting the Department of Transportation to Begin Construction on the Leeward Bikeway Before the End of 2016

Aloha Chair Inouye, Vice Chair Gabbard, and esteemed members of Committee on Transportation and Energy,

Hawaii Bicycling League **strongly supports HCR169** requesting that the DOT begin construction on the Leeward Bikeway in 2016.

The Leeward Bikeway has been promised since 1980, 36 years ago. Funding was made available in 1995, 21 years ago. People from Nanakuli, Kapolei, Ewa, and Waipahu are waiting for this off-road multi-use path to be built as an alternative way to get to work, exercise, and recreate.

The Hawaii Bicycling League has made starting construction on the Leeward Bikeway in 2016 our priority project. We are committing our time and asking others in the community to make it their priority also. Our members have a target to raise \$60,000 in private donations to hire community outreach staff to inform Leeward Oahu residents and community organizations about the project's status and gain community support for this important project that will enable people to save money, get exercise, and fight global warming while going to work instead of being stuck in traffic, wasting time and gas. This multi-use path will complement the rail system and enable more people non-motorized access to rail stations.

At the SR 95 and SCR128 hearing, DOT testified that the estimated construction start is late 2017. The project does indeed have some last hurdles to clear, most significantly the National Historic Preservation Act Section 106 requirements that are already underway. However, based on our involvement in the project, including in the Section 106 process, we believe that if the remaining items are expedited that construction can begin significantly earlier than the 2017 date.

We urge the Senate Transportation and Energy Committee to pass this resolution and send a strong message that all Oahu wants this multi-use path built now and that DOT should do everything they can to expedite the project.

Aloha,

My name is Reef Amano and I work for Leeward Community College. I am also a cyclist that commutes regularly to and from work from Ewa Beach to our campus in Pearl City. I have been waiting for the construction of the Leeward Bikeway since I was a college student attending Leeward. Now I am close to retirement age and still waiting for the construction to begin on this project.

Nearly everyday during my commute from Ewa through Waipahu, I have sketchy encounters with cars, trucks and buses as I bike along Farrington Highway. Sometimes it is downright scary and dangerous and I wonder why the planned Leeward Bikeway is taking so long to build especially since everyone seems to want it, there is funding for it and it is a safety issue. The number one reason I always hear from my friends and coworkers why they don't ride a bicycle anywhere is that the roads are too dangerous. Many of them said if they had a safe cycling route to where they need to go, they would ride it now.

At Leeward Community College where I work, we serve 8,000 students. Many of them come from the Leeward side of the island including Waipahu, Ewa, Kapolei and the Waianae coast. Many of them cannot afford to drive so they have to catch a bus or carpool with someone. Building the Leeward Bikeway will provide an economical, healthy, eco-friendly and safe means to get to campus from the west side of the island. To complement the Leeward Bikeway extension, the LCC Connector bike path is underway that will connect Leeward Community College campus directly to the existing Pearl Harbor Bike path further demanding the need for the Leeward Bikeway construction to get started soon.

I urge everyone to help expedite this long overdue project in anyway possible so that pedestrians and cyclists can enjoy this safe and well needed bikeway soon. I hope it can be built before I am too old to ride a bike anymore.

Comments: I support the resolution to begin construction of the Leeward Bikeway as soon as humanly possible. I am a resident of West Loch Fairways in Ewa and have been anticipating connecting the West Loch Shoreline Pathway with the greater Pearl Harbor Historic Trail for more than 20 years. This pathway would offer the Ewa Villages, Ewa by Gentry, West Loch Fairways and West Loch Estate communities a way to safely commute to places east. Having a continuous pathway all the way to Aiea gives people healthy choices on how they might commute to work and school, providing some relief to traffic congestion. The pathway will also provide local families and visitors a place to explore and enjoy the great outdoors. The Betty Nagamine Bliss Memorial Overlook at the Honouliuli National Wildlife Refuge is currently being constructed by the U.S. Fish and Wildlife Service and will undoubtedly become a destination on the pathway. I believe that when the Leeward Bikeway is completed in its entirety, all 18.6 miles, it will become an engine for commerce providing opportunities for new businesses along the pathway including bicycle rental and tour groups.
