#### TO CHAIRPERSON DELLA AU BELATTI AND MEMBERS OF THE COMMITTEE:

Thank you for the opportunity to provide comments on H.C.R. 32.

H.C.R. 32 requests the convening of a task force to examine cancer in the firefighting profession.

The Department of Human Resources Development ("DHRD") has a fiduciary duty to administer the State's self-insured workers' compensation program and its expenditure of public funds. In that regard, DHRD respectfully submits these comments on the resolutions.

As a public employer which is self-insured and self-administered for its workers' compensation liabilities, including those for firefighters employed by the State Department of Transportation, Airports Division, the State has a clear and substantial interest in the matters that the putative task force would examine, including but not limited to: 1) recommendations for revisions to state workers' compensation laws that expedite the delivery of workers' compensation benefits for firefighters diagnosed with

cancer; 2) estimated costs to the State and counties were there to be an increase in workers' compensation benefits for firefighters diagnosed with cancer; and 3) amending or adopting administrative rules that can improve workers' compensation benefits for firefighters diagnosed with cancer. ## REQUESTING THE CONVENING OF A TASK FORCE TO EXAMINE CANCER IN THE FIREFIGHTING PROFESSION

Chair Bellati, Vice Chair Creagan and Members of the Committee,

HCR 32 requests a task force to examine the issues related to cancer in the firefighting profession. The task force will include a representative of the Employees' Retirement System (ERS) and one of its main purposes is to provide recommendations for revisions to the state workers' compensation laws, administrative rules and benefits for firefighters diagnosed with cancer.

As the ERS does not have a role in workers' compensation determinations, the ERS staff has no position on this resolution or to our participation on this task force.

An ancillary connection between workers' compensation and ERS benefits may be that ERS members are required to file for workers' compensation in order to submit a claim for ERS service-connected disability benefits. The approval of workers' compensation benefits, however, does not guarantee that a member will be approved for service-connected disability retirement and does not have any impact on the outcome of the disability application. All disability cases are reviewed by the ERS Medical Board which consists of three physicians. Recommendations by the Medical Board to the ERS Board of Trustees (Board) are based on medical records, reports and interviews with the claimant. Upon review, the Board may decide to approve, deny or remand Medical Board recommendations.



Section 88-79, HRS, provides for service-connected disability benefits for a member who is permanently incapacitated for duty as the natural and proximate result of an accident occurring while in the actual performance of duty or as the cumulative result of an occupational hazard. This section already includes a rebuttable presumption that firefighters, police officers and sewer workers who are permanently incapacitated for duty as a result of any disease of the heart, lungs, or respiratory system, contracted such disease while in the performance of duty and as the result of the inherent occupational hazard of exposure to smoke inhalation, toxic gases, chemical fumes, and other toxic vapors.

These benefits are typically higher than regular retirement benefits and have no minimum age or service requirements. As a word of caution, should the task force recommend legislation to obtain higher ERS benefits with additional cancer presumptive causes, the task force's mandate could result in the enhancement of benefits. This would be contrary to Act 29, Session Laws of Hawaii 2011, which placed a moratorium on retirement benefit enhancements until the ERS becomes fully funded. Any benefit enhancement would increase the ERS' \$8.7 billion unfunded liability, increase employer contributions and would lengthen the period required for the ERS to become fully funded. The ERS Board of Trustees will likely oppose any legislation which provides for enhanced retirement benefits and/or increases the System's unfunded liability.

## HCR 32 REQUESTING THE CONVENING OF A TASK FORCE TO EXAMINE CANCER IN THE FIRE FIGHTING PROFESSION

My name is Robert H. Lee and I am the President of the Hawaii Fire Fighters Association (HFFA), Local 1463, IAFF, AFL-CIO. The HFFA represents approximately 2,100 active-duty professional fire fighters throughout the State. We **SUPPORT** HCR 32, as it relates to the convening of a task force to examine cancer in the firefighting profession.

Thirty-three states and eight Canadian provinces already have cancer presumptive laws that provide fire fighters with medical and service-connected disability benefits. Several studies, as recommended by the International Association of Fire Fighters (IAFF), serve as the basis that demonstrates the growing need for cancer presumptive legislation locally. In addition, despite our fire departments' efforts in improving procedures for cleaning the protective clothing and breathing apparatus, fire fighters are still exposed to carcinogens and toxicants while performing their duties as a study administered in 2014 entitled "Systemic Exposure to PAHs and Benzene in Firefighters Suppressing Controlled Structure Fires" have recently discovered. Such exposure to these carcinogens and toxicants during a fire fighter's career may not result in immediate manifestation of symptoms or cancer diagnosis but instead, years after retirement.

HCR 32 requests the convening of a task force that will examine the issues and make recommendations based on their findings relating to cancer in the firefighting profession. With the ever-increasing number in statistics through research conducted by legitimate, prominent organizations and researchers relating to the risk of cancer as well as infectious diseases and illnesses associated with exposure to patient care and biochemical substances for fire fighters in comparison to the general population, it is important that discussion begins.

HFFA appreciates the Committee's favorable consideration of this measure and ask that you pass HCR 32.
