Catholic Charities Hawai`i (CCH) strongly supports HR 35, Urging United States Citizenship and Immigration Services to Immediately Resume Biometric Intake and Interviews on the Counties of Hawaii, Maui, and Kauai.

CCH is a Board of Immigration Appeals (BIA) recognized agency and has the only three BIA partially accredited staff in the State of Hawai'i, including one accredited staff on the island of Hawai'i. This accreditation allows our non-attorney staff to represent immigrants on legal immigration matters with the U.S. Citizenship & Immigration Services (USCIS), such as Application for Naturalization, Petition for Alien Relative, Deferred Action for Childhood Action, or Change of Status to Permanent Resident.

Our work targets low-income immigrants. One of the barriers to maintaining legal status is cost. In addition to paying for USCIS filing fees, which generally cost several hundred dollars, our neighbor island immigrant clients must pay to travel to Oahu, including air and ground transportation, to complete biometric intake and interviews. This is often a significant barrier that results in immigrants falling out of legal status, or unable to achieve their goal of becoming U.S. citizens.

We support this resolution in order to provide immigrants, who live on the neighbor islands, reasonable access to USCIS-required steps that are necessary to maintain legal status or achieve U.S. citizenship.

Comments: On behalf of the Hawai'i Coalition for Immigrant Rights, the immigration arm of Faith Action for Community Equity (FACE), I would like to thank the Committee for this opportunity to testify. The Coalition strongly supports H.R. 35, which urges U.S. Citizenship and Immigration Services (USCIS) to restore equal access to the immigration process for all Hawai'i residents. In 2007, USCIS discontinued its mobile operations to Hawai'i Island, Kaua'i, and Maui. The lack of basic immigration services outside of Honolulu has a pervasive discriminatory effect on people attempting to access benefits that the agency is adjudicating. Residents are required to travel to Honolulu from their neighbor island homes, at their own expense, in order to undergo USCIS fingerprinting and interviews required to obtain or maintain lawful immigration status. The ability to lawfully work, study, and reside in the United States or secure the highest privilege of our nation's immigration system— citizenship— is essential for access to vital medical services, job security, and political participation. HCIR is the only organization in the state that coordinates policy advocacy to advance immigrant rights. We serve as a partnership platform for over one hundred direct service providers, immigration attorneys, faith leaders, professors, and individual advocates. Through our community work, we have witnessed the discriminatory impact USCIS operating against the reality that our state is a set of islands. USCIS has an obligation to provide a feasible process otherwise its services are meaningless. Thank you.
