#### 1. Origin Compliance Program



A two-year collaborative project encouraged Oregon Christmas tree shippers to comply with Hawaii's pre-treatment procedures



#### 2. Inter-island Compliance

This program allows shippers of agricultural commodities to ship pest free commodities between islands. Shippers who enroll in this program





work closely with the department to implement measures to eradicate, control, reduce, or suppress designated pests such as coqui frog and little fire that have established within the State.
