PURPOSE: S.B. 1018 appropriates funds for providing civil identification cards for

Proper identification is a gateway requirement for an individual to apply for and receive

available government services and benefits, to engage housing and to obtain employment. The

DAVID Y, IGE GOVERNOR lack of proper identification prolongs the time it takes for an applicant to receive available services and benefits. Many homeless individuals routinely cycle through jails and may not have proper identification when they are released. At the time of their release, inmates may not possess the necessary documentary proof to apply for a Hawaii State ID such as evidence of one's legal name, date of birth, social security number, legal presence and proof of principal residence address in the U.S.

Senate Bill 1018 would address this problem by allowing inmates to obtain another form of identification known as a "civil identification card." The "civil identification card" may serve as a temporary measure, if recognized as an official form of state issued identification to apply for benefits, employment and housing.

This testimony is respectfully offered on behalf of the 5,600 Hawai'i individuals living behind bars, always mindful that more than 1,600, and soon to be rising number of Hawai'i individuals who are serving their sentences abroad, thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Native Hawaiians, far from their ancestral lands.

SB 1018 appropriates funds for providing civil identification cards for inmates upon request prior to their release.

Community Alliance on Prisons is in strong support of this common sense measure.

This bill would accomplish promises that have been made since the Lingle administration.

The importance of people having some form of photo identification when they are released from incarceration cannot be overstated.

We have also heard from people working with the houseless that when their clients are arrested and incarcerated, their belongings (including identification) is thrown out. We hope that this is not true, and if it is, we respectfully ask that this practice stop immediately.

We ask the committee to pass this important bill that comports with Hawai`i's reentry plans to facilitate successful transitions from institutional to community life. In this world, it is difficult to do anything without some form of photo identification.
