In consideration of SENATE BILL 1126 RELATING TO FOREST STEWARDSHIP

Senate Bill 1126 proposes to amend Chapter 195F, Hawaii Revised Statutes (HRS), by enabling private landowners and long-term leaseholders on public lands to be eligible for an increased cost-share reimbursement rate for the development of an approved forest stewardship management plan. The Department of Land and Natural Resources (Department) strongly supports this Administration measure.

Senate Bill 1126 seeks to clarify conditions necessary to receive cost-share funds from the State Forest Stewardship Program, as well as increase reimbursement rates for the development of a forest management plan from 50% up to 75%. The proposed amendment will also provide greater involvement from the United States Department of Agriculture through various federal natural resource landowner assistance programs.

With over one-half of the forested area in Hawaii being privately owned or managed, the Department understands the importance of promoting public-private partnerships for the long-term socioeconomic and environmental services that provide public benefits to all. The Forest Stewardship Program provides expert technical and financial assistance to private landowners or long-term leaseholders for the development and implementation of management plans used for sustainable management, protection, or restoration of forested lands. Payments to Program participants are made from the Forest Stewardship Special Fund established pursuant to Section 195F-4, HRS.

Newly established partnerships with the United States Department of Agriculture in Hawaii have enabled more federal cost-share funds to support the implementation of approved forest stewardship management plans. Through modest increased cost-share rates to private landowners for the development of sound forest management plans, the Department hopes to encourage greater program enrollment and participation with federal landowner assistance programs.

Supporting public-private partnerships through the Forest Stewardship Program allows the State to leverage private and federal funds for forest management that benefit the greater public in Hawaii.
