- 1 Fiscal Implications: This measure requests \$6,000,000 for fiscal years 2016 and 2017 to provide
- 2 direct health care for the uninsured and underinsured which takes into consideration the need
- 3 in all counties.
- 4 Department Testimony: The purpose of this Act is to appropriate funds to provide quality, cost-
- 5 effective health care for Hawaii residents who are uninsured, newly uninsured, or
- 6 underinsured.
- 7 The intent of Section 2 is to restore the nearly \$6,000,000 in State funds that was reduced by
- 8 the Director of Health due to severe budgetary reductions in fiscal year 2010. As a result of the
- 9 reductions, the funding for contracts with thirteen (13) FQHCs for the provision of primary care
- services (medical, behavioral, dental treatment) and contracts with Hana Health
- 11 (urgent/primary care services) and Waianae Coast Comprehensive Health Center (emergency
- room services) were switched to the community health centers special fund. If the \$6,000,000
- 13 is restored to its original intended purpose which is to fund the aforementioned contracted

- 1 services, the community health centers special fund will be used to provide capacity and
- 2 infrastructure expansion for the FQHCs.
- 3 The Department appreciates the intent of Section 2, however we defer to the priorities in the
- 4 Governor's Executive Budget request.
- 5 Thank you for this opportunity to testify on this measure.

Ho`ola Lahui Hawaii the only Federally Qualified Health Center and Native Hawaiian Health Care System on Kauai is strongly **SUPPORTING** this bill to provide additional funding to support visits at community health centers for uninsured/underinsured patients.

It is important to note that there is great emphasis in Section 1 of this bill discussing the importance of community health centers and defining them. Section 2 seems to be more general omitting that the payments are for community health centers. We suggest the following insertion into Section 2 as a proposed amendment.

SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$6,000,000 or so much thereof as may be necessary for fiscal year 2015-2016 and the same sum or so much thereof as may be necessary for fiscal year 2016-2017 for the direct health care for the uninsured and underinsured, which may include primary medical, dental, and behavioral health care; provided that distribution of funds may be on a "per visit" basis and may include an additional per member per month quality incentive payment that takes into consideration need in all counties for care <u>delivered by</u> Community Health Centers.

My name is R. Kawahine Kamakea-Ohelo and I am in support of SB 117 relating to health and Community Health Centers (CHC). I currently attend the Myron B. Thompson School of Social Work in the Master's program at UH Manoa. There has been a lot of attention to the homelessness issue, especially here on the island of Oahu. With that in mind homeless individuals and families access the needed health care services in the communities they are in. Even with the new federal mandate that everyone shall be insured, the reality is there will still be many that will fall through the cracks in the system that will be uninsured. CHC's are the entities the homeless will go to and obtain their acute health care services.

As you are well aware the mission of the CHC's is to provide primary care services to the underserved, underinsured, and uninsured. They provide services to all persons regardless of their ability to pay. Under the governance of a community board, charges for services are set on a sliding fee scale and payment is made according to the family's income and size.

Historically, the CHC's originally were to provide comprehensive health services to the medically underserved to reduce patient load at hospital emergency rooms. However, without the needed funding, Hawai'i will continue to see an increase utilization of hospital emergency rooms. The cost of health care will continue to rise without the needed support and services at the community-base level.

Your financial support will allow for the continuation of the 14 CHC's to provide primary health care to the indigent in the state of Hawai'i.
