I am Jan Yamane, Acting State Auditor. Thank you for this opportunity to testify in support of Senate Bill No. 119, making appropriations for public employment cost items. The Hawaii State Ethics Commission ("Commission") requests the Committee's support of S.B. 119, which is to appropriate additional funds to the legislative agencies, including the Commission, to fund Hawaii employer-union health benefits trust fund costs and other cost adjustments authorized by chapter 89C, Hawaii Revised Statutes, for legislative officers and employees excluded from collective bargaining.

The Commission's approved budget for FY 2015-2016 does not include any amount to fund the costs associated with Hawaii employer-union health benefits trust fund costs and other cost adjustments that the Legislature may deem appropriate. It is critical that the Legislature appropriate additional funds for the Commission should the employees of the Executive departments be entitled to adjustments in benefits and pay. Without the additional appropriation, the Commission may be unable to provide its employees with similar adjustments.
