Re: Testimony in support of SB1201 - Tax incentives/Affordable Housing

Good afternoon committee members and our elected officials. Many thanks to those of you from Senator Chun Oakland's office who made it possible for this bill to be heard and to those who have supported our efforts to achieve rent relief for Hawai'i residents.

My name is Andrea Ilima DeCosta and I am the creator of this bill. A Kaneohe girl, I was raised with the values instilled in me by two honored individuals – my mother and my father - both of whom spent their career in public service and raised five children on civil servant salaries.

A few decades ago, it was completely possible for two civil servants with a handful of children to send their keiki to private school, and still afford to purchase a family home. These days, by the state's own accounts, an estimated 262,000 persons in Hawai'i is considered "at-risk" for homelessness – a whopping 1 in 4 persons - while another estimated 14,000 languish in our streets, parks and beaches.

Of the estimated 14,000 who are homeless, 25% of Hawai'i's homeless population is identified as veterans and another 30% are kanaka Maoli; two communities which have grown increasingly vulnerable to homelessness and the disproportionate rates of morbidity that accompany homelessness. Lack of housing is a healthcare risk.

The price of paradise has caught up with Hawai'i families and it has reached a crisis level. More than a lack of units, the real problem is that the rents are too high and local wages haven't been keeping pace with the rate of housing inflation.

This problem is further exacerbated by the fact that local residents must compete for scare housing options with both military members/their families and the many visitors who flock to the islands.

The competition for scare housing units, depressed wages and limited development options led me to donate a day of my own wages so that I could gather the signatures necessary to demonstrate that the community really does demand relief.

During the course of the legislative opening day, of the approximately 450 persons who attended the capitol, I was able to gather 84 unique signatures from concerned

citizens. This represents a capture rate of nearly 19% - an incredible response for a few hours of outreach!

In addition to the physical signatures, an online petition that I created via the site Change.org netted an additional 914 digital signatures; a copy of the link is included for your review:

The process of building affordable housing units is cost-prohibitive and time consuming – Hawai'i residents can't wait for units to be built and we strongly urge our elected officials to immediately pass this tax incentive bill; passage of the bill will result in creating affordable housing out of the existing stock – a win/win for landlords and for struggling Hawai'i families.
