I currently hold the elected office as the District 7 Governor on the Board of Governors of the American Chiropractic Association. Nationally, I represent the local **Hawaii** Doctors of Chiropractic and also all the Doctors of Chiropractic in California, Nevada, Guam, American Samoa and the Mariana Islands. Additionally, In the State of Hawaii, I hold the elected office of President of the Hawaii State Chiropractic Association.

The American Chiropractic Association is the largest Chiropractic professional representative organization in the world. The Hawaii State Chiropractic is the only state wide representative organization for the Chiropractic profession in Hawaii. I give this as testimony to voice strong support to the intent of **SB 1217**.

The Patient Protection & Affordable Care Act was signed into law by President Obama in 2010, thus forever changing the business of health care insurance coverage and its availability to the public at large. As part of the law's many provisions, a very important section established in section 2706 (a) of the Public Health Service Act language that prohibits discrimination in insurance plans, health care policy, etc. against health care providers that are performing services that they are licensed in that state to perform.

The language of **SB 1217** brings Hawaii health care law and policy into alignment with federal statutes and policy. The net effect is to allow the health care consuming public in Hawaii to better choose and direct which providers and the type of health care they desire to provide the services they require.

Please pass SB 1217 from your committee for the benefit of all Hawaii health care consumers.
