Testimony in OPPOSITION to S.B. 1227 RELATING TO FOOD WASTE

1 **Fiscal Implications:** No funding is provided to enforce the prohibition.

- 2 Department Testimony: The Department respectfully opposes this measure, which prohibits generators
- 3 of commercial organic material from disposing any solid waste into landfills, waste-to-energy facilities,
- 4 or incinerators. While we believe the intent of the measure is to restrict the disposal of large quantities
- 5 of food waste, the measure actually prohibits the disposal of all waste by commercial organic material
- 6 generators at the aforementioned facilities, and requires all of their waste to be taken to specific organic
- 7 waste management facilities, which may or may not be appropriate. Restaurants, supermarkets, and
- 8 food manufacturers are known to generate other waste streams than just food waste.
- 9 Assuming that the intent of the measure is to divert large quantities of food waste from landfills and H-
- 10 power, the City and County of Honolulu already has a food waste recycling ordinance that requires large

11 food establishments to recycle food waste. We believe that this existing ordinance addresses majority

- 12 of the waste stream that is targeted in this measure.
- 13 In addition, the Department opposes this measure because we do not have the resources to enforce the
- 14 proposed recycling requirements. The proposed new requirements will require oversight over a new set
- of regulated entities, not ones that we already regulate under HRS 342G or H. Our solid waste
- 16 enforcement staff is primarily funded by the collection of the solid waste management surcharge, which
- 17 its collective revenue decreased over recent years. In order to accommodate reduced solid waste
- 18 surcharge revenue and increased personnel costs, we have already cut or reduced services, such as
- 19 state-wide solid waste management planning, compliance monitoring of solid waste facilities,
- 20 enforcement of battery and tire retailers, and municipal solid waste landfill operator training.

The practice of feeding food waste to livestock is prohibited throughout the European Union and in 22 states in the US. Unless the garbage is boiled for a set amount of time at a prescribed temperature, the possibility of disease is a serious issue. Although allowed under federal law, enforcement in Hawai'i is deferred to the State. Records obtained by Animal Rights Hawai'i under UIPA, show that compliance is spotty and we doubt that the Dept. of Agriculture has the resources to adequately protect the health of people who consume the flesh of swillfed pigs. Aloha Committee Members:

Maui EKO Systems supports SB1227, which prohibits organic material waste from landfills, with amendments. EKO fully supports the concepts of zero waste and sustainability, which the intent of this bill seems to be supporting.

Our concerns with this bill as currently written stem from the inclusion of the term "or transfer any solid waste..." EKO is contracted with Maui County to compost incoming greenwaste and biosolids, with the compost facility cited within the Central Maui Landfill. As currently written, the bill may be interpreted to mean that our current operations may not be permitted. In talking with the introducer of this bill, halting operations such as ours is not the intent behind this bill. Therefore, EKO respectfully requests that the language be amended to read:

"(a) Notwithstanding any law to the contrary, any generator of commercial organic material shall not dispose of <u>or transfer</u> any <u>solid waste commercial</u> <u>organic material</u> to any landfill or waste-to-energy facility, or by incineration, in the State."

EKO supports SB1227, with amendments.

The phrase "or transfer of commercial organic waste" would seem to illegalize our operations at the Maui Landfill where we are collecting waste oils from restaurants and transferring it to tankers to be shipped to Big Island Biodiesel. Pacific Biodiesel has been in operation in the Central Maui Landfill since 1996 and has won numerous awards for our recycling of waste vegetable oil into high quality biodiesel. We respectfully request you strike the words "or transfer" from the first sentence and add the biofuel production to the list of possible alternate means of disposal. Comments: Aloha, I fully support his bill. I am an organic farmer on Maui and I generate compost from green waste and over 25 tons of food waste a year. it has dramatically decreased our fertilizer bill, increased our soil health, increased the flavor and quality of our produce and reduced soil erosion rates on our farm by 95%. Hawai'i can take a big step towards sustainability by increasing our ability to capture and use organic waste rather than leaving it in a land fill where it just becomes a problem for future generations. Maui County has been fined over 3 million dollars by the EPA for excessive methane emissions from our landfill, due largely to the unnecessary accumulation of organic matter in the landfill. With our rapid rates of vegetative growth and food waste from 1.4 million permanent residents (not mentioning transients) we have the opportunity to benefit substantially from the capture of our organic waste and turning it into a resource whether it be biogas or soil regenerating compost.
