Dear Chairwoman Kidani & Committee Members:

SB 126 – Relating to Education

I oppose the language of SB 126 as it stands. Although I am certainly sympathetic to the view that more could be done to build stronger connections between community members and their local public schools I believe that radically altering the governance structure of the Board of Education would not accomplish this objective.

The inclusive intent of the language in Bill 126 is no doubt admirable. It is vital that Hawaii's Board of Education reflect the full diversity of thought and experience that the Islands represent but diversity alone is insufficient. One cannot legislate an effective Board of Education. Good boards need to be constructed thoughtfully with an eye toward both the current needs and the long term objectives of the underlying institution. Surely the Governor him or herself is best placed to ensure that the composition of the BOE represents both the diversity and the broad array of skills necessary to oversee this, the most complex and largest single institution in the State.

The synchronization of members' terms, something which indisputably runs contrary to best practices for both for-profit and non-profit institutions would significantly degrade the effectiveness of the BOE and would invite the injection of a degree of short-sighed and political behavior into an institution which must above all take a long term and strategic view. The mission of the Board of Education as stated on its website is as follows:

The mission of the Hawaii State Board of Education is to promote excellence and equity in Hawaii's public schools and enable all students to meet their own unique and varied potentials.

This mission doesn't change every four years and it did not change after the recent State Constitutional referendum regarding the BOE. To be effective, the vision of both our Governor and his Board of Education must span far beyond a two or four year political cycle. We simply cannot afford a governance structure that contributes to the same "stop and go" approach to public education that is such a consistent complaint of active teachers and administrators. No other board in the State, including the UH Board of Regents, operates in this manner and for good reason.

The Department of Education is the largest and most complex business in the State; our Governor deserves the flexibility to balance the need for experience and institutional memory with the need for fresh and representative voices.

I am naturally sympathetic to the view that given the Governor's ultimate accountability he or she should have strong input into the composition of the Board of Education. I also believe that he or she should in fact select the Board's Chairperson. As it stands, the Governor will have had the opportunity to appoint the majority of the BOE half way through his first term. Given the long term perspective needed to effectively shepherd our public school system surely this is sufficient.

It is worth bearing in mind that virtually all of the important responsibilities entrusted to our Governor have impact that extends far beyond a four or even an eight year political term. Why should the Governor's perspective on public education in Hawaii be of a shorter duration than that of our transportation, health or fiscal policy? This makes little sense given that that average public school student will spend at least 13 years in our schools – well beyond the Constitutional term limit of any administration.
