Title of Bill: SB 1311, SD1 RELATING TO EDUCATION.

**Purpose of Bill:** Allows a licensed or credentialed educational practitioner to utilize

behavior analysis principles and techniques without being licensed as a behavior analyst; provided the unlicensed individual's use of those techniques is limited to the individual's recognized scope of practice.

#### **Department's Position:**

The Department of Education (Department) supports SB 1311 SD1 and has met with representatives of the Hawaii Association for Behavior Analysis to discuss this measure. As part of their regular duties in the delivery of teaching and strategies to assist students to learn, Department personnel may engage in the practice of behavior analysis in a school classroom setting. In this context, behavior analysis would focus on the identification of performance or behavioral issues and the intervention(s) such as positive reinforcement to result in positive learning and educational outcomes for a child with autism spectrum disorder.

Department personnel, including but not limited to, general and special education teachers, counselors, school psychologists, and educational assistants do not, in the course of their work in a public educational setting, use any title or description stating or implying that the individual is a licensed behavior analyst or a "practicing" behavior analyst.

SB 1311 SD1 is important to avoid a disruption in services to students with autism spectrum disorder provided by school personnel pursuant to an individualized education program. The language in this measure will clarify the applicability of the exemption for the Department and will ensure that educational professionals are not subject to mandatory licensing outside the scope of their formal educational degrees and training.

The State Council on Developmental Disabilities **supports the intent of SB 1311 SD1**. This measure would allow a licensed or credentialed educational practitioner to utilize behavior analysis principles and techniques without being licensed as a behavior analyst; provided the unlicensed individual's use of those techniques is limited to the individual's recognized scope of practice.

The Council strongly supports the licensing of behavior analysts for the practice of behavior analysis. We appreciate the changes in SB 1311 SD1 that would limit the unlicensed provider's use of techniques being limited to their recognized scope of practice.

Chair Tokuda and Committee members,

The Hawaii State Teachers Association opposes SB 1311 SD1, relating to education.

This bill, even as amended, leaves a loophole that would allow unlicensed and untrained individuals to provide behavior analytic services to keiki in Hawaii's public schools, just as long as they don't call themselves "Behavioral Analysts". We have serious concerns with this bill. Behavioral Analysis for our most vulnerable keiki is extremely important for our students with special needs. Those who complete this analysis require a license and a considerable amount of training. Teachers and Educational Assistants are neither certified nor licensed to complete this task, and that is why they need specialists, such as Behavior Analysts to assist them. Teachers and Educational Assistants are not specialists in Behavior Analysis, and they are not expected to be. This bill would leave a loophole where teachers or educational assistants could be required by the DOE to conduct behavioral analysis work, even though they could not call themselves Behavioral Analysts, or require teachers or educational assistants to be certified Behavioral Analysts.

To become a Behavior Analyst, you need a master's degree, additional coursework in behavior analysis, and supervised fieldwork hours where they are trained in the hands-on applications of behavior analysis. This bill might still allow people to provide "behavior analysis" without the level of training that is necessary to be competent, and could even be detrimental to our students. This bill continues to

try to circumvent the most recent passage of Act 199 from last session, that took effect this January, therefore, we will continue to oppose this bill.

Yes, the Department of Education already struggles to provide decent behavior analytic services. A recent article in the Star Advertiser states that the DOE does not currently have the ability to provide services to the students in need of special education. They struggle with providing services, with hiring and retaining qualified staff, and with monitoring services. This leads to many unqualified people attempting to provide educational services that will inevitably lead to poor outcomes, educational neglect and even abuse. However, this lack of finding qualified people does not mean we should lessen our level and quality of care for our keiki. Once again, we need more funding for our schools to help us retain and provide these specialized services for our keiki.

Our state must not allow untrained individuals to provide behavior analytic services to our most vulnerable keiki in Hawaii's public schools. Therefore, the Hawaii State Teachers Association asks your committee to **oppose** this bill.

# **Testimony in OPPOSITON of SB1311 SD1**-behavior analysis DOE exemption

Honorable Chair Tokuda, Vice Chair Dela Cruz and members of the committee,

Thank you for the opportunity to submit testimony today in **OPPOSITON to SB1311 SD1.** My name is Kristen Koba-Burdt, President of the Hawai'i Association for Behavior Analysis (HABA). On behalf of the behavior analytic community, HABA met with the DOE on 2/11/16 in an effort to work collaboratively and ensure children receive the services they need, from licensed, trained, qualified providers. Following this meeting, testimony from the DOE, and testimony in opposition to this bill from a number of organizations, including the Hawaii State Teacher's Association and the Hawaii Association of School Psychologists, the committees sought to add clarifying language to Act 199 and included the following in the committees' hearing report:

"Your Committees received testimony in support of the proposed S.D. 1 from the Department of Education. Your Committees received testimony in opposition to the proposed S.D. 1 from the State Council on Developmental Disabilities; Hawaii Association for Behavior Analysis; Hawaii Association of School Psychologists; Wolff Behavioral Services, LLC; Hawaii School Counselor Association; Autism Behavior Consulting Group, Inc.; Hawaii State Teachers Association; Autism Society of Hawaii; Keiki Educational Consultants; and numerous individuals.

Your Committees find that teachers and other Department of Education personnel must employ a wide range of strategies in the course of their regular duties to effectively instruct students and create an environment conducive to learning. Some of these strategies employ principles and techniques that fall inside the practice of behavior analysis. If teachers are required to be licensed as behavior analysts before they employ these techniques, they will be hindered in their ability to provide educational services to their students. However, your Committees note that teachers who are not licensed as behavior analysts are not equipped to provide the same services as a licensed behavior analyst, especially with regard to students with special needs. For that reason, the use of behavior analysis techniques by teachers who are not licensed as behavior analysts should be limited to the course of their recognized scopes of practice."

We agree with the committees' report and thank Senators Baker and Kidani for their insightful comments; however, we fear the amended language of SB1311 leaves too much uncertainty and likely exposes the DOE to ongoing due process lawsuits.

Just this last legislative session, Act 199 was passed to license behavior analysts because the legislature recognized the need for consumer protection. Individuals that receive behavior analytic services are some of our state's most vulnerable population. Individuals with intellectual and developmental disabilities that may not be able to speak for themselves. We believe that any child receiving applied behavior analysis (ABA) services deserves a licensed, trained, and qualified provider. Act 199 as written includes exemptions for other licensed professionals working within their scope of practice. SB1311 adds language to Act 199 stating that "This chapter is not intended to restrict the practice of other licensed or credentialed educational or healthcare practitioners practicing within their own recognized scopes of practice." A number of licensed and credentialed professionals working in the DOE have submitted testimony in opposition to this bill because they do not have the training, experience, and qualifications needed to help these vulnerable students, yet many teachers and educators feel they will be told they have to attempt to provide the behavioral support their student's need and they will not receive any additional support from a licensed, qualified, behavior analyst.

The practice of behavior analysis requires extensive specialized training and experience, in not only the science of behavior, but also the most effective means to oversee direct care or paraprofessional level staff working one-on-one with children. Recent news reports continue to document the shortage of special educators in the Department of Education, with recent figures reporting nearly 20% of positions vacant. Many positions are filled by long-term substitutes or emergency hires that do not have the training and qualifications needed to provide behavior analytic interventions to children in an effective and ethical manner. Currently, the DOE contracts with outside agencies for paraprofessional (one-to-one aide) staffing. These paraprofessionals are supposed to be led and directed by the licensed teacher; however, in numerous cases across the state paraprofessionals receive little-to-no training or oversight because the teacher is a sub or an emergency hire. This current system costs tax payers millions of dollars each year, and yet progress and development for children in the special education system is the worst it's been since the Felix decree. The current system is not effective and needs to change. Our educators need support, from licensed, trained, and qualified professionals. This proposed bill creates great uncertainty for families and could allow undertrained staff, outside contracted providers, substitutes, and others to practice behavior analysis, putting the most vulnerable special education students at risk

We ask that you uphold the existing language of Act 199 by ensuring all children in Hawai'i are afforded the same protection of a licensed professional working in their scope of practice when receiving behavior analytic interventions. Please oppose this bill.

Hawaii Association of School Psychologists (HASP) believes that licensure is important for all professionals that are entrusted to care for students, especially those with special needs. Act 199 ensured a higher level of care for children with autism based on the specialized training and expertise required to implement Applied Behavior Analysis (ABA). HB868 and SB1311 proposes that the training and expertise are not necessary in the "practice of behavior analysis" within the educational setting.

School psychologist act to benefit all students and to do this, they must practice within the boundaries of their competence, use scientific knowledge from psychology and education to help students and others make informed choices, and accept responsibility for their work (NASP Ethics, Principle II.1). In accordance with the National Association of School Psychologists (NASP) Practice Model 2010, HASP asks that school psychologists practice in ways that are consistent with ethical, professional, and legal standards and regulations. School psychologists engage in effective, collaborative, and ethical professional relationships that support a multi-tiered continuum of services to support all students' attainment of academic, social, emotional, and behavioral goals. School Psychologists are trained in a variety of treatments that distinguishes us as mental health professionals within schools, but we do not provide nor practice "applied behavior analysis" (ABA) or "behavior analysis" when it is outside the scope of our competency. Those who have attained competency to provide ABA are recognized by their board certification through the Behavior Analyst Certification Board and through the Department of Commerce and Consumer Affairs, Professional and Vocational Licensing in the state of Hawaii.

Hawaii Association of School Psychologist asks that you uphold the existing language of Act 199 by ensuring all children in Hawaii are afforded the same protection of a licensed professional working in their scope of practice. Please oppose this bill.

Comments: Thank you for the opportunity to submit my testimony in OPPOSITION of SB1311. This piece of testimony, introduced on behalf of the Department of Education, asserts that classroom teachers and educational assistants (along with others) possess the skillset to design and implement applied behavior analysis (ABA) --without a license, adequate training, or appropriate oversight by a licensed professional. As is, our license already exempts many licensed providers listed in this request: "An individual working within the scope of practice or duties of another licensed profession that overlaps with the practice of behavior analysis; provided that the person does not purport to be a behavior analyst" (Act 199, Exemption 1). One of the major loopholes we see with the language introduced by the Department of Education is that it lists positions (e.g. teacher, social worker, etc.) and does not make reference to them being licensed or qualified. Additionally, the language that is being proposed in the DOE bill also seeks to exempt "Educational Assistants". We are talking (most often) individuals with high school diplomas who have received little to no training in autism or applied behavior analysis. The purpose of ACT 199 is to increase consumer protection. SEVERE harm is a real and very likely risk to our keiki if this proposed bill moves forward. Our keiki deserve qualified professionals and our teachers deserve support! Please support our keiki and our teachers by OPPOSING SB1311. Malama our keiki, Amanda N. Amanda@keikiconsultants.org The Importance of Licensure - "Licensing of behavior analysts is important for many reasons. However, one reason stands out well beyond any of the others – the ability of the state licensure system to provide a mechanism for protecting consumers of ABA services. Services provided ...by those who are not adequately trained in ABA include an inherent risk to those served. Therefore, consumer protection is vital. The process of licensure would result in the requirement that only those licensed by the state board could advertise themselves to the public as "applied behavior analysts," or could provide services defined within the law as the "scope of practice" of licensed applied behavior analysts. Some consumers may not be able to discriminate between adequately and inadequately trained providers, and they may trust providers who insist that they are "just as well trained" and have "many years of experience" in ABA." (Dorsey, Weinberg, Zane, and Guidi, 2009). Indeed, our legislators have

already made the vital decision to license the profession last year when Hawaii Licensure for Behavior Analysts (Act 199) passed as law. Serving Sensitive and Vulnerable Populations - Behavior analysts work with clients to address a number of behavioral concerns. We are often called in when clients present with behavior that threatens their health or safety or the health and safety of others, as well as behaviors that constitute a barrier to quality of life (e.g., severe aggression, selfinjury, property destruction, or noncompliance). Behavior analysts also help clients learn developmentally appropriate adaptive, social, or functional skills that are fundamental to maintain health, social inclusion, and increased independence (e.g., toileting, dressing, feeding, compliance with medical procedures, etc.). The vulnerable populations we service have the right to effective behavioral treatment. An article published in 1988, clearly identifies six specific rights of our clients (Van Houten, Axelrod, Bailey, Favell, Foxx, Iwata, & Lovaas). • Right to a therapeutic environment • Right to services whose overriding goal is personal welfare • Right to treatment by a competent behavior analyst • Right to programs that teach functional skills • Right to behavioral assessment and ongoing evaluation • Right to most effective treatment procedures available Eligibility Requirements for Behavior Analysts & Assistant Behavior Analysts - "Professionals in ABA engage in the specific and comprehensive use of principles of learning, including operant and respondent learning, to address the needs of individuals with ASD in diverse settings. Services are provided and supervised by Behavior Analysts with expertise and formal training in ABA for the specific treatment of ASD (see BACB document: "Applied Behavior Analysis in the Treatment of Autism Spectrum Disorder"). Applicants who meet the degree, coursework, and supervised experience eligibility requirements are permitted to sit for either the BCBA or BCaBA examination. Each examination is professionally developed to meet accepted examination standards and is based on the results of a formal job analysis and survey. In addition, all BACB examinations are offered under secure testing conditions and are professionally administered and scored" (Appendix A: Eligibility Requirements for BACB certification). Growth and Status of Professionals in the State of Hawaii - Over the past 15 years, the field of applied behavior analysis (ABA) has experienced extraordinary growth in the number of practitioners, as well as those seeking ABA services. The BACB credentials and recognizes individuals at four levels: In Hawaii, we have over 350 Registered Behavior Technicians (RBT), a handful of Board Certified assistant Behavior Analysts, and over 100 Hawaii Licensed Behavior Analysts (BCBA/BCBA-D). With the passage of autism insurance and subsequently the passage of licensure of behavior analysts, we have seen ABA university programs develop in Hawaii. At present, there are three local options for individuals to choose when pursuing their BCaBA/BCBA/BCBA-D. • University of Hawaii (BCBA online program) • University of West Florida (UWF) Hawaii-cohort • Florida Institute of Technology (FIT) Hawaii-cohort Intentions of Board Of Education - From information that has been shared with us, we are concerned about the intentions of the DOE and worry for the safety of Hawaii's keiki. Specifically, we are concerned about the guidance BOE is providing its staff and administrators, pertaining to ABA. We have attached for your review, the body of an email that was sent to Hawaii School Administrators: Dear School Administrators, ACT 199 (signed into law July 2, 2015) basically says that anyone doing behavior analysis for a child with autism needs to be a licensed behavior analyst as of Jan. 1, 2016. Behavior analysis refers

to Applied Behavior Analysis (ABA) - programs, trainings, principles/components/processes, etc. The DESes have been awaiting guidance or word of being exempt from State Sped, however none received yet. In the interim Leeward Autism will be proactive and refrain from saying and providing: ABA student programs, trainings of ABA awareness/methods or implement ABA principles throughout the day, etc. We will instead describe and continue to train/implement developmentally appropriate educational practices/intervention strategies in our work. These are implications for anyone servicing students with ASD. This would not apply to those with a license as described in ACT 199. Please consider talking to your respective school staff that service students with ASD. Thank you for your understanding and cooperation. Feel free to call me if you have guestions. # 675-0384 In addition to this email, last month on February 4, 2016, the Department of Education (DOE) released addendums to their paraprofessional (direct services) and behavior intervention support specialist (consultant/supervisors) contracts (see addendum to current RFPs). In these documents, it clearly states that Board Certified Behavior Analysts (BCBAs) would no longer be eligible to serve as supervisors of ABA programs (see image below). This conflicts with guidance from experts in education. It is also in direct conflict with the law (Act 199). Conclusion The purpose of ACT 199 is to increase consumer protection. SEVERE harm is a real and very likely risk to our keiki if SB1311 moves forward. Our keiki deserve qualified professionals and our teachers deserve support!

#### Dear Senator Tokuda, Senator Chun Oakland and members of the committee:

I strongly believe that licensure is important for all professionals that are entrusted to care for ALL our keiki, especially those who are the most vulnerable, children with special needs. The true intent of Act 199 is to safeguard the rights of these children by ensuring a high quality standard of care based on the specialized training and expertise required to implement the science of Applied Behavior Analysis (ABA). SB1311 SD1 proposes that the training and expertise are not necessary in the "practice of behavior analysis" within the educational setting, but at what cost?

The Hawaii Department of Education's leadership claims that by opposing their proposed exemption there will be an interruption in service for the children who need it most. This smoke and mirrors statement would only be true if the department was actually providing all these children the quality services they need by professionals appropriately trained to do so. This bold claim is just another bullying tactic to skirt the fact that this is a serious problem and will continue to put our most vulnerable keiki in true harm's way at the hands of untrained individuals.

As a community stakeholder, and a parent of a child with special needs, who has previously worked in the DOE and at a non-profit organization, which serves the families of children with special needs, I can speak with tremendous concern that DOE even refuses to listen to their own people. In my time with DOE I know of many well-intentioned employees that work in the trenches with these students, and they are crying out for more support and training, (which by the way doesn't work if you use your own untrained in house autism consultants to tackle this ongoing problem). Wouldn't it make sense to instead partner with professionals that are licensed, and extensively trained in ABA to support your own people?

Furthermore, there are groups of professionals within the DOE that strongly oppose the "gut and replace" tactics in both HB 868 and SB 1311 because this goes against their own professional integrity and code of ethics to not operate outside their scope of training and expertise. Nevertheless, many of them are reluctant to take a stand for fear of losing their jobs. When I worked for the non-profit parent training information center, I fielded numerous calls from parents of children with special needs who were also DOE employees begging for representation and support in getting appropriate services for their children because they could not advocate for their very own child without fear of retaliation. We should not allow the DOE to bully their way out of ACT 199 as it was truly intended. I ask that you uphold the existing language of Act 199 and take a stand for our keiki. **Please oppose this bill.**

It is already disappointing that Luke will not be benefitting directly from the bill named after him but to read that this new bill is seeking to disregard licensing requirements for those who provide ABA services, is in my opinion downright irresponsible. #### Good Afternoon Senators,

I was so happy when Luke's Law passed, as you know Luke missed the cut off age for help, but I felt we had made a difference together, we changed the lives of so many innocent children and their families and our wonderful state. I was confident in the licensure law that passed that these children would get help not by snake oil providers who were in it for the money but by bone fide educated people who would change these children's lives for the better.

Here I am though, after hearing that this may not happen in the very institution where these children live the better part of their day.

I know firsthand what it is like for these vulnerable children who cannot communicate the hurt that is inflicted upon them by untrained people. Look at my son, who has endured such treatment. Look at him he is the poster child for perseverance for enduring so many wrongs on so many levels. I could not protect him as I too wasn't trained and could not get help for him from these very people who I asked for help from. I often wonder what things have happened to him as he was not always able to communicate.

I couldn't protect him. But I say here today to tell you first hand we must protect these children!!

Let me help you visualize some of the memories I live with (and now have a hope of changing for others)

- 1. Luke-preschool doesn't want to separate from me and attend school. The school sends a special education teacher to take him to class. Luke has abrasions on his arm from where the teacher forcefully (after he left me) took him. It is logged in the healthroom records if you would like to see. People would say why didn't you sue the dept.? I say was that teacher qualified and trained in behavior? So taking apart someone elses life wasn't the right answer. But Luke suffered? Could he tell me? No.
- 2. Luke was sent to the vp's office the vp took away his thing that he walked around with (part of autism) and luke was distraught. The v.p. came to me later asking to make ha pono pono. Ok I could do that as I know she wasn't trained either and didn't know what she was doing. But did Luke suffer? Could he tell me?
- 3. Just recently his one on one for band was an e.a.. Luke left her and ran across North road (a very busy road). I had just arrived to pick him up. The e.a. was on one side of the road and hadn't even crossed to where Luke was. Was she trained in these specific Autism Behaviors? No.
- 4. Luke left band this year and called me to say he was done. Where was the ea I kept telling him on the phone? I got him to go to the office to wait as I scrambled to get there. At least the ea went and got help from the ssc. Was she trained? When we talked with Luke about how this was not a good choice he said "I wasn't thinking" when he got to the car he said "ahh I wasn't thinking when I crossed North road last year. So

- the communication and connections are starting but that doesn't change the people who work with him not having the training to work with Autism behaviors.
- 5. Do you know that at Luke's IEP I asked everyone on his team this year who had formal training in ABA/Autism. Not a single person.

These are the people we put in harm's way to do behavior analysis without the required training and licensure: The child, the teachers/ea's, the system, our taxpayers in our beautiful state.

Did I mention that Emma, Luke's Sister, has a 4.0 in her first year at High School? Despite the fact that none of her teacher's are highly qualified. Why would we do that to a child with special needs? And yes Luke's teacher is not highly qualified as well. Why would we put these people in these positions to do something they are not trained for?

On a positive note. Luke watched the movie inside/out and cried for the first time and we heard a lot of his concerns and worries. I called Kapiolani to get help from the people who are trained in behavior and at the same time called his school, I talked to someone who works with him from an outside agency who is trained in ABA and guess what, he already had worked with Luke that morning before I even called.

See the difference? Hear my pleas in opposition to this bill SD1. Hear the children who cry this morning (and the adults who want to help but do not know how).

Last year it was determined that licensure was necessary to ensure that behavior analytic programs are designed and implemented by qualified individuals. In order to become a licensed behavior analyst in the state of Hawaii one must become certified by the Behavior Analyst Certification Board by meeting these requirements: 1. Hold a master's degree in the field of applied behavior analysis, education, or psychology. 2. Complete 270 classroom hours of graduate-level instruction from specific content areas from an accredited institution. 3. Gain experience under the supervision of a Board Certified Behavior Analyst though either supervised independent field work (1500 hours), a practicum (1000 hours) or an intensive practicum (750 hours). 4. Pass the Behavior Analyst Certification Board Exam. At public school campuses, there are students with developmental disabilities and problem behaviors that require the use of applied behavior analysis in order to remain in their least restrictive environment and access meaningful education with their peers. In my experience working on public education campuses with students with special needs, efforts to implement applied behavior analysis by untrained individuals are usually ineffective and/or harmful. Techniques that may seem simple to a lay person are actually quite complicated and require constant adjustments based on the individual and their progress. When determining the requirements for certification and licensure, experts agreed on the level of education and experience needed to develop the necessary skill set to provide behavior analysis services. There are teachers, paraprofessionals, and even many school behavioral health specialists that do not meet the requirements to legally provide

applied behavior analysis. Paraprofessionals often have no training requirements prior to beginning work and spend more time with their student than any other school employee. They usually do not receive any training in behavior analysis. Without training and supervision from a behavior analyst, the behavior support plan is often abandoned in favor of ineffective reprimands and threats resulting in frustration to the student, teacher, and paraprofessional. Why should the requirements to practice behavior analysis be completely disregarded in the most important environment that reaches the majority of Hawaii's children? Public schools should adhere to the same requirements as any other practicing individual to fulfill their ethical responsibility to provide effective evidence-based interventions to their students.

My name is Johanna Taylor and I provide support to children with autism and their families in Hawaii. I am a Maui resident. I am in strong opposition of SB1311 SD1. There are several key reasons why this bill should not move forward:

- Changing the wording in the law creates ambiguity which may result in more due process lawsuits across the Hawaiian islands.
- The current contracted provider system cost \$38 million last year this salutation has essentially become a band-aid with paraprofessionals spending time with children without appropriate support. The Department of Education has reported that they do not have enough qualified teachers. No matter the setting (school, home, community) children with autism should have the right to access appropriate treatment from trained individuals. Based on previous testimony from caregivers of children with autism in Hawaii it is clear that harm can come to children that do not have access to treatment from trained professionals. As a neighbor island resident we have an even greater shortage of licensed, qualified educators in the schools; therefore, the consumer protection that Act 199 provides is even more important.

• The DOE has changed the wording in their contract from "applied behavior analysis" to "differential reinforcement, prompting, and calming strategies." By changing this wording they are admitting they are not providing applied behavior analysis treatment. It is imperative that providers working with children with autism have specialized training and expertise required to implement ABA. This bill proposes that the training and expertise are not necessary. To be proficient in the application of behavior analysis (ABA) requires an individual to complete extensive training and supervision. This science of ABA sets behavior analysts apart from individuals with other educational backgrounds.

The passing of this law is unrighteous for the future of keiki in Hawaii. Please **OPPOSE SB1311 SD1**.

I have worked in and with the DOE for the past 17 years servicing children diagnosed with Autism. There has always been and continues to be a significant difference in training and competency between DOE staff and contracted providers. More so, when compared to a BCBA. Although the DOE reports that their staff members are trained in ABA, I can assure you that they are not. This has led to inappropriate treatment of our Keiki. I currently continue to encounter the miss-use of punishment procedures, inappropriate placement, and schools without Fully Self Contained (FSC) classrooms forcing students to transition during every class into classes that are 3-4 times above their academic level. I continue to encounter teachers that would rather allow there students to hit themselves with a bloodied face using extinction (a popular but not always ethical ABA treatment) rather than implementing a Functional Behavior Assessment and appropriate Behavior Support Plan that would use more ethical and humane procedures. I continue to see the promotion of paraprofessionals and the transformation of untrained DOE personnel into ABA consultant positions without nearly the ABA education needed to create and monitor an ABA program. This is a continua frustration that I encounter. On the positive side, I continue to work with teachers and staff members that are so stressed and in need of help. These are the providers that ask for help. These are the providers that willingly express that the help from a BCBA consistently surpasses the help that they receive from DOE staff members. Teachers themselves will agree that a BCBA is needed to confidently and successfully create and monitor ethical ABA programs. Without a licensed professional, I can assure you that Teachers and staff will use the limited interventions that they have been taught in the past to treat suffering children. Such inappropriate interventions as ignoring a child that hits herself until bloodied. Inappropriate interventions such as restraint just to gain compliance (not recommended in ABA). Interventions that will not just lead the DOE into more law suits but will create undo pain and suffering upon our children and continue to hinder their learning and reduce their potential in life. Please continue to hold the DOE at the same standard as everyone else. If the law doesn't, neither will thev.

My name is Lindsey Shepherd, and I am a licensed Board Certified Behavior Analyst. Before I became a Behavior Analyst I was hired by the Kauai school district as a Behavior Specialist, consulting with teachers, paraprofessionals, and parents on students diagnosed with Autism. I had no experience prior to being hired on, but was lucky enough to get to shadow a current behavior specialist. We taught paraprofessionals how to deliver ABA instruction, worked with teachers on developing behavior plans based on ABA strategies, and taught parents how to deal with students in their own home using ABA strategies. I enjoyed the work I did so much that I went back to school to get my masters in applied behavior and autism and pursue my BCBA. During my schooling I was incredibly embarrassed and shocked at the amount of things that I was doing incorrectly. The training that I had delivered to teachers and families was not up to par with standards of practice. Since then I have still worked with the school district as a contracted provider on the Island of Kauai, and I am constantly faced with situation where people who are given less training then I was when I was hired are designing and training ABA programs. Many of the Behavior Specialist employed are emergency hires who were paraprofessional and have no formal training in designing ABA programs, functional behavior assessments, or even the diagnosis that they work with most often, Autism. The school district is unable to hire or maintain skilled staff and the staff that are skilled are pulled so thin that their services become ineffective. It is crucial to the students with Autism in the department of education that they are required to hire and train staff to the reasonable standards that are already put forth in the law. It is logical that a licensed professional be the person delivering training to a teacher, instead of someone who has received no formal training or practice in the area. I strongly oppose HB868 and SB1311 and support delivering quality services to keiki in our school districts.

Applied Behavior Analysis, otherwise referred to as ABA, is a science. Board Certified Behavior Analysts are the scientists of Applied Behavior Analysis. Currently there is a private Board, the BACB, which certifies, oversees and defines the field. There are ethical guidelines and principles which are required of BCBA's to follow. DOE teachers are not required to adhere to these ethical codes of conduct, will not be overseen by the board, and is not apart of the ABA field. With that being said, Applied Behavior Analysis is also one of the only recognized treatments for autism. Autism is a multifacted disorder affecting many areas of development. In schools (DOE/public), the behaviors of autism can be so severe that a child's safety is at risk. ABA can help these kids with severe needs; but only if a qualified professional is providing services. There are two bills which the DOE has submitted which would allow anyone in school settings to legally practice Applied Behavior Analysis. As a graduate student studying Applied Behavior Analysis, I can assure you that there is so much to the science, that someone who is unqualified cannot fathom to implement or understand. Many special needs teachers (probably most for that matter), have not studied Applied Behavior Analysis...What is worse, is that our special needs keiki are at risk since they will not be receiving these treatments, interventions, and assessments from a licensed professional such as a Board Certified Behavior Analyst. These kids matter, and they do deserve quality care, given by qualified professionals.

Thank you, Senator Tokuda,, for supporting our keiki in passing Luke's Law (autism insurance reform) last year. This year, we meet again to discuss the implementation of applied behavior analysis (ABA) by licensed professionals within our schools. While I agree with Senators Baker and Kidani's comments on this bill, the language of SB1311 is not specific enough. It is imperative that our keiki with autism receive ABA by licensed and trained professionals- at home, in the community, and in school. Without a quality ABA program embedded into their education and run by licensed, trained professionals, our special needs children will continue to fall through the cracks. Soon, our special needs children will become special needs adults, dependent on the state's resources for support. We see this in the news all too often with families of children with special needs filing suit against the DOE for lack of care or ineffective treatment in the schools. Let's stop putting band-aids on these cracks; lets fix the system by supporting our teachers and our students in providing effective treatment by licensed and trained professionals. It is the right thing to do. Please oppose this bill.

First, thank you all so much for passing Act 199, to ensure the licensure of Behavior Analysts during the last session. I am writing today to lend my voice in STRONG opposition of SB1311 SD1. This bill would allow unlicensed and untrained individuals to provide behavior analytic services to keiki in Hawaii's public schools. I have several concerns with the bill.

- 1. Behavior Analysis is a field which requires a considerable amount of training. To become a Behavior Analyst, I needed to have a master's degree, additional coursework in behavior analysis, and 1500 supervised fieldwork hours where I was trained in the hands on applications of behavior analysis. This bill would allow people to provide "behavior analysis" without the level of training that is necessary to be competent.
- 2. The Department of Education struggles to provide decent behavior analytic services. A recent article in the Star Advertiser states that the DOE does not currently have the ability to provide services to the students in need of special education. They have difficulty with providing services, with hiring and retaining qualified staff, and with monitoring these services. This leads to many unqualified people attempting to provide educational services, which will inevitably lead to poor outcomes, educational neglect and even abuse. This is a waste of money that could be better spent in providing services that help our keiki achieve their full potential.
- 3. The DOE does NOT have the capacity to provide these services at this time. The current system of contracted providers is costing the Department of Education about \$38 million a year. This system is broken and costing the DOE a massive amount of money for services that are ineffective. Contracted providers are not required to be BCBA's. The Department of Education changes the wording in the contract to remove reference to Applied Behavior Analysis (ABA), yet continue to provide services that fall under the state definition of ABA. This is a waste of money and could potentially lead to an increase in lawsuits.
- 4. The ambiguity in the current version of the bill (referencing "educational professionals" as opposed to licensed teachers) may result in an increase in due process cases being brought against the DOE and could cost the state millions of dollars.

- 5. Many teachers are struggling. They are asking for help to create and monitor progress with behavior analytic programs. While they have the training and ability to use classroom reward systems, they do not have the training and skills to perform Functional Behavioral Assessments, Functional Analyses, and to create acquisition and behavior management programs. As **licensed** teachers, many in the DOE will fall under exemption #1 in Act 199.
- 6. There have been too many reports of abuse and neglect of our keiki in special education. These cases are avoidable with proper training and supervision by a qualified, licensed Behavior Analyst. In addition to the harm to the children and families, these instances also cost our state money that could be better spent on prevention.
- 7. The goal of Act 199 was increasing consumer protection. I believe that is a reasonable goal that should be upheld, regardless of the setting. DOE should NOT be exempt.

I believe the DOE should be responsible for hiring qualified professionals that can change the quality of services delivered. An increase in quality will go a long way toward increasing skills for our keiki, leading to lower costs to our state in the future. Just as preventive medicine lowers costs to consumers in the long run, quality ABA will lower costs to our state in terms of the need for life-long services and care. Please, hold the DOE responsible for increasing quality, hiring qualified professionals (Board Certified Behavior Analysts and Registered Behavior Technicians), and providing services our keiki so desperately need.

I urge you to oppose SB1311 SD1. This bill will do nothing but perpetuate harm for Hawaii's keiki with special needs.

Thank you for your time and your desire to do what is right! Let's continue to work together as a state to Malama Our Keiki!
