This measure proposes acquisition of Dole Food Company properties by the State through land exchange for the purpose of supporting long-term diversified agricultural production. Having the State acquire prime agricultural lands in fee and with land rents based on the agricultural productivity of the land is the most direct means to ensure the availability of agricultural lands for agricultural production in perpetuity. The Department of Agriculture believes the process to evaluate, prioritize, select, and complete land exchanges as contemplated in this measure will require the cooperation and expertise of other agencies.

In consideration of SENATE BILL 1374, SENATE DRAFT 2, HOUSE DRAFT 1 RELATING TO LAND EXCHANGE

Senate Bill 1374, Senate Draft 2, House Draft 1 proposes to require the Department of Agriculture to negotiate and, as appropriate, facilitate land exchanges with Dole Food Company, Inc. The Department of Land and Natural Resources (Department) provides the following comments on this measure.

The Department, through its Division of Forestry and Wildlife (DOFAW), has been working for several years to acquire a portion of these Dole lands in the Helemano/Poamoho area totaling over 3,000 acres of conservation and agricultural district lands to be added to the state forest reserve system managed by the DOFAW forest resources management program. Activities under that program broaden the State's economic base by producing, improving, and assisting in the production of high quality forest products to support a sustainable forest industry that maintains and creates jobs, generating revenue for the State of Hawaii. Reforestation of degraded agricultural-use lands improves watershed values, provides timber, windbreaks, soil erosion control and contributes to the forest product development and utilization program.

Future public use for these Helemano/Poamoho Dole lands contemplates multiple uses including public recreation in the form of motorized recreation activities, non-motorized recreation activities such as hiking, biking, camping and public hunting, as well as forestry management, rare species habitat enhancement, and watershed protection. The Department has secured or is in the process of securing approximately \$8.8 million for the acquisition of four of Dole's parcels in this area from the United States Forest Service Forest Legacy Program, City and County of Honolulu, and State Legacy Land Conservation Program. The Department wishes to ensure that these plans are not disrupted for this portion of the Dole lands that are the subject of this bill.

Further, the Department is unable to comment on the state land impact of this measure as it does not identify any state parcels for exchange and does not specify the type of state land to be exchanged. In this regard, the Department requests the following considerations:

- To ensure against loss of important lands currently under its stewardship and management for public purpose use, including the protection of natural, cultural and historical resources and providing for public recreation; or for revenue enhancement purposes that provide support to our core mission.
- That the appropriate due diligence is done for any exchange of state lands, including title, property condition, use, and value.
- That any land exchange would be subject to the requirements of Section 171-50, Hawaii Revised Statutes, including the approval by both the Board of Land and Natural Resources and a majority of both houses of the Legislature.

The Agribusiness Development Corporation ("ADC") strongly supports Senate Bill No. 1374 S.D. 2, H.D. 1 which appropriates funds to investigate the possibility of exchanging state land for land owned by Dole Food Company Inc., and for cost of executing the exchange.

Today, many local farmers are struggling to stay in business, or are contemplating selling their farms due to a number of challenges. One of the major barriers which inhibits farming from flourishing in Hawaii is the inability to access land due to the rising cost for agricultural land and urban sprawl development.

Dole has a large inventory of excess land that has been fallow for years and has listed over fifteen thousand acres for sale between central Oahu and the North Shore. I am Dan Nellis, General Manager of Dole Food Company Hawai' i. Dole Food Company supports S.B. 1374 as one method to acquire certain excess lands owned by Dole Food Company in the Central O'ahu and North Shore regions of O'ahu. Ownership of these lands could facilitate the State's mandate to conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency and assure the availability of agriculturally suitable lands, and to protect lands that are suitable for conservation or preservation.

Dole Food Company has a long history of agriculture in Hawai' i and our intent is to continue to support and promote diversified agriculture in Hawai' i. Our plan is to continue cultivation of existing pineapple, coffee and cacao crops and the operation of ancillary agricultural facilities.

The Chamber of Commerce Hawaii ("The Chamber") **provides the following comments on** SB 1374 SD2 HD 1, which requires the Department of Agriculture to negotiate and, as appropriate, facilitate land exchanges with Dole Food Company, Inc., for agricultural lands in Central Oahu.

The Chamber is Hawaii's leading statewide business advocacy organization, representing about 1,000 businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of members and the entire business community to improve the state's economic climate and to foster positive action on issues of common concern.

The bill cites the State constitution ". . . under article XI, section 3, to conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency, and assure the availability of agriculturally suitable lands." What is missing from this statement is the need to insure that agriculture is "economically viable." Preserving agricultural lands for the sake of preservation is misleading.

Perhaps the bill should include language that requires an economic analysis of the cost to acquire both the agricultural lands <u>AND</u> irrigation water to keep these lands productive against the benefit resulting from the active use of these lands in agriculture be it self-sufficiency (this should be defined), creation of new jobs (employment), taxes on new agribusinesses, ecotourism, etc.

There is a cost to preserving agricultural lands, it would be wise to identify and quantify these costs prior to the acquisition process.

Testimony in support of SB 1374

Aloha Chair Tsuji, Vice Chair Onishi and Members of the Committee,

My name is Anthony Aalto, I am the Chair of the O'ahu Group of the Sierra Club of Hawaii. The Club has more than 12,000 registered members and supporters in the state on whose behalf I am testifying, and I thank you for this opportunity to do so.

We strongly support this bill and respectfully urge you to pass it out of your committee.

We believe the bill offers a unique opportunity to O'ahu but also the chance to create a useful precedent for the neighbor counties.

BALANCE

All our counties are grappling with the issue of how to balance needed growth –particularly the construction of vitally needed affordable housing for our workforce- with the need to protect agricultural, conservation and rural areas.

These areas need protection for several reasons:

- 1) First we must preserve the beauty of the land that is the foundation on which our tourist economy is built.
- 2) Second, as traditional food-growing areas in other parts of the world deal with the mounting impacts of climate change (such as the drought-driven crop losses in California's Central Valley last year) and the food demands of a global population that is expected to increase by 2 billion people in the next 25 years, Hawai'i needs to boost its food resilience. This is not necessarily to argue that we must become food self-sufficient, but given that we currently grow only about 10% of what we consume, we are extremely vulnerable to events beyond our control. Stimulating expansion of our local food production is a wise policy goal adopted by this Legislature in 2013. Since the availability of long-term leases of land is the major obstacle to boosting local food-production, securing ownership of and permanently preserving agricultural land by the state would enable a significant stimulus to food production.
- 3) Third, as Climate Change starts to make its effects felt, we need to increase protection of our Conservation areas in order to preserve our water supply. The National Drought

Mitigation Center currently categorizes more than 94% of Hawaii's land area as in a Moderate or Severe drought, impacting 538,315 Hawaii residents. Large areas covered by this bill are zoned for conservation.

4) Fourth, as we move to meet the state goal of zero reliance on fossil fuels for our energy needs by 2045, we will likely need to grow some biofuel crops to meet transportation demands – particularly for aviation and maritime craft. This will create further demand for agricultural land.

PRESSURES

The currently agriculture-zoned lands targeted by this bill are already beginning to be subdivided into "gentlemen farms" or "fake farms" where no real farming occurs and new construction impacts roads, water and other resources.

Meanwhile, the housing demand analysis by the Department of Business Economic Development and Tourism shows that we need to build nearly 65,000 homes over the next 10 years. Where to put these homes without sprawling over the agricultural land we should be preserving?

On O'ahu the decision has been made to concentrate new housing along the rail route. And, while the (seemingly) inevitable cost overruns and delays in the HART project have made it unpopular for the time being, the City & County of Honolulu continues to focus its planning for new housing along the rail route.

We believe the residents of the other counties will similarly continue to press for new development to be concentrated in higher-density areas near mass transit.

This confluence of circumstances therefore gives us an opportunity for healthy trade-offs on all the islands. Land swapping is a preservation technique that is likely to receive growing attention across the state.

SB1374 proposes a tool to facilitate swaps of land owned by the state along the rail route in areas of O'ahu where development, especially of affordable housing, is appropriate and to be encouraged, with privately-owned land in areas that ought to be preserved for all the reasons listed above.

If your committee approves this proposal, we believe it could become a model for similar swaps on the neighbor islands.

For these reasons, we respectfully ask you to approve this bill.

The Land Use Research Foundation of Hawaii (LURF) is a private, non-profit research and trade association whose members include major Hawaii landowners, developers and a utility company. One of LURF's missions is to advocate for reasonable, rational and equitable land use planning, legislation and regulations that encourage wellplanned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources and public health and safety.

LURF appreciates the opportunity to provide testimony **in support of SB 1374, SD2**, **HD1**, and to offer comments.

SB 1374, SD2, HD1. As an advocate for the various agricultural stakeholder groups who defend the goals of viable agricultural operations and the conservation and protection of agriculture, including important agricultural lands in Hawaii, LURF supports this measure which requires the Department of Agriculture to negotiate and, as appropriate, facilitate land exchanges with Dole Food Company, Inc. and requires a report to the Legislature.

LURF's Position. LURF members include private property owners, farmers and ranchers who maintain and engage in agricultural enterprises, and who consider the potential for additional agricultural land and leases critical to the conduct of their operations and to help sustain their businesses. These land owners and agricultural stakeholders believe that SB 1374, SD2, HD1, by making available, agricultural land and long-term leases at affordable and predictable lease rents, would greatly assist agricultural stakeholders and support the growth of the local agriculture industry.

This bill is consistent with the underlying intent and objectives of the IAL laws (Hawaii Revised Statutes [HRS], Sections 205-41 to 52), which were enacted to fulfill the mandate in Article XI, Section 3 of the Hawaii State Constitution, "to conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency and assure the availability of agriculturally suitable lands." As noted in HRS Section 205-41, the intent of Act 183 (2005) was to develop agricultural incentive programs to promote agricultural viability, sustained growth of the agricultural industry, and the long-term use and protection of important agricultural lands for agricultural use.

Passage of the long-awaited IAL legislation would be pointless without implementation of these efforts which involve the collaboration and support of agricultural and business organizations, as well as government agencies, which this bill is intended to cultivate and promote.

By recognizing the significance of, and need to advance the interrelationships between private and public sectors to develop and improve the local agriculture industry, and establish opportunities which identify the objectives and address the needs of the industry, this bill significantly helps to promote economically viable agriculture and food self-sufficiency in Hawaii.

For the reasons stated above, LURF is **in support of SB 1374, SD2, HD1** and respectfully urges your favorable consideration of this bill.
