TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is May Ferrer, Executive Officer of the Hawaii Board of Psychology ("Board"). Thank you for the opportunity to testify on Senate Bill No. 13, Relating to Psychology. Its companion, House Bill No. 269, Relating to Psychology, was heard by the House Committee on Consumer Protection and Commerce on February 2, 2015. At its decision making, on February 4, 2015, the House Committee recommended that the measure be passed, unamended.

The Board agrees with the proposed changes to its statutory language as this will expand the scope of doctoral level education, internship training in professional psychology and post-doctoral specialty training in professional psychology, and allow greater opportunities for licensure. The American Psychological Association has been accrediting programs in professional psychology for over 60 years, gaining formal recognition as an accrediting body by the United States Department of Education and the Council of Higher Education Accreditation.
